

### CAPE COD GATEWAY AIRPORT COMMISSION MINUTES OF THE REGULAR SESSION TUESDAY, MARCH 16, 2021 Via Zoom

#### Call To Order:

Chairman Griffin called the regular meeting of the Cape Cod Gateway Airport Commission to order at 4:01 p.m. Attendance roll call was taken followed by the Pledge of Allegiance.

Chair Griffin spoke briefly about the 21st anniversary of the Falcon 90 incursion off the end of the runway into the Staples parking lot.

#### Minutes of the previous meetings:

The minutes of the December 17, 2020 Airport Commission Meeting were approved and will be signed at a later date.

#### **Public Comment:**

Joseph Dini and Robert Segal, Massachusetts Air & Space Museum (MASM) appraised the commission of their future plans. The museum reopened in July 2020 on a limited basis in the Kmart plaza and can plan on being there through the end of the year.

A location on the Airport with ramp access would be ideal for static displays and transition to the airport/airfield. They have been in active dialog with Airport management for a location on the East Ramp. They may have to plan a staged approach for raising the funds to move forward. This would also be ideal for all involved parties. There was a discussion of providing space for a flight school and future education for interested parties. Their main goal would be to bring people back into aviation, and education will be an ongoing program.



Rachael Youngling wanted to reach out ahead of the March 22<sup>nd</sup> Airport Master Plan meeting. She stated the issues from the West Yarmouth perspective would be the expansion of the runway and the impacts the community might see from that. She requested that a lot of information be included in the presentation to alleviate some concerns. Manager Servis said that this information would be addressed in the presentation.

Joseph Dini requested that he Commission let the MASM know what they need to do to firm up space on the airport.

#### Commissioners Response to Public Comment:

The commission was very excited to work with the MASM toward the next step.

#### **New Business:**

COM0321-01 - Welcome and Presentation by Aloft Aviation Management, LLC

- Manager Servis gave a brief introduction to Eric Drugge, founder of Aloft Aviation based in South Carolina.
- He summers on Cape Cod and would like to offer seasonal flight instruction and aircraft rental at the Air Cape Cod facility.
- Mr. Drugge stated he would have 2 or 3 available aircraft for instruction, rental, and scenic flights (air tours).
- He plans to be operational May 1, 2021 through September.
- He has been working with another individual to possibly partner to accommodate a year round operation if the business warrants it. He said there is nothing better than New England for aviation!
- He thanked the Commission and stated that management has been very accommodating and welcoming.

## COM0321-02 – Approval of FY2022 proposed budget

MOTION to approve the Cape Cod Gateway Airport Fiscal Year 2022 Operating Budget. SPONSOR: Management (May be acted upon)

- Manager Servis reviewed the power point presentation for the FY2022 Proposed Budget. (attached)
- The following was reviewed:
  - o FY2021 Budget Summary tracking and comparisons, and modifications
  - o The FY2022 proposed budget, a 9% increase over FY2021, is for \$7,486,010
  - o Summaries of proposed Revenues and Expenditures and corresponding detailed changes. The projected revenues exceed the projected expenditures.
  - The CARES Act funding and reimbursements to date and the plan for future expenditures.

#### COM0321-03 - Review and discuss modified financial reporting

- The Finance Subcommittee has requested some changes to the summary information as follows:
  - o Add the top 6 revenue and expenditure items to the spreadsheet
  - o Budget summaries for the top 6 revenue producers as a pie chart
  - o Budget summaries for the top 6 expenditures as a pie chart
- Manager Servis reviewed the spreadsheet information that remained the same: detailed reports, jet fuel information, and FY2020 and FY2021 comparisons.

#### COM0321-04 - Review and discuss Airport Commission By-Laws

- Manager Servis provided the Commission with a clean version of the Draft By-laws for review.
- She reviewed the key elements of the background of the modifications. The document has been reviewed by the Town of Barnstable counsel, The Airport Commission, management, and Anderson & Kreiger counsel.
- Mass General Law Chapter 90 (governs the Airport Commission), General By-laws of the Town for Boards and Commissions, and open meeting law were reviewed to make sure the document met these parameters. The words "as periodically updated" were added to the By-laws to reference any updates to these in the future.
- Basic rolls and duties of the commissioners were included, but details of the duties will be developed in a guideline separate from the by-laws.
- These will be voted on at the April Commission meeting.

### COM0321-05 - Business Plan Update Presentation - Third Quarter FY2021

- Manager Servis reviewed the Business Plan Fiscal Year 2021 Third Quarter Update PowerPoint presentation (attached).
- The focus for FY2021 has been on Goals B Diversify Revenue Streams, and D-Enhance Airport Image & Branding; however, Management is still managing to complete tasks in Goals A and C
- Manager Servis reminded the Commission that the goal is not to complete 100% of the tasks but to strive to complete those identified as priorities for the fiscal year
- The initiatives to date for each Goal were reviewed; and the initiatives currently being worked on were listed.
- Goal A is 19% complete, Goal B is 50% complete, Goal C is 7% complete, and Goal D is 30% complete.
- There was a brief discussion of the following:
  - Mary Dunn Way Extension and possible location of the Massachusetts Air & Space Museum
  - o Future events with the EAA, Young Eagles
  - o Possible new tenant to supply Helicopter services
  - o A new seasonal flight instruction/aircraft rental business, Aloft Aviation
  - o Massachusetts Air and Space Museum to become a permanent fixture at the Airport
  - o New Solar Revenue projects in the Main Terminal Parking lot.
  - o Airport Terminal Advertising
  - o A Request for Proposal for the old Mildred's property for parking
  - o Airline reengagement post COVID and existing airline scheduling and marketing.
  - o Rebranding and associated changes to media, letterhead, signage, uniforms, etc.
- The next steps were reviewed to include:
  - o Continuing to develop Goals B & D
  - o Business Plan Fourth Quarter Reporting will occur in June 2021
- It was mentioned that the public opinion of the name change has been positive; and that it was good to incorporate "Cape Cod" into the name.

Commissioner Weill forwarded an article on Electric Aviation in Washington State. There was a statewide effort to attract electric aviation. The commission should look at the involvement of Cape Air as an opportunity for specialization for this Airport. New Hampshire has approved "airplane cars" and the Airport could also look into this.

Manager Servis has met with Cape Air to discuss becoming a prototype airport. There may be some grant funds available to Airports that intend to reduce greenhouse gasses. The airport would work with the Cape Cod Commission and other non-profit organizations on the Cape to implement regional policy plans.

- Management presented a draft FY2022 budget for discussion purposes prior to presentations to the Town of Barnstable and Town Council.
- Management will also be meeting with Mark Ells in March prior to Town Council to review.
- Proposed FY22 Budget is \$7,316,263.00 which is an overall increase of 7% over FY21.
- Revenues are similar to FY21.
  - o Airline, car parking ,rental car revenues are still depicting 20-30% with only marginal improvements
  - o Corporate aviation revenues are slightly improving due to better than expected fuel sales.
  - o We will have some new Land and Facility leases. (HMI Parking, Hy-Line, Griffin and Hyannis Hangar)
  - Our fuel sales have increased.
- Expenses are similar to FY21 but are adding the following:
  - o Renegotiation of 3 year Union Contract
  - Asset Rehabilitation
  - o New Business Plan Goals
  - Marketing Funding
  - o Training and Conferences to meet our business goals.

- Management prepared a power point presentation to review the modifications to the Financial reporting.

#### 10321-01 - Business Plan Update Presentation - Third Quarter FY2021

- Manager Servis reviewed the Business Plan Fiscal Year 2021 Third Quarter Update Power Point presentation.
- The focus has been on Goals B Diversify Revenue Streams, and D-Enhance Airport Image & Branding.
- Goal A is 19% complete, Goal B is 50% complete, Goal c is 7% complete, and Goal D is 30% complete.

## 10321-02 - Update on Green Initiatives

Vehicle purchases for FY2022 (hybrid options)

- Management has applied for the vehicle purchased through the MassSave Program, and is awaiting the acceptance for funding.
- The Airport had obtained three quotes for hybrid vehicles, and the difference is approximately \$4000 to \$5000 each between hybrid and all-electric vehicles.
- The Airport will qualify for up to \$7500 rebate for each vehicle.

Electric vehicle charging stations

• Application was submitted, but the awardees have not been announced.

#### 10321-03 - Update Guidelines for Construction

- McFarland Johnson developed a brochure that highlights the green initiatives that the airport and its tenants have implemented. The Guidelines for Construction have been updated to include this information.
- Commissioner Young commented that our Airport is on the leading edge of green initiatives and would like to formulate the
  next steps to make the Airport a model for this area. Management is working with Cape Air concerning the electric aircraft
  and charging vehicles in order to accommodate these aircraft at the Airport to become the prototype for the New England
  region.
- It was recommended to contact the Cape Cod Climate Change Collaborative and other organizations to promote the green initiatives at the Airport. This is a good opportunity for the Airport to be a leader in the area. This will be included in the Business Plan and referenced in future updates.

#### **Updates:**

- CARES Act Projects
  - o Replacement of T-hangar to include 2 four unit structures.
  - Fleet Hangar Door Replacement
    - o Manager Servis reviewed the schedule for these projects. Construction will be in the August February 2022.
  - Mary Dunn Way Extension
    - o Construction will commence in April May 2022.
- o Airport Master Plan Update
  - Live public meeting scheduled for March 22 @ 6PM live on Zoom Webinar and possibly Facebook
  - o Management is coordinating with both Town of Barnstable and Yarmouth with updates
- o Airport Environmental Assessment
  - Post master plan update planning process
  - This is out for bid and should start in the fall.
  - 18-24 month process
- Airport Tree Clearing Project
  - O Spring reseeding late April 2021 on the condition of:
    - o Airport Maintenance site prep in March 2021 (rock removal, rough cut, prep for April seed)
    - o Temperature monitoring and presumed stretch of good weather with temperatures over 45 degrees
- o PFOS/Public Involvement Plan & Update
  - o Management met with the DEP in January. They requested additional testing and sampling to identify existing plumes and future plumes based on ground water and PFAS movement. The analysis is being conducted now.
- MCI Drill September 2021
  - o Preparation meetings have begun with the various agencies involved
  - Volunteers, victims, and evaluators are always welcome. Commissioner Bierwirth will contact Cape Cod CERT to see if they would like to volunteer.

The utilities for the Mary Dunn Way Extension will not be underground as it would be cost prohibitive. The MassDOT Yarmouth Road Rehabilitation included a new water line that the Airport can tie into from Mary Dunn Way. The Airport Green initiatives guidelines will be adhered to for the project.

Ms. Mederios asked about the capacity of the new T-hangars and stated that there is a great need for these. There was a brief discussion of availability for building T-hangars on the east ramp and the possibility of a restaurant on the airfield to generate more business.

Adjournment: Having no other business to discuss, the meeting was adjourned at 11:36 a.m.
