The Commission members shall include one member appointed from two nominees of each of the following organizations: the Barnstable Historical Commission, the Massachusetts State Chapter of the American Institute of Architects, and the Cape Cod and Islands Board of Realtors and four members who are residents and/or business operators from the district. In the event that no nominations by one or another of the above-named nominating groups have been received within 30 days from the date of an invitation to nominate, the Town Council may make the appointment to the Commission without such nomination. In addition, to the extent possible, members should be appointed from among professionals in the disciplines of architecture, history, architectural history, planning, archaeology, or closely related fields. All Commission members should have demonstrated special interest, competence, and/or knowledge of community history, character, and historic preservation.

Chair of Committee asked if the Committee members wanted to recommend anyone that was interviewed this afternoon: Councilor Clark recommended Peri Wentworth, to the Hyannis Main Street Waterfront Historic District Commission as an alternate member to a term expiring 06/30/2026, this was seconded by Councilor Terkelsen and Mendes, all members present voted in favor. Councilor Terkelsen recommended Eileen Elias to the Housing Committee as an alternate member to a term expiring 06/30/2025, this was seconded by Councilor Clark, all members voted in favor of the recommendation.

Councilor Clark made the recommendation of Eileen Elias, to the Disability Commission, as a regular member to a term expiring 06/30/2027, this was seconded by Councilor Terkelsen, all members voted in favor of the recommendation; Councilor Bloom recommended Inna Podgornaya, to the Disability Commission as a regular member to a term expiring 06/30/2027; Councilor Terkelsen would like to make sure we include her in the decision of the Board of Health as well, she was passionate about helping others, and if she is interested in serving on two committees. The Administrator will reach out to her and ask. Councilor Bloom recommended again after discussions Inna Podgornaya, to the Disability Commission as a regular member to a term expiring 06/30/2027, this was seconded by Councilor Burdick, all members voted in favor of the recommendation

Administrator reminded the members of the Zoning Board of Appeals and Ms. Pittinger that was interviewed for the open position, Chair of the Appointments Committee asked that the applications be pulled together from anyone that has applied in the past since this Appointments Committee started to meet so that no one is missed or overlooked. The Chair mentioned this will also give other residents an opportunity to see the vacancy, as it has not been vacant long, and we need to make sure we are capturing everyone who has interest, before recommendations are made.
