## MINUTES OF BOARD OF ASSESSORS' MEETING FEBRUARY 15, 2022

DIRECTOR UPDATE: We currently have approximately 108 Fiscal 2022 abatement applications. Several are repeat applicants from previous years which are at the Appellate Tax Board. Our front staff is now located at the Tax Collector's Office during the remodel of the Assessor's Office and the Assessors are still located in the back offices of the Assessing Office. I am currently working with our Information Technology staff to get Vision, version 6.5, uploaded to enable me to see the changes Vision made when we converted to Vision version 8 to enable me to rectify some issues. Our field inspector was injured on the job therefore we have posted a temporary part-time data collector position and this additional position may possibly be funded for fiscal 2023. We also had one of our Administrative Assistants resign and are going through the process to fill that position as well.
