1. Failed Septic System

(Continued from March 25, 2025) John O’Dea, P.E. representing Lana and Edward Lukatsky, owners – 129 Hayes Road, Centerville, failed septic system, located within Phase 1 of the Comprehensive Wastewater Management (CWMP) Plan.

2. Septic Repair Review

Douglas A. Brown licensed septic installer representing, Sharon A. and Courtenay F. Harris, owners – 394 Old Stage Road, Centerville, Map/Parcel 190-193, failed septic system, requests permission to excavate old stone around existing leaching pit, install new stone and re-use existing leaching pit, located within Phase 1 of the Comprehensive Wastewater Management (CWMP) Plan.

3. Bedroom Doorway

Tigran Gichunts, owner – 108 Field Road, Marstons Mills, Map/Parcel 150-028, under construction (renovation), requests a decreased amount of wall removal at the doorway to the previous bedroom, now labeled as a “study-room” and does not want this room to be considered as a “bedroom” in association with the septic system capacity/design.

4. Septic Variances:

John O’Dea P.E. Sullivan Engineering representing Randolph & Barbara Noelle – 34 Short Beach Road, Centerville, Map/Parcel 206-041; requesting permission to install a tight tank; variances requested from 310 CMR 15.211 minimum setbacks to foundation wall and property line and variance requested from Chapter 360-1 of the Town of Barnstable Code, minimum setback to waterbody.

5. Sewer Connection/ Extension Requests:

- A. Kathleen Mathews of Ed Matthews Plumbing Company representing William & Marilyn McClearn, owners – 365 Phinney’s Ln, Centerville, Map/Parcel 230-091, failed septic system, was ordered to connect to public sewer within sixty (60) days, requests an extension.

6. Food Variances:

- A. Benjamin Lamora, representing Beach Club of Craigville Inc – 27 Long Beach Rd, Centerville, Map/Parcel 206-016, variance requested from Town of Barnstable Code 322-5, proposal to provide openings to outdoors with minimal or inadequate protection against the entry of insects and rodents.
- B. Bruce Murphy representing Cotuit Athletic Association and Cotuit Kettleers- 10 Lowell Ave, Cotuit, Map/Parcel 036-038, requesting renewal to cook limited food items outdoors during 22 home games, nine-weeks each year.
- C. Daryl Kirby representing Hyannis Athletic Association (McKeon Ball Field) and TNT Stand- 116 High School Rd, Hyannis, Map/Parcel 326-001-003, variance requested from Town of Barnstable Code 322-3, grease trap.
