1. Call to Order

Bill B. attended the Town Council meeting to provide a summary of the CFAC committee's report on the recommended FY11 CIP plan.

Bill B. responded no. He noted that the Town Council created a sub-committee but had no reports yet from them.

Tom M. gave kudos to the Clean Water Protection sub-committee for helping to bring the issue to the table for discussion. Tom questioned if the Town might be close to making a decision?

Ralph K. feels a decision needs to be made soon as the Stewart's Creek project is almost ready to begin.

Bill B. commented that past projects may have been 100% betterments, grant funding received made that 100% really 25 % of the true cost of the project.

Stan H. inquired if any interest in the open committee positions had been received?

Bill B. responded that yes, one application had been received.

Tom M. inquired how many openings were available?

Bill B. replied three.
