## 5. Other matters not reasonably anticipated by the chair

Mark reviewed the 2017 Budget Action Calendar with the Comprehensive Financial Advisory Committee.

Ralph asked if the shooting range was really going to happen, and Mark responded that several options will be evaluated including opening the range on a temporary basis. This would give the police access to the range for training purposes. In addition, a survey went out to the 2,000 original members of the shooting range to assess the likelihood they would return. There are lead issues at the shooting range, however, as long as the range stays open the Town may be allowed to manage the contaminates on site. Ralph also asked if the range could rent to other police departments, which Mark replied yes.

Bob asked if there are any new projects expected in the Capital Improvement Program.

## Mark's responses

- We could reasonably expect a requests for funding the Town's wastewater management plan as the Town needs to finalize its plan in one year under the new Section 208 plan requirements
- Potentially looking at Solid Waste new layout design initiative
- The usual pipe replacement program for Water Supply
- Airport usual replacement program
- Craigville Beach is receiving \$450,000 funding for renovations
- Sandy Neck parking lot issue, potential study and design to move the parking lot back, and build a barrier to prevent erosion
