A motion was made to approve the minutes ("A – B").

### II REQUESTS FOR DETERMINATION

**Bartlett Tree Experts.** Cut invasive gray willow trees to 6-12 inch stumps. Work to be done from water side; all debris to be removed from site via raft over water for proper disposal. Each stump to be painted with Glyphosate (Rodeo) using paint brush to suppress new sprouts and kill roots; one follow-up treatment may be applied to help further limit new sprouts. Work to be done along shorelines of Hamblin Pond, Middle Pond, and Mystic Lake, Marstons Mills as shown on Assessors Map (various) Parcel (various). **DA-09030**

The applicant was represented by Holly Hobart, President of Indian Ponds Association.

Issues discussed: no concerns arose.

A motion was made to issue a negative determination.

**Samuel Yee.** Enlarge approved new deck from 8' x 12' to 10' x 12'; install 3' x 6" concrete retaining wall; excavate under new deck for storage at 135 Lakeside Dr. East, Centerville as shown on Assessors Map 252 Parcel 091.
