**Housing to Protect Cape Cod Summit**

**Update from Jillian on the Affordable Housing Growth and Development Trust Fund Board**

Jillian reviewed the projects that are in process with the Trust. Jillian provides an update on Forward 2 Friends or Relatives With of Autism Related Disabilities in Dennis, MA. Jillian also provided an update on Hanover Hyannis and a potential funding opportunity with Hanover to provide an additional 10 affordable units.

**Housing Choice Grant Program/Inclusionary Ordinance Update**

Town of Barnstable was awarded a grant for \$72,700.00 to provide an economic feasibility study to potentially increase the percentage of affordable units a developer must provide in a project with 10 or more units.

**Shared Regional Housing Services/SHI monitoring plan**

Barrett Planning working as lead consultant on the Shared Regional Housing Service project is beginning the work of assisting the Town of Barnstable updating the Town's SHI and begin the process of monitoring the units on the SHI.
