### New Business

Puritan Cape Cod, 408 Main Street, Hyannis, Map 327, Parcel 262

Façade renovation: siding, trim, doors, windows/sills, awnings, painting, lighting

Represented by Rick Penn, Puritan Clothing, also present is Linda Grice and Chris Graham - Contractor

- Revised set of plans submitted by Mr. Penn
- Updates include:
  - \* Sign band on façade has faded over time; goal is to create a design in keeping with the features of the building and restore it back to as much of the original design as possible
- Entrance: goal is to create one dominant entrance
- Doors: Main door: change of material from aluminum to mahogany, to be painted black luster enamel with brass hardware; the door and window on the far west end of the building will be reversed, restoring it to its original state; all three (3) entrance doors will be painted black with white trim
- Accent bands: changed to limestone, not concrete as originally planned, second band to be added @3' under existing
- Brick: review of brick placement; S&H Charcoal waterstruck brick / veneer to closely match existing
- Sills: changed to limestone, not concrete as originally planned; will be custom length
- Windows: black frame, white trim with Caledonian granite skirting; recessing reviewed
- Awnings: solid frame, color to be black above each window to run the length of the facade with separation between awnings
- Painting: Azek trim in brilliant white and low-luster black
- Lighting: Nauset lights proposed, no information provided with application
- Commission requests samples / specs of door, lights, windows
- Applicant to return to Commission under a new application for signage, awning lettering if any and lighting

Motion duly made by Bill Cronin, seconded by Meaghann Kenney to accept as presented all the materials, façade renovations; siding, trim, doors, windows, sills, awnings and painting

Application to be continued for signage which requires a new application

### AT&T Mobility c/o Gerry Squires, 49 Ocean Street, Hyannis, Map 326, Parcel 025

Add antennas and equipment to an existing telecommunications tower Represented by Gerry Squires of J. Lee Consulting

- Application reviewed
  - AT&T is proposing to add three (3) antennas and additional antenna equipment to an existing cell phone tower
  - Current tower has six (6) panel antennas split into two different levels; four of the existing antennas are located at 78', and is located at 66'
  - Proposing to add two (2) more panel antennas, one at each sector (78' and 66'), four (4) 17"x17" remote radio heads which go behind the antennas and three (3) surge arrestors
  - Purpose of additional equipment is for AT&T to become compliant with 4G technology for the installations
  - Antenna size is 48"; exact model number may change,
  - Application pending before the ZBA
  - Structural analysis has been completed and tower has the capability for additional equipment
  - Structural analysis completed and table

- Final decision of the contents of the document lies with the consultant and the Commission
- Commission expresses thanks for the efforts and support
