# **MINUTES**

<u>Members Present:</u> George Jessop – Chair, Marina Atsalis, Joe Cotellessa and Bill Cronin, and Brenda Mazzeo; <u>Members Absent</u>: Paul Arnold, Dave Colombo and Meaghann Kenney; <u>Staff Present:</u> Theresa Santos, Principal Assistant, Growth Management Department

A quorum being duly present, Chair Jessop opened the HHDC meeting at 6:31pm

An announcement was made by Chair Jessop stating the meeting is being recorded and broadcast on Channel 18 and in accordance with MGL Chapter 30A, s. 20; and requested that anyone taping this meeting to please make their presence known.

# Continued Business

Warren Reid for Prova Brazil, 415 Main Street, Hyannis, Map 326 Parcel 014 (continued from April 17, 2013)
Outdoor Charcoal Barbeque Gazebo and Grill
Represented by Warren Reid, Project Manager

- Updated renderings submitted into record (Exhibit B)
- Location has been changed to the opposite side of the property eliminating concerns previously expressed by Commission members
- Two (2) tables and two (2) chairs will be relocated to provide ample space in the walkway and the Egress path to be at a minimum of 4'4"
- No plantings, trees or shrubs will be affected by the installation of the structure
- Patio fencing reviewed: structure will be placed behind the rear post to maintain a clear path
- All exterior features will match existing building
- Fire walls and placement reviewed; Bill Cronin's concerns include blocking the view of the trees and flowers
- Roof design: options discussed; Marina Atsalis prefers a flat roof and that it be as unobtrusive as possible; also
  requests changing the position of the structure to form a balanced line from Main Street viewing and to mirror the
  existing image above the columns; Mr. Reid is amenable to the requested changes provided fire department
  requirements are met
- Bill Cronin expressed concern that the addition of the gazebo detracts from the historic significance of the building, and is opposed to the structure
- Structure position reviewed; Mr. Reed is open to changing the face of the structure provided that all changes abide by the Board of Health regulations
- Chair Jessop requests that an acceptable location be established then a layout could be determined; also suggests reversing the window (to the front) and the door (to the rear) which would then allow the door to swing out
- Marina Atsalis suggests reducing and reposition the size of the structure as well as repositioning the pit
- Brenda Mazzeo and Marina Atsalis are in favor of the new location
- Chair Jessop requests a detailed site plan and construction drawings of the preliminary level which shows sufficient detail of the exterior and scale of the property and the proposed structure including the main building

Motion duly made by Joe Cotellessa, seconded by Marina Atsalis to continue the application to June 5, 2013

Outside dining

Represented by Gerald Spitz

- Application reviewed (Exhibit C)
- Outside dining furniture existing from previous owner
- Table tops require an impervious surface which the applicant will purchase
- Bill Cronin suggests adding some type of cushion for the chairs

Motion duly made by Bill Cronin, seconded by Joe Cotellessa to accept the application as presented Vote: So voted unanimously

# The Cape Cod Cookie Company, 569 Main Street, Hyannis, Map 308, Parcel 111 / 00E

Business Signs, Open / Closed Sign

Represented by Carrie-Lee Touhey

- Application reviewed (Exhibit D)
- Sign placement reviewed
- Applicant stated that the landlord may install an awning at a future date
- Marina Atsalis prefers removing the 'cookies' on the awning; majority of members prefer the "cookie" pictures
- Open / closed sign proposed is a two sided flip sign and will not be illuminated

Motion duly made by Bill Cronin, seconded by Joe Cotellessa to accept the business sign, the open/closed sign and the awning as presented with the exception of removing one 'cookie' picture and the word 'gifts' Vote: So voted unanimously

\*\* Bill Cronin wished to advise applicants and merchants alike that businesses are to have street numbers on their doors, many of whom do not.

# Elaine Stathe d/b/a for Elaine & Yong's Place, 572 Main Street, Hyannis, Map 308, parcel 278

Business sign, Open / Closed Sign and Outdoor dining

Represented by Yong Mavor

- Application reviewed (Exhibit E)
- 3' x 4' Oval business sign will be placed on the existing pole on Main Street;
- Property has one door on Bassett Lane and one door on Main Street
- Location Hardship sign applicability: this location is ideal for a location hardship sign; applicant would need to design appropriate A-frame sign, receive approval from the Commission and proceed accordingly through the Planning Board
- Chair Jessop advises applicant that the building sign should be lowered and centered vertically as well as horizontally to appropriately fit the façade
- Outside dining to consist of four (4) tables and sixteen (16) chairs which will be black wrought iron chairs with cushions; applicant required to submit sample cut for review and approval before the Commission

Motion duly made by Bill Cronin, seconded by Marina Atsalis to accept the two signs as presented Vote: So voted unanimously

Motion duly made by Bill Cronin, seconded by Marina Atsalis to continue the application for outside dining furniture and A-Frame sign to June 5, 2013
