- Application for Certificate of Appropriateness reviewed (Exhibit B)
- Comments: Ms. Atsalis states that the sign is not visible from the street due to the tree; Chair Jessop suggests lowering the sign for better visibility provided ADA compliance has been met or moving the sign to the other side of the pole
- Valet parking sign: a-frame style not permitted; pedestal sign permitted provided approval thru the Planning Board has been obtained

Motion duly made by Paul Arnold, seconded Joe Cotellessa to accept the sign as presented subject to either lowering the sign or moving it to the opposite side of the pole; also approved is the pedestal valet parking sign and a standard 3' x 5' nylon trade flag Vote: So voted unanimously
