Welcome to New Members, Special Guests, and Advisors

Chair Cheryl Powell welcomes Jonathan Kanter, the Commission's newest appointed member. Welcome to Town Council President, James Crocker Jr./Liaison in attendance.

Paul Wackrow hands out a new format for voting on the Certificate of Appropriateness, Exhibit A.

New Business

Sturgis Charter Public School - 529 Main Street, Hyannis - Map 308 Parcel 269 New Sign

Jim Albrecht in attendance, He gives an explanation of the proposed signage. Would like the address numbers 529 on the front of the building, nothing on the Pine Street side, there is nothing there now.

Chair Cheryl Powell asks for any Public Comment. - None. Public Comment closed.

Taryn Thoman thinks it's a good sign.

Betsy Young asks if there will be any other signage? Jim Albrecht replies no.

Chair Cheryl Powell entertains a motion to make findings, motion moved by Betsy Young that the Commission finds the sign proposal to be compatible with the preservation and protection of the district, seconded by Taryn Thoman, so voted unanimously.

Chair Cheryl Powell moves to issue a Certificate of Appropriateness for the sign proposal at 529 Main Street, as described in the submitted application, seconded by Taryn Thoman, so voted unanimously.

Northwinter Realty Trust – 35 Winter Street, Hyannis – Map 309 Parcel 224 New Sign

Mike Caggiano from Plymouth Sign Co. in attendance. He gives an explanation of the proposed signage. Same height, same location.

Chair Cheryl Powell asks for any Public Comment - None. Public Comment closed.

David Colombo asks for clarification regarding the lighting, the current sign is internally lit and will the size of the posts be 5 x 5 with colonial caps?

Mike Caggiano replies that it will not be internally lit. He states that they will be 5 x 5 posts and agrees with the suggestion for the colonial caps.

Chair Cheryl Powell entertains a motion to make findings, motion moved by Jonathan Kanter that the Commission finds this sign proposal to be compatible with preservation and protection of the district, seconded by Taryn Thoman, so voted unanimously.

Chair Cheryl Powell moves to issue a Certificate of Appropriateness for the sign proposal at 35 Winter Street, as described in the submitted application, seconded by David Colombo, so voted unanimously.

David Colombo states/clarifies that he was going to make this motion, he was not seconding it, this moved too quickly, he wanted to make sure the post/caps suggestion was put into the Certificate of Appropriateness.

Liaison/Town Council President Jim Crocker Jr. gives instruction on how to take a vote for reconsideration/remand of the vote and procedure for.

David Colombo makes a motion to reconsider amend the Certificate of Appropriateness, seconded by Taryn Thoman, so voted unanimously.

Amended motion: Motion made by David Colombo to approve the Certificate of Appropriateness with the inclusion that the posts are to be 5 x 5 and colonial style caps, seconded by Taryn Thoman, so voted unanimously.

Narinder Thind d/b/a Indian Pavilion - 511 Main Street, Hyannis - Map 308 Parcel 093 New Sign

Narinder Thind in attendance. He explains that they would like to take down the existing canopy and put up letters, he refers to the picture of the building with the letters, Exhibit B. He shows the plastic letters that he would like to use, a red color as in Exhibit B.

Chair Cheryl Powell asks for Public Comment - None. Public Comment closed

Chair Cheryl Powell asks for clarification of the color.

Narinder Thind confirms that he can change the color if the Commission doesn't approve/like, this is a red color.

Taryn Thoman clarifies that it is a maroon color.

Betsy Young makes a motion for the Commission to find this sign proposal to be compatible with preservation and protection of the district, with the letter color - wine as presented, seconded by Jonathan Kanter, so voted unanimously.

Chair Cheryl Powell moves to issue a Certificate of Appropriateness for the sign proposal at 511 Main Street as described in the submitted application and as per the stipulations listed, seconded by Jonathan Kanter, so voted unanimously.
