## Old Business:

- **Update on Pending Conservation Restrictions-Prince Avenue/Harju/Amaral/Communication Way**

Ann reports that the conservation restrictions (CR's) are being worked through by Lindsey Counsell – Chair of Community Preservation Committee (CPC). She notes that the new Town Attorney – Karen Nober is familiar with these issues and expects clarification in the next few months on CR's.

Orenda: It is not ready to come before LAPC as of yet but will be put on a future agenda

- **Update on Open Space & Recreation Plan**

Ann hasn't heard back from anyone from Planning & Development Department as of yet on the status. She notes that Jessica Rapp Grassetti is not here tonight but relayed to Ann that she had a chain of emails that left off about two weeks ago regarding the OSRP but hasn't received an update as of yet. Jessica had no other updates.

- **Update on Pathways Subcommittee**

Phyllis Miller states that she has nothing new to report; no meeting has been scheduled and has not heard from David Anthony.

- **Update on Pathways Walking Weekend**

Farley Lewis distributes the brochure for the Fall Walking Weekend. Farley notes that Doug Payson has shared the information with Cape Cod Today, Ann Canedy has put it in her bulletin and will be putting the information on the Barnstable Village Bulletin Board. Farley gives a quick review of the walks scheduled and states that more information for the Crocker Neck walks can be found on the Barnstable Land Trust's website.

Ann notes that in regards to the Santuit Management Plan, Tom Lee emailed her and notified both the Town of Barnstable's Board of Health and the Mashpee Board of Health about the plan. Phyllis Miller clarifies that Mr. Lee asked the Mashpee Board of Health to notify the Town of Barnstable's Board of Health in order to post it on their site.

- **Presentation by Committee Member Janet Crystal on mushrooms**

Committee member, Janet Crystal gives presentation about mushrooms: She notes that she became interested in mushrooms approximately five years ago and that mushrooms are everywhere, come in all shapes, sizes, colors and configurations. They are not a plant, have their own kingdom, are fungi and don't photosynthesize. Not all fungi are mushrooms and that the mushrooms in the stores for consumption are domesticated versions which are edible. She talks about their field markings, gills and how the spores are released. She shows a mushroom and points out the root system. She talks about poisonous varieties and what to be aware of. Janet has read and refers to books about mushrooms one of which is Fascinating Fungi of New England by Lawrence Millman and Mushrooms of Northeast America – Midwest to New England by George Barron. She shows a picture of green stain mushrooms and reads from Mr. Millman's book of what it was used for which was a natural stain. She then gives instruction on how to do a spore print.
