#### BARNSTABLE LICENSING AUTHORITY LICENSING HEARING MINUTES Town Hall Building, 367 Main Street, 2<sup>nd</sup> Floor Hearing Room, Hyannis, MA – 9:30 a.m. March 12, 2012

A regular meeting of the Barnstable Licensing Authority was held on Monday, March 12, 2012. Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced Gene Burman, Vice Chairman; Paul Sullivan, Clerk; Thomas Geiler, Director of Regulatory Services and Licensing Agent, Richard Scali, Consumer Affairs Supervisor, Lt. John Murphy and Patrolman Steve Maher, Liaison Officers from the Barnstable Police Department, and Christine Ade, Recording Secretary.

### Hearings:

A Motion was duly made by Mr. Burman seconded by Mr. Sullivan and a unanimous vote taken to approve the minutes of the last meeting on February 13, 2012.

**Two One Day Entertainment Licenses:** Application of Cecelia Carey on behalf of Rotary Club of Hyannis, P.O. Box 39, Hyannis for two one day entertainment licenses for its annual Home & Garden Show. Exhibitors will showcase home, garden, landscaping, financial and the like industries for their goods and services. All proceedings go to scholarships and community projects and this is a registered non-profit organization.

Cecelia Carey appeared for the application. She brought a program from last year's show – they have about 160 people who will be there. It has been held for years and this will be the  $54^{th}$ . It will be this month.

Mary Lyons appeared for this application as well. This is the same event held for several years.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Sarah Biggs of Casual Gourmet, 31 Richardson Road, Centerville on behalf of Cape Cod Academy, 50 Osterville West Barnstable Road, Osterville, for a One Day Wine and Malt License for a fundraising gala event to be held on March 24, 2012 from 5:30 pm to 9:30 pm

<u>One Day All Alcohol License</u>: Application of Sean Whelahan on behalf of Kian n Rylee's Pub & Patio, 561 Main Street, Hyannis, holding a Seasonal All Alcohol Common Victualler License for permission from the Board for a One Day All Alcohol License to commence its 2012 season on March 31, 2012 rather than April 1, 2012 (one day earlier than seasonal licenses commence) because April 1<sup>st</sup> falls on a Sunday.

Mr. Whelehan appeared for this application he is making to open one day earlier. They have owned the restaurant since 2006. Their seasonal license opens April 1<sup>st</sup>. He has applied for this to open a day earlier. They have been in full compliance since 2006 – with no violations. Mr. Hoxie stated that all alcohol on a one day basis can only be issued to a non-profit, not a profit organization. Mr. Geiler stated State laws do not allow a seasonal licensee to obtain a one day license in the off season or have an extension of the license. Mr. Scali spoke with Mr. Whelehan that he apply this way, unfortunately it is not a fail-safe way to get the license. Mr.

Whelehan stated that he is sorry to have wasted the Board's time. Mr. Burman stated on March 31 he is not a license holder – Mr. Geiler asked who else has the right to renew that license except him. Mr. Geiler stated this used to come up all the time for St. Patrick's Day. The law was written to put a limit on the actual operation of seasonal licenses. He stated he cannot fully explain it, but it is clear under the law that a seasonal licensee is not entitled to operate other than in that period. Mr. Hoxie stated it protects the annual licensees.

Mr. Whelehan stated he was not aware of the all alcohol limitation for people who operate for profit and withdrew his application.

<u>One Day Entertainment Licenses (2)</u>: Application of Kevin Howard on behalf of Arts Foundation of Cape Cod, 3 Shootflying Hill Road, Centerville, for two one day entertainment licenses for its annual TD Bank Pops by the Sea - preview party Saturday, August 11, 2012 from 5 pm to 9 pm and the Boston Pops concert on Sunday, August 12, 2012 from 1 pm to 7 pm with regionally based bands on the lawn in front of the Town Hall building, 367 Main Street, Hyannis.

Mr. Howard stated the application is complete – they are hoping for about 2,000 people on Saturday evening and about 15,000 on Sunday. They have not finalized the bands for Saturday yet. They will have guest conductors. Mr. Burman asked about the 501c (3) letter which expires in '08. It is a ten year renewal – the next expiration date is 2018.

Ms. Voorhees appeared for this request. This is their 8<sup>th</sup> year, but her 1<sup>st</sup> time to appear before the Board. She entertained questions but there were none.

Mr. Hoxie explained that we can no longer waive the fees as there is now a ½ price fee for non-profits in place.

Change of Manager on its annual All Alcohol General on Premises license from Malcolm Stoker to Peter J. Lawson.

**New Annual Wine & Malt Common Victualler License:** Application of Pizzeria Barbone, LLC, d/b/a Pizza Barbone, 390 Main Street, Hyannis, Jason O'Toole, Manager, for a New Annual Common Victualler Wine & Malt License, hours of operation to be 11 am to 11 pm, with seating for 42 at tables/chairs & banquette, 7 at counter and 12 outside.

Mr. O'Toole appeared for his application. It will be right next to Puritan's on Main Street. He plans to open mid-May. He is requesting to open without the alcohol if it is not approved by then. He will still run his mobile operation in Sandwich – most of it is private catering. The pizza is wood fired. The oven is coming from Italy next week to NJ and then to here. It is a 3<sup>rd</sup> generation oven. The pizzas cook in 90 seconds to 2 minutes. The use a special flour as well – it is like the pizza in Naples. Mr. Hoxie asked if you can get a plain pizza – Mr. O'Toole stated they can. Mr. Geiler asked what is in the basement – he said an office and dry storage. No food prep or customers. They will have full pizzas, no slices. No access into Puritan's. There will be a café/creperie in between. Mr. Hoxie asked if the CV alone can be done with the main motion and Mr. Geiler stated that can be added on.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Pizzeria Barbone, LLC, d/b/a Pizza Barbone, 390 Main Street, Hyannis, Jason O'Toole, Manager, for a New Annual Common Victualler license, hours of operation to be 11 am to 11 pm, with seating for 42 at tables/chairs & banquette, 7 at counter and 12 outside.

A second motion was made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Pizzeria Barbone, LLC, d/b/a Pizza Barbone, 390 Main Street, Hyannis, Jason O'Toole, Manager, for a New Annual Common Victualler Wine & Malt License, hours of operation to be 11 am to 11 pm, with seating for 42 at tables/chairs & banquette, 7 at counter and 12 outside.

Mr. Geiler asked if he had cleared the outside dining as he is on Main Street; Mr. O'Toole stated he has started working on that.

**New Seasonal Common Victualler License:** Application of Cynthia J. Oliver, d/b/a Lobstahs, 569 Main Street, Unit D12, Hyannis, Cynthia J. Oliver, Manager, for a New Seasonal Common Victualler License, the hours of operation to be 10:00 a.m. to 6:00 p.m. with seating at tables outside for 18.

No-one appeared for the application. Mr. Hoxie suggested we just continue the application so it would not have to be re-advertised.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to continue this application to the 3/26/12 Hearing so there would not be a need to re-advertise.

**<u>Change of Manager and Addition of 2 Pool Tables:</u>** Application of Tommy Doyle's Hyannis, LLC d/b/a Tommy Doyle's Irish Pub & Restaurant, 334 Main Street, Hyannis, for a Change of Manager from Jason Irving to Shawn Dougherty and for the addition of two pool tables.

Mr. Dougherty and Alan O'Sullivan appeared for the request for two pool tables. They will be in the 2<sup>nd</sup> room. It has been signed off by the Building Commissioner. They will be coin-operated and are in the view of the bartender. He stated the new manager is an ex Marine and has been in the bar business for years – they moved Jason the current Manager on the license to Cambridge and Sean will be in Hyannis now. Mr. Hoxie asked about other games – Mr. O'Sullivan stated they have two other games – no payouts or gambling. Mr. Hoxie asked about the 8 seats they are losing – Mr. O'Sullivan stated the Building Commissioner has ok'd that plan.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Tommy Doyle's Hyannis, LLC d/b/a Tommy Doyle's Irish Pub & Restaurant, 334 Main Street, Hyannis, for a Change of Manager from Jason Irving to Shawn Dougherty and for the addition of two pool tables.

<u>Alteration of Premises:</u> Application of Brazilian Grill Inc., d/b/a Brazilian Grill, 676-78 Main Street, Hyannis. Kelly A. DePaula, Manager, for Alteration of Premises to change to the following premises description: Wood frame building at 676-78 main Street with 1 entrance on Main Street, 2 exits to rear of building. 74 x 16 kitchen, 8  $1/2 \times 4 1/2$  coffee room. Central dining room 48 x 18 with 67 seats,  $2^{nd}$  dining room 48 x 17 with 44 seats, garden room 38 x 28 with 48 seats. Garden room has 1 entrance from central dining corridor and 2 emergency exits to sidewalk. Bar room 28 x 18 with 20 seats. Outside patio 9 x 12 with 16 seats. 10 x 24 salad bar, 3 restrooms with handicap provisions, 8 x 14 registration area, 15 x 15 waiting area. Total seating 195.

Jonathan Tyler appeared for the Brazilian Grill. He is the builder of the enclosed patio. He indicted he does have the Affidavit of Abutters and green and white cards but not here – said they were in another folder. Hoxie stated he can go forward and the Board can approve pending the delivery of the Affidavit this morning. He stated the enclosure is hurricane proof glass similar to the Apple building in New York. Mr. Geiler asked how they protect from sun; he stated that there is a shield in the glass and their HVAC system is built to accommodate the excessive heat there – they may also have shades on a small part of it for the couple hours when the sun is very bright. The owners really run a good business. Mr. Geiler asked how they made out with their quest for more parking. He stated he does not know exactly. They do have parking out back and some they can use in International Inn lot. Mr. Tyler

stated they are pursuing that parking area Mr. Geiler mentioned. Mr. Geiler said it is a tough area – the traffic leaving there by the little curve is a tough spot. He asked if the driveway is in and out. Mr. Tyler stated it is mostly an "in;" zoned as in and out though. He thinks it should be recommended that it be in only. Mr. Burman asked if the operation will be the same as now; there will be tabletop service for meats and you take your plate to the buffet as well. There will be a corner display of meats so they don't have to go back and forth from the other area.

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Brazilian Grill Inc., d/b/a Brazilian Grill, 676-78 Main Street, Hyannis. Kelly A. DePaula, Manager, for Alteration of Premises to change to the following premises description: Wood frame building at 676-78 main Street with 1 entrance on Main Street, 2 exits to rear of building. 74 x 16 kitchen, 8 1/2 x 4 1/2 coffee room. Central dining room 48 x 18 with 67 seats,  $2^{nd}$  dining room 48 x 17 with 44 seats, garden room 38 x 28 with 48 seats. Garden room has 1 entrance from central dining corridor and 2 emergency exits to sidewalk. Bar room 28 x 18 with 20 seats. Outside patio 9 x 12 with 16 seats. 10 x 24 salad bar, 3 restrooms with handicap provisions, 8 x 14 registration area, 15 x 15 waiting area. Total seating 195.

#### Renewals:

# The following renewals have been submitted without any changes from the previous year for Licensing Authority approval:

#### Common Victualler (Seasonal):

Ben & Jerry's, 352 Main Street, Hyannis

A motion was duly made by Gene Burman, seconded by Paul Sullivan, and a unanimous vote taken to approve the application of Ben & Jerry's for renewal of its seasonal common victualler license.

#### **Business Meeting:**

<u>Changes to Licensing Authority Rules and Regulations Chapter 502</u>: Hearing requested by the Barnstable Police Department, which has identified as an issue, and has requested the Licensing Authority consider adoption of changes to the regulations for Secondhand Dealers and Collectors as outlined in Chapter 502, Sections 4C&D, and 6E&F. This hearing will be for discussion purposes on the concept proposed.

Officer Maher stated as the junk dealers send their reports, many are sending handwritten ones and they can't read them. They want them sent electronically. It helps as it is more easily readable and they are able to look at everything on a spreadsheet rather than having to add the handwritten ones. Also, photographs

have been taken as a lump of stuff rather than each piece photographed separately. They are able to take the photos and add them to a database to compare with items which may have been stolen. It is easier for BPD. Another section which is a problem is "consignment" to get around the regulation. Definition of consignment is needed – if any profit is gained it is considered a recordable item. Another issue is resale of gift cards. Subject would steal an item, return it for a gift card which they would sell for less than the value of the gift card. This needs to be looked at and regulated. Mr. Hoxie stated we have to have a public hearing on the request. Mr. Geiler stated we need to run the ad showing the exact changes, etc. It would not have to be re-advertised if something is taken out. If we don't do the ad it would not be legal. Mr. Burman had a concern that anyone who has a junk dealer license must be a computer savvy person. Officer Maher stated only 2-3 do not at this time. Mr. Hoxie stated public hearing will be 3/26/12.

Discussion: Number of Class II Auto Dealers (used vehicles). Mr. Hoxie opened the discussion with the information the Board received about the numbers over a few years – Ms. Ade prepared a memorandum indicating the number of licenses for the past 9 years. We presently have 53 in 2012. This does not include Class I dealers. Mr. Geiler stated some of these have split. The problem we have with a lot of our business zoned land is that it is in wellhead protection areas. The Health Dept. does monitoring for hazardous materials and the Fire Dept. also does inspections, but there is an ever present danger for a well having to be closed down for years. He said that it may not be a plan for reducing the number of dealers we need, but for a minimum requirement for facilities to upgrade the protection. He thinks that would help. The Water Dept. is concerned and anything we can do to help would be a good thing. He also stated some of these dealers are operating on a shoestring and may not be as careful as they need to be. Mr. Hoxie stated that apparently some are going out of business as more are coming in so that is why the numbers aren't growing too much. He thinks we need to take each application on its merits. Mr. Burman stated he does not disagree, but it seems almost every corner has one now. It might be to the point where we say this is enough. He also said he does see more and more complaints - thinks it is for the public protection to limit it. Ptl. Maher stated one of the things that have happened is that larger places are opening rather than those with a smaller number of cars. They become more competitive, and we are seeing more consumers come in with complaints. The better plan would be to look at the number of spaces approved. This breaks down as most have numbers assigned to their lots but some that were grandfathered do not. Mr. Hoxie thinks we should entertain applications, but look at them as to need and merit. Mr. Burman thought we may want to have a meeting with Class II Dealers and ask them what they think. Lt. Murphy stated we could give Officer Maher a little more time to check on these dealers and their operations to make sure they are operating properly and complying, a little more aggressively than in the past. If it turns out there is a bigger issue we could put the dealers on notice there would be a meeting to resolve these problems. Mr. Geiler stated when this first changed (who had enforcement) and the police department took over, we had assistance in regard to day people assigned, in the summer especially, to monitor things. It is hard now to deal with these issues on

just complaints. The problems in the parking lots especially seem to happen on the busiest days and times of the year. Lt. Murphy said that he can bring the suggestion to Chief McDonald for day shift people to be educated to the issues and parking setups. He does not see staff or manpower being an issue. Mr. Hoxie stated the new applicants need to be advised they should show a public need for another license where they plan to go. Mr. Geiler stated the number of consumer complaints has risen significantly as well.

Mr. Burman asked if there are any executive session minutes to be released. There were none at this time.

Mr. Geiler stated we have been getting quarterly reports regarding where arrests are made and where the people say they had their last drink. Most do not show many locations in Barnstable. This packet however is Court cases – there are a dozen places in Barnstable on this list. It is somewhat surprising that the forms are not going to the Attorney General but the list of dockets are very telling. Some have been charged more than once. Mr. Hoxie asked if we should hold hearings on these? Mr. Geiler stated we could but it is almost impossible to use this information as evidence. Ptl. Maher stated he got one a week ago with none in Barnstable listed. He said in the past they have gone out to the locations and asked them how they plan to deal with it in the future. He thinks we should read them out loud as they are a matter pf public record. Mr. Geiler stated the Board used to simply notify them to provide a written plan to show how they can prevent it in the future. He thinks the police going out is good as well. Mr. Hoxie stated these places should be informed of the problem list and asked to communicate with us. Mr. Burman had a problem with taking as gospel the testimony of these people telling where they had a drink last - they may be protecting someone. Ptl. Maher stated that he still thinks it requires the police department at a minimum to speak to them and ask for a plan for future protection. Lt. Murphy stated there is one establishment in the list that he views as a problem as to what he has witnessed first hand. He said that he believes they should all be visited, and told there is a problem with the way they are serving.

The meeting was adjourned at 10:45 am.
