# BARNSTABLE LICENSING AUTHORITY LICENSING HEARING MINUTES

Apparently the seating used to be "common" seating; they have now obtained a variance. The seating will require a Common Victualler license. It is open 7 days a week in season and 6 off season. Mr. Hoxie asked what happens if it rains. Attorney Lawler answered, "You get wet." It has an awning. There is a lot of takeout. It is a great place – a little breakfast, and lunches.

Mr. Geiler asked about the other 2 lots – each have special permits. Mr. Burman wondered how Mr. Laham could be spread so thin – Attorney Ford stated he is well able to handle it all and has very competent staff to help him.

**Show Cause Hearing Re-opened:** Due to a request from Judith Eldredge, the Licensing Authority is re-opening its Show Cause Hearing for Auto Smart, LLC, Daryl Fietz, Manager, 202 Yarmouth Road, Hyannis, MA, which hearing was called for January 9, 2012 for failure to return her deposit or otherwise make her whole under MGL c. 140, §58 (c) (1) (v) (8) despite her returning the vehicle to Auto Smart, LLC for mechanical issues and higher loan payments. That hearing was closed as the Licensing Authority was advised that Ms. Eldredge was satisfied with the resolution of the matter. The Licensing Authority may cancel, suspend, revoke or further condition this Class II Auto Dealer License.

Mr. Hoxie read the hearing notice. He asked who was here today and confirmed Mr. Fietz was here along with Judith Eldredge.

Mr. Hoxie asked Ms. Eldredge to come forward first on this. She advised the Authority that last July she purchased a car with a \$1000 down payment. The next day she found out the payments were \$14 more than he had told her they would be. She took the car back to him and she alleges he said he had to sell the car first before returning the \$1000. She sent a letter to us in January as she still did not have her money or a satisfactory vehicle. She backed out of the former hearing as he promised her a vehicle. He then offered her \$805 out of the \$1000. She banked that as she was glad to get something, but she went to Court to see if she is entitled to the other \$195.00. She said that is put off until May. She stated that she already paid money to his mechanic directly so she should not owe him any more money. Mr. Hoxie asked if the matter was still at Court; she said it is. Ms. Eldredge stated he called her the other day and threatened her saying he was going to sue her for thousands of dollars. He knew she did not have more money than she had agreed to pay. She said if he could not get her a car for what she told him she could pay, he should have returned her money. She still has no car.

Mr. Fietz appeared and stated the ordeal began last summer. She required special financing. Source One Financial is the company he uses – the 27 page document was reviewed with her prior to the deal being made – spelling out her payments, etc. He said that she signed all the documents, took possession of the vehicle and left. He stated that in Mass, there is no 3 day refusal. He was kind to even agree to try to help her. She returned the following week saying there was something wrong with the vehicle – he stated there was nothing wrong, but her real concern was that she was paranoid about the payment. He asked her what she wanted him to do. He said the minimum payment at this company is \$50 per week. He talked them into a \$25-\$30 payment per week for her, but of course it would then have to be a cheaper car. He showed her maybe 6 vehicles. Her comment was "he wants to put me in that >>>?" Her vehicle was on his lot. She had conversations with his mechanic and with him. They are now offering to fix her car. The pan is not even made for Ford. Gas is leaking and it is unsafe. This has also been through Consumer

Assistance Council. He states he could not make her happy, and then finally she had a tow company take her car out of his lot and scrapped it. He stated that not once did they say she was not getting her money back, but he does feel he has to be compensated something for his time. A few weeks ago he gave her the \$805. He wrote on the check memo paid in full. They both shook hands and he said he believed this to mean she would not pursue it further in Small Claims Court. He did not go but she did. He said that his bond protects him. Now he has to go back to Court if he wants to get the judgment reversed. He reiterated that she shook his hand, took the check and then went to Court. She knows exactly what she is doing. He said for 8 months he has been trying to help her. He states he fought with a company on her behalf to get a very low payment. The Court case he agrees he defaulted on but only because he thought she had withdrawn it after they shook hands. He does not want to go on with this; will pay the \$195.00 - he has the Judgment, the only thing she was talking about was that the "payment" date is May 2. It is a closed case, nothing further would happen in May unless he didn't pay. Mr. Sullivan stated the Judgment does not address the merits of the case. It was awarded because he did not go to the Court when she agreed with him she would withdraw the case. Mr. Fietz stated that in this economy he has helped many many people get loans when they cannot elsewhere. Mr. Fietz will pay that money today if we wish to Mrs. Eldredge.

Mr. Scali stated we are here only to see if he is running his business properly. There have been three complaints – one settled, this Mrs. Eldredge case and another complaint that came in Friday. He is here only because there seems to be a pattern of issues at Auto Smart and because he did not show up at the last hearing.

Mr. Geiler asked Mr. Fietz if he understands his obligations with respect to lemon law, refunds and being able to satisfy a customer. He said Mr. Fietz sold a 2007 vehicle with 75K + miles on it for almost \$11K. When pointed out there was mechanical work necessary, he stalled and did not fix it. Mr. Fietz stated that there was nothing mechanical wrong with it. Mr. Geiler stated he does not know if he is a fit person to hold an auto dealer license – procedures are spelled out in the law – they are not his personal decisions to make. Mr. Fietz said he has had 2,600 + sales with no problems until now. He stated he can't afford to be conned and lied to and cheated. Mr. Sullivan asked how long he has been licensed here; he said 6 years in two locations.

Mr. Hoxie asked that he satisfy Ms. Eldredge this morning and we will file this complaint.

Meredith Carter came forward with her additional complaint. She stated she left a deposit of \$1500 for a vehicle; she was in need of funds and asked for \$1000 back; when she was there she saw a person driving her car – the one she still had a \$500 deposit on. He then told her the car was in Bridgewater and she says he sold it out from underneath her. He still has her deposit. She called Bridgewater which he indicated to her was affiliated with his dealership and they said they want nothing to

do with Darrell Fietz, that he owes them almost \$8,000. She stated he swore at her when she went to his lot to get her money back. He next tried to charge her for the car she was driving. Cape Auto Credit is on his sign. She googled him and said he has been arrested for breaking and entering. She says she was sworn at in front of his mechanic. Her person was also threatened on the phone in very descriptive foul language. She has filed a complaint at the Attorney General's Office and the Consumer Assistance Council as well as with us.

Mr. Hoxie stated without making any judgments on this we will advertise for a show cause hearing on this specific case for the April 30<sup>th</sup> meeting.

Mr. Scali advised the Board they may want to hold off on the decision on the Eldgredge case until 4/30 as well because they may want to consider the cumulative complaints. Ms. Eldredge asked if she had to be there and Mr. Hoxie stated she did not.
