BARNSTABLE LICENSING AUTHORITY LICENSING HEARING MINUTES

Town Hall Building, 367 Main Street, 2nd Floor Hearing Room, Hyannis, MA – 9:30 a.m. **November 18, 2013**

A regular meeting of the Barnstable Licensing Authority was held on Monday, November 18, 2013, Chairman Martin Hoxie called the meeting to order at 9:30 A.M. He introduced Gene Burman, Vice Chairman; Paul Sullivan, Clerk; Ron Semprini, Associate Commissioner; David Nunheimer, Associate Commissioner, Richard V. Scali, Interim Director of Regulatory of Regulatory Services, Lt. John Murphy and Patrolman Steve Maher, Liaison Officers from the Barnstable Police Department, and Christine Ade, Recording Secretary. Dick Boy was absent.

Vote to accept Minutes: Vote to accept minutes of the 10/28/13 Meeting.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the minutes of the 10/28/13 Meeting.

Hearings:

<u>Two One Day Entertainment Licenses:</u> Application of Susan Mendoza Friedman on behalf of Dancing for a Cure, 39 Rosewood Lane, Cotuit for Two One Day Entertainment Licenses for productions to be held at Barnstable High School Knight Auditorium, West Main Street, Hyannis on December 14, 2013 from 2 pm to 3:30 pm and 7 pm to 8:30 pm, and December 15, 2013 from 2 pm to 3:30 pm.

Ms. Mendoza Friedman appeared for her application. It will be at BHS Knight Auditorium. This is their 8th annual event. They are hoping for approval. Dancing for a Cure is a partnership with Dana Farber; they will get 100% of the proceeds.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Susan Mendoza Friedman on behalf of Dancing for a Cure, 39 Rosewood Lane, Cotuit for Two One Day Entertainment Licenses for productions to be held at Barnstable High School Knight Auditorium, West Main Street, Hyannis on December 14, 2013 from 2 pm to 3:30 pm and 7 pm to 8:30 pm, and December 15, 2013 from 2 pm to 3:30 pm.

Two One Day Entertainment Licenses: Application of Coby Vincent on behalf of Coastal Dance Company, 49 John Maki Road, West Barnstable for two One Day Entertainment Licenses for productions to be held at Barnstable High School Performing Arts Center, West Main Street, Hyannis on December 14, 2013 from 2 pm to 4 pm and December 15, 2013 from 2 pm to 4 pm. A third performance will be on December 13, 2013 from 10 am to 12 pm for the school only.

Mr. Vincent appeared for the application at the High School. This is the 28th year of production. This is the first Coppelia Ballet; admission \$20-\$30. They give out 60 tickets to each school in the community.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Coby Vincent on behalf of Coastal Dance Company, 49 John Maki Road, West Barnstable for two One Day Entertainment Licenses for productions to be held at Barnstable High School Performing Arts Center, West Main Street, Hyannis on December 14, 2013 from 2 pm to 4 pm and December 15, 2013 from 2 pm to 4 pm. A third performance will be on December 13, 2013 from 10 am to 12 pm for the school only.

One Day Charity Wine Pouring License: Application of Kevin Howard on behalf of Arts Foundation of Cape Cod, 3 Patti Page Way, Centerville for a One Day Charity Wine Only Pouring License for a charity Winter Art Exhibit opening reception to be held at Cotuit Center for the Arts, 4404 Falmouth Road, Cotuit, on January 11, 2014 from 7 pm to 9 pm.

Mr. Howard appeared for his application for a Charity Wine Pouring License to be held at Cotuit Center for the Arts. Mr. Howard is the Executive Director. This exhibit is a call to artists to appear on the Cape. The opening reception is from 7-9. TIPS trained bartenders will dispense the alcohol.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Kevin Howard on behalf of Arts Foundation of Cape Cod, 3 Patti Page Way, Centerville for a One Day Charity Wine Only Pouring License for a charity Winter Art Exhibit opening reception to be held at Cotuit Center for the Arts, 4404 Falmouth Road, Cotuit, on January 11, 2014 from 7 pm to 9 pm.

Amend Class II Auto Dealer License: Application of Used Auto Cape, LLC, d/b/a Used Auto Cape, 61 Falmouth Road, Hyannis, Aramayis Melikyan, Manager, to amend its Class II Auto Dealer license to 3 customer and 33 display vehicles as noted on plan signed by the Building Commissioner 9/26/13.

The owners appeared as they are leasing the space behind the building; they have increased by 10 spots which have been approved.

Mr. Scali stated this one is here to bring itself into compliance by expanding their number. The difference was noticed when the police department investigated. Officer

Maher asked how customers will go to the back lot. They advised that they will not; they will bring a vehicle up front for a customer to see.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Used Auto Cape, LLC, d/b/a Used Auto Cape, 61 Falmouth Road, Hyannis, Aramayis Melikyan, Manager, to amend its Class II Auto Dealer license to 3 customer and 33 display vehicles as noted on plan signed by the Building Commissioner 9/26/13.

Amend Class II Auto Dealer License: Application of Big Bad One, Inc., d/b/a Ziggy's, 832 Bearses Way, Hyannis, William H. Baron, Manager, to amend its Class II Auto Dealer license to 3 employee, 7 customer, 12 rear storage, 15 display a handicap vehicles and 16 inside vehicles (54 total) as noted on plan signed by the Building Commissioner 9/27/13.

Mr. Baron appeared for his request.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Big Bad One, Inc., d/b/a Ziggy's, 832 Bearses Way, Hyannis, William H. Baron, Manager, to amend its Class II Auto Dealer license to 3 employee, 7 customer, 12 rear storage, 15 display a handicap vehicles and 16 inside vehicles (54 total) as noted on plan signed by the Building Commissioner 9/27/13.

Amend Class I Auto Dealer License: Application of Xiphias Enterprises, Inc., d/b/a Hyannis Honda Annex, 405 West Main Street & 57 Shady Lane, Hyannis, James B. Goodwin, Manager, to amend its Class I Auto Dealer license to include a total of 79 spaces as shown on updated plan signed by the Building Commissioner 10/15/13.

No-one appeared for this application. Mr. Hoxie continued the application to the 12/9/13 Meeting with no need to re-advertise.

Amend Class I Auto Dealer License: Application of Tracy Volkswagen, Inc., d/b/a Tracy Volkswagen/Cape Cod Auto Body, 686 Iyannough Road, 151 Iyannough Road, 138 & 140 Cedar Street and 63 Cit Avenue, Hyannis, Bradford W. Tracy, Manager, to amend its Class I Auto Dealer license to include in its d/b/a "Cape Cod Auto Body," and to include a lot at 63 Cit Avenue, Hyannis with a steel building to be used as a prep center with car wash bay and shop area with 3 lifts. Lot is fenced in and has a maximum of 44 vehicles as shown on plan approved by the Building Commissioner on 10/7/13.

Bradford Tracy appeared for this application to get everything in order. Mr. Scali stated he wanted to make sure they add the d/b/a and clarify for Mr. Tracy that he needs to add vehicle counts on his other lots as well. Mr. Hoxie asked him if he knew that.

Mr. Tracy stated the lot in back should have 80 cars on it and the town should have this information. Mr. Scali stated that he and Mr. Tracy have met and do not agree on this

issue. The issue here is whether or not he needs to come back to get the vehicle counts noted on his license for all areas. Officer Maher asked if he has some documentation of those 80 vehicles; Mr. Tracy stated he is sure the Town has it and he did not know if he has that. Mr. Scali stated that if not, he needs to go to Zoning to get those spaces approved and back to Licensing for addition of the number(s) to his license.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Tracy Volkswagen, Inc., d/b/a Tracy Volkswagen/Cape Cod Auto Body, 686 Iyannough Road, 151 Iyannough Road, 138 & 140 Cedar Street and 63 Cit Avenue, Hyannis, Bradford W. Tracy, Manager, to amend its Class I Auto Dealer license to include in its d/b/a "Cape Cod Auto Body," and to include a lot at 63 Cit Avenue, Hyannis with a steel building to be used as a prep center with car wash bay and shop area with 3 lifts. Lot is fenced in and has a maximum of 44 vehicles as shown on plan approved by the Building Commissioner on 10/7/13.

New Seasonal Non-Live Entertainment, Automatic Amusement and Carousel Licenses: Application of Wackenhammer Corp., d/b/a Wackenhammer Arcade, 541 Main Street, Hyannis, Tim Burns, Manager, for a Seasonal Non-Live Entertainment License, Automatic Amusement License for 40 games and a Carousel License (Sun—Sat 11 am—11 pm Memorial Day through Labor Day; Fri 6 pm—11 pm, Sat 11 am—11 pm & Sun noon—6 pm from April 1 - May 31 & day after Labor Day—Jan 15).

The owners and Manager appeared to advise they have purchased the arcade and carousel. There is an existing license for 40 games, non-live entertainment and the carousel with the same configuration and numbers. They will be changing out some of the games. Mr. Scali stated if they change in the future they will need to come back.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Wackenhammer Corp., d/b/a Wackenhammer Arcade, 541 Main Street, Hyannis, Tim Burns, Manager, for a Seasonal Non-Live Entertainment License, Automatic Amusement License for 40 games and a Carousel License (Sun–Sat 11 am – 11 pm Memorial Day through Labor Day; Fri 6 pm – 11 pm, Sat 11 am – 11 pm & Sun noon – 6 pm from April 1 - May 31 & day after Labor Day – Jan 15).

New Annual Common Victualler License: Application of Hyannis Y's Choice Cafe, Inc., d/b/a Y's Choice Cafe, 2245 Iyannough Road, West Barnstable, Dylan Jordan, Manager, for a New Annual Common Victualler License, to be operated 6 am to 6 pm 7 days. Seating for a maximum of 16.

Dylan Jordan appeared for this application for the YMCA building. This will be a café and smoothie bar inside the YMCA. They have in the past only had vending machines. It is members only. There will be some prepared snacks, baked goods, etc. and the smoothies. Mr. Scali stated they will also need a Food Service Permit.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Hyannis Y's Choice Cafe, Inc., d/b/a Y's Choice Cafe, 2245 Iyannough Road, West Barnstable, Dylan Jordan, Manager, for a New Annual Common Victualler License, to be operated 6 am to 6 pm 7 days. Seating for a maximum of 16.

<u>Amend Class II Auto Dealer License:</u> Application of Cape Cod Auto Connection, Inc., 152 Ridgewood Avenue, Hyannis, Tom Lundquist, Manager, to amend its Class II Auto Dealer license to include 108 vehicle spaces, 4 employee spaces and 6 customer spaces (118 total) as noted on plan dated 10/3/13.

Attorney John Kenney and Tom Lundquist appeared for this application. This one is the same as the others; he is bringing the license into compliance. They are not asking for the repairs now. It was a pre-existing non-conforming use without repairs. He does recognize he needs to go back on this. As of now there are no repairs being done on premises. They will have to go back to the Planning Board. Mr. Scali stated it took us a very long time to get a response. In the future he does not want to see the reluctance to comply with Officer Maher.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to approve the application of Cape Cod Auto Connection, Inc., 152 Ridgewood Avenue, Hyannis, Tom Lundquist, Manager, to amend its Class II Auto Dealer license to include 108 vehicle spaces, 4 employee spaces and 6 customer spaces (118 total) as noted on plan dated 10/3/13.

Show Cause Hearing: Show Cause Hearing requested by the Barnstable Police Department for Cape Cod Auto Connection, 152 Ridgewood Avenue, Hyannis, Tom Lundquist, Manager, alleging that it was not in compliance with regard to the total number of vehicles allowed on the licensed premises on the following dates: 8/30/13, 9/16/13 and 9/24/13, did not get back to the Police or file anything with the Licensing Authority with regard to the overage of vehicles (95 when approved for 70) by September 20, 2013 as requested.

Officer Maher stated on August 30th he conducted an inspection and found 95 vehicles on display and the license allows 70. He also saw repairs being done. He had a conversation with Mr. Lundquist to start applying for changes. On September 16th he had another conversation about it being done; also on the 24th he went by and there will still over 90 vehicles there.

Attorney Kenney stated his client had 49 cars on display, plus another set of vehicles for customers, employees, cars to go to auction or to the junkyard. He stated it is cheaper to do a full load instead of one or two at a time. He stated there was a discussion on August 30th. He stated Mr. Lundquist went to the Licensing Office to advise he was starting work on it. He stated his client was not on the property at the 2nd visit. He had paperwork completed in early September but had not received the plan back. He immediately filed as soon as he got the plan. They admit to being over on their vehicle

count. Attorney Kenney stated there was never any intent to disregard Officer Maher's instructions or the notice from the Licensing Authority. Attorney Kenney again stated there were 49 vehicles for sale. The new number they have now been granted will totally rectify the situation.

Officer Maher asked about his visit in January 2009, why he was in front of the Board. Mr. Lundquist stated he purchased the property and at the time boat repair was there and a painting company which are now gone. He was then approved for 70 vehicles. He went back to the Planning Board and in that time had accumulated more vehicles. He thought he was able to have those cars at the time as Licensing had approved, but he evidently was not. At that time he was told to stay within the listed car limit. Officer Maher stated he was brought in for too many vehicles. Mr. Lundquist said that he did not understand at that time that the approval was conditioned on the Planning Board approval. He says that over the last 5-6 years they have really grown. August was a busy month with a lot of trade-in vehicles. He didn't realize so many were there. He stated he came to the Licensing Office to advise it would take some time. He was working elsewhere on the days Officer Maher came in except for the first day. He did not know he had a September deadline.

Officer Maher stated that the violation in 2009 was for the same offense – too many vehicles on the lot. Mr. Hoxie stated the Board's decision will take into account the fact he has been charged with this violation before. Attorney Kenney advised the first violation was because he was approved here but did not know the Planning Board had to approve as well before he brought in the cars, so argued it was not the same offense. Officer Maher also asked why on the 2nd visit he was still over 90 vehicles after being told he was over the first visit. Mr. Lundquist stated he brought the count down before each subsequent visit – a lot of those vehicles accumulated were to go to auction.

Mr. Semprini asked about the 10 vehicles waiting for repair. Where is the repair being done? Mr. Lundquist stated they are repaired at Mid-Cape, and Dave's Reconditioning cleans up the cars for him.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken for the following findings: That Cape Cod Auto Connection, 152 Ridgewood Avenue, Hyannis, Tom Lundquist, Manager was over the vehicle count on all three days as counted by the Police Department.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken as to guilt or innocence that based on findings the licensee is guilty of being over the license quota.

Mr. Hoxie asked Officer Maher for a recommendation. He stated this licensee was in here in 2009 and again today on the same violation. Having considered everything, he still was over both times the establishment was revisited, and he thinks the violation is more severe that the first time. He recommended a week's suspension. Mr. Hoxie asked if he would not recognize the Planning Board situation might have caused the

first problem. Officer Maher thought he might concede that Mr. Lundquist did not understand the procedure at that time. However, at this time he only tried to change the license after being caught at infractions of numbers and doing repairs.

Attorney Kenney argued that he had been told by the Licensing Board he could have 70 vehicles and then accumulated 70 vehicles. He had an illegally grandfathered repair shop. He went to the Planning Board without counsel and the Planning Board told him he could then not do the repairs – but only had the license for sales, not repairs.

Attorney Kenney said he has to do some research before going back to the Planning Board. On the new violation, Attorney Kenney argued that his client did not receive the message about a deadline. He did take immediate steps to get his paperwork to file but had to wait for the plan to actually file it. Attorney Kenney asked that the Board not suspend the license; it would cause a significant hardship. Officer Maher stated after the FIRST inspection he could have asked for a Show Cause Hearing. He stated that you are either in compliance or are not. Mr. Lundquist is one of the only ones to be here today as he did not move the vehicles quickly as the others did. Attorney Kenney stated he took the inventory, tried to separate out the vehicles not to be sold from the others.

Mr. Scali stated letters went out to five licensees. Mr. Lundquist stated when he received our letter he called Officer Maher to discuss this.

Mr. Hoxie is in agreement with the 7 day suspension recommended by Officer Maher to be held for one year from today to make sure he complies. If any other violations occur he would serve that plus whatever the new violations were. If none it would be filed.

Officer Murphy stated the police department will of course go along with any decision the Board makes.

Mr. Sullivan stated he is tired of hearing that they "accumulate for auction." He thinks they should not be doing that if it means they are over the total number allowed on their license. To plead ignorance does not fly. Mr. Semprini asked if there is an area he puts the "auction" cars — Mr. Lundquist says there is; an area for the auction and the junkyard vehicles. Mr. Lundquist stated these places will not take one at a time. He also said he did not realize there were that many cars. He stated there is an area for sale vehicles. Mr. Sullivan stated the number should include the "auction" cars. Mr. Scali reiterated his number includes ALL vehicles, period. Attorney Kenney stated he does understand this now.

Mr. Burman stated the violation is there. The number is the number. There is no such thing as "reserves." It is impossible for us to enforce helter skelter. He believes Mr. Hoxie's suggestion would make a lot of sense for sanctions.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken for the following sanctions: A seven day suspension to be held in abeyance

for one day from today and if any further violations it would be served along with the new violation. If no further violations, it would go away.

Show Cause Hearing: A Show Cause Hearing was requested by the Barnstable Police Department for Prime Pre-Owned Center, 95 Falmouth Road, Hyannis, Matt McGovern, Manager, alleging that it was non-compliant with regard to the total number of vehicles allowed on the licensed premises on the following dates: 8/30/13, 9/16/13 and 9/24/13, and have an additional storage lot not contained on the licensed premises, and despite conversations with the manager advising on the last visit to file by September 20, 2013 a Show Cause Hearing would be requested, no-one has filed to amend the license. (Application for change to be heard at 12/9/13 hearing).

Officer Maher appeared for this show cause hearing. Mr. Fallows appeared for Prime as General Sales Manager, stating Mr. McGovern had a death in the family. This is his first town meeting. They expect to be before the Board again on 12/9 for the change to the license.

Officer Maher stated that on 8/30 a first inspection was conducted – there were 73 vehicles when the license allows 40. He also observed another fenced lot behind the first, which lot was not listed on the license. He met with Tim Fallows at that time.

Officer Maher said that on a second visit 9/16 there were again 70 vehicles instead of 40.

Mr. Fallows does not dispute the overage on the days inspected.

Mr. Hoxie asked how many are there today; Mr. Fallows stated he was not sure. Mr. Hoxie stated there are 92 cars today.

Officer Maher stated this is a new licensee; he has no prior violations.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken that there were 70 vehicles on the premises on the dates in question instead of the 40 allowed.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken that Prime is guilty as charged.

Officer Maher recommended a one day suspension to be served.

A motion was duly made by Mr. Hoxie, seconded by Mr. Sullivan and a unanimous vote taken that a one day suspension to be imposed and held in abeyance for one year, to be served then if there were further violations in the interim.

Show Cause Hearing: A Show Cause Hearing is called on Beech Tree Cantina/Off the Hook Sushi & Raw Bar, 599 Main Street, Brian D. Beatty, Manager, in accordance with

the Town of Barnstable Noise Ordinance, i.e., It shall be considered a violation whenever the noise level created by a licensed entertainment is clearly audible on property abutting the licensed premises. It shall be the responsibility of every license holder, licensed under Chapter 138 or 140 of the General Laws of the Comm. of MA to conduct entertainment, to contain the noise created by said entertainment to their own property. Failure to do so shall be sufficient grounds for revocation or suspension of their entertainment license. This regulation requires the management to take whatever steps are necessary to ensure that the noise created by their entertainment does not disturb the neighbors.

The complainant has agreed with Beech Tree Cantina owners to postpone the Show Cause Hearing to the February 10, 2014 meeting as the sound engineer will be meeting with them today to work out a resolution to the sound issues.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan and a unanimous vote taken to postpone the Show Cause Hearing for Beech Tree Cantina/Off the Hook Sushi & Raw Bar to February 10, 2014.

Request to Appeal Suspension Dates: Request of Davester, LLC, d/b/a Embargo, 453 Main Street, Hyannis, David Noble, Manager to change the dates of suspension imposed for November 29th and 30th, 2013 in accord with letter from Attorney Robert A. Bianchi.

Attorney Bianchi appeared to request a change in suspension dates to December 29th and 30th – a Sunday and Monday. Attorney Bianchi stated that his client wants to conclude this in 2013. They need to do this so the new Manager can then be appointed. They will withdraw their appeal to the ABCC if the Board grants these two new dates.

Mr. Hoxie stated they were scheduled for a Friday and Saturday suspension. The violation was on a Thursday. Attorney Bianchi stated there is punch to this as it is the holiday season. Mr. Noble stated he will be doing some cleaning and using his employees to do that during the suspension time so they will have some earnings. Officer Maher stated unfortunately this is not allowed during the suspension time. He has 30-50 employees during the season. Probably 21-25 are working during this time.

Elizabeth Wurfbein came forward for Embargo. She stated that the police department works very well with all the businesses on Main Street. In this instance she wanted to speak for Embargo. She stated that they acknowledge the mistake made. This restaurant is a well run "highlight" on Main Street. It is high quality and raises the bar for Main Street. Everyone here is trying to do their best; she applauded the police, Regulatory Services, the Board, etc. and hopes the Board will keep in mind the mission in going forward.

Mr. Scali stated no application can go forward for Change of Manager when there are DUA issues, which this restaurant has. Those would have to be cleared up first. Attorney Bianchi stated they are working on that.

Lt. Murphy stated they are striving to go in the same direction but on this one date this did not happen. He deferred to the Board for the dates. He would not object to the changed dates.

Mr. Sullivan wanted clarification for December 29th & 30th; that Mr. Noble will be paying his salaried and hourly employees in spite of the closing. Mr. Burman states this is the first time in years they have negotiated a penalty. He agrees that we should accept it.

A motion was duly made by Mr. Burman, seconded by Mr. Sullivan, and a unanimous vote taken to change the suspension dates to December 29th and 30th, 2013, with 3 days to be held for 1 year from the original decision date and that the appeal be immediately withdrawn from the ABCC by Embargo.
