2. Police Department updates: ABCC was in town to conduct over service stings; Lt. Murphy was contacted prior to. Additional information will be provided to the Board at the next meeting. Mr. Hoxie asked about lack of supervision if they are found guilty. Is this double jeopardy? This should be looked at via case law. The offshoot of over service creates numerous issues. It has the potential to create other problems.
