#### D. Ball Fields

**Patti Machado** stated we have a lot of issues with our fields. Lombard received CPC funds. **Richard Sawyer** asked the process for decision, money for Lombard but not Lopes. **Patti** stated bigger issues with conservation, if not mistaken. **Lynne Poyant** stated issues with drainage, part of why, amount of money it would take was not available in this round. Discussion followed.

New Chairperson is **Kevin Turner**. **Kevin** nominated **Joe O'Brien**, for Vice Chair, **Rene King** second. All in favor. **Joe** accepted Vice Chair position.

**Osterville Bay Report, Kathy Pina** – March 23, given packets for six proposals for engineering, narrowed down to three, consensus was VHB would be given the award. We will have some post meetings at the

**Marstons Mills Field Update** – **Joe O'Brien** stated received email from Tom Lynch that the RFP process for the Marstons Mills School is being extended into the summer. Trying to exhaust all options in trying to get some money for the building. **Joe** stated he wanted Tom to understand we have a sort of commitment to Barnstable Little League. The sub committee is going to sit down and regroup and weigh options. **Steve Mele** asked if the price tag is \$100,000. **Joe O'Brien** stated anything under will not be accepted. Town is only selling building. Discussion followed.

**New Business – Kevin Turner** motioned that August meeting be changed to the 12<sup>th</sup>. **Joe O'Brien** second, all in favor. **Joe O'Brien** stated William Dado has had one reading to be new commissioner. **Richard Sawyer** stated he has been sworn in as commissioner expiring 6/30/16.

Joe O'Brien stated Diane Klaiber, tentatively, fees, and liaison for Centerville playground for August's agenda.

Joe O'Brien made motion to adjourn Kathy Pina second, all in favor. Meeting adjourned at 7:03PM.
