# **Staff Report:**

#### Nina Coleman addressed the Board:

- The gatehouse is open every day from 9 am to 4 pm with extended hours on Friday and Saturday until 9 pm. After Memorial Day the hours will be extended every day from 8 am to 9 pm.
- Sandy Neck is now fully staffed.
- As of May 1<sup>st</sup>, curfew in place must be off the beach by 11 pm. No one past the gatehouse after 9 pm. This does not include cottage owners or campers and chase vehicles.
- Regarding high tides and camping/beach conditions check the website for information. Will make sure the website is up-to-date.
- There are many plovers nesting east of Trail 6. As always, too early to tell if they will be in the ORV corridor.
- There will be a Sandy Neck Plover Walk on Tuesday, June 15th, 10 a.m. noon with Nina Coleman. It is a one mile hike. This is one of many educational hikes provided during the spring and summer. Usually one a month. Check the website.
- Diamondback terrapin turtles will be nesting on Sandy Neck in late June and July.
- On May 1<sup>st</sup>, NRO Matt Gough gave a presentation, *Welcome Back ORVs*. It was a good event and they hope to do it again in July.
- Beach cleanup was held on April 25. Great job. Lots of folks showed up. Thanks to everyone who participated.

# **Continuation of Cottage Colony Guest Parking Discussion**

# Rich French addressed the Board:

In review, the Sandy Neck Beach Management Policies with regard to guests of property owners remains in effect. But, after the meeting, there was the idea of having off site parking available at the West Barnstable Railroad Station. This is town owned land governed by the Lombard Trust. This would be off site parking available for anyone that can not park – for whatever reason – at Sandy Neck. It is not just for the cottage/property owners. This would be for overnight parking with proper hangtags.

# At this point, Rich French opened the discussion to the public:

*Lucille Moquin* stated that Sandy Neck is special. That is their road. People should be able to come. Sandy Neck is unique. They want to be treated special and unique. [Note: her letter was submitted later and on file.]

**Pamela Buck** spoke. She is a taxpayer in Barnstable. She has a cookout at her cottage on the beach for her friends. She wants them to be able to park at the beach for free. Also, if the beach parking lot is full, she wants a place for her friends to park.

Paul Stingley asked if this off site parking would be free. Rich French answered "yes".

**Deborah Nourse** was concerned. If this off site parking does not go into effect, where will her friends and the friends of her kid's park? They do not have the money to pay for parking. This will be a burden for them to pay.

*Cheryl Letourneau* spoke. She feels the problem is that the property owners should have been notified before the Board made any decision. She wants more communication. She likes the idea of off site parking. *Rich French* stated that the Board has always tried to have an open dialogue and keep everyone informed

**Bill Carey** explained that he was in fact told by the Town Attorney that there could be a conflict or an appearance of a conflict and neither he nor Lynn Heslinga (as cottage owners) should speak on this issue. They are supposed to recuse themselves.
