## Sandy Neck Board Meeting October 20, 2014

A regularly scheduled meeting of the Sandy Neck Board was held on October 20, 2014 at the Selectmen's Conference Room, 367 Main Street, Hyannis, MA. The meeting was called to order at 7:33 pm by Chairman Rich French.

#### Roll Call:

- Board Members present: Lynn Heslinga, Nate King, George Muhlebach, Pete Sampou, Tom O'Neill and Rich French.

- Public: Skip Crone, Paul Connors, Judi Connors, Diane Hill, Marie Thomas, Peter Thomas, Wendy Paquette, Diane Lomba, Kylie Palomba, Robert Lovell, and two others (who did not sign in).

#### Act on Minutes:

 On a motion by Lynne Heslinga and seconded by George Muhlebach, the Sandy Neck Board voted to approve the September minutes as printed.

#### **Staff Report:**

#### Nina Coleman addressed the Board:

- The Gatehouse hours are Monday Thursday 9:00am to 4:00pm and Friday Saturday 9:00am to 6:00pm. Sunday 9:00am to 4:00pm. Park Entrance is under the winter hours which are daily 8:00am to 6:00pm. You must be past the gatehouse by 6:00pm to stay on the beach until 8:0pm (unless you are actively fishing). You still need an ORV sticker, but there is no charge for overnight camping.
- There is now an active hunting season for pheasants, rabbits and ducks. There is no hunting allowed on the front beach and there is no hunting on Sundays.
- CoastSweep was held in September and was very successful.
- There were two groups that recently used the Halfway House for educational purposes.
- Nina Coleman held a hike called "The Hunt for Red October". They searched the dunes (off trail) looking for freshwater cranberries. Good year for cranberries.
- Terrapin hatchlings were successful again this year. She has applied for a grant to help pay for the some of the program. MET grant money comes from Cape and Island license plate money.
- Incident reports since last month: one for someone who fell off their horse, one search and rescue, and one alleged theft of a cell phone.

#### **New Business:**

#### Thatcher Drake - Eagle Scout Project

Thatcher Drake addressed the Board. He is a 17 year old who will be starting on his Eagle Scout soon. There is an old foundation (from the Winder Cottage) that is still intact. He would like to build an Adirondack type shelter (8x12) with 3 walls and the one open side would face the marsh on that footprint. (*See locus pictures attachment #2.*) It could be used by hikers as a safe place to stay at night and used in rain/cold weather. Plus this would allow for shade while hiking in summer. It would not impact the environment because the area is already cleared. He would like to complete this project by early May 2015. Once his plans are drawn, Nina Coleman will start the permitting process. The Board was in support of this project.

#### **New Business:**

#### Street lights at Sandy Neck - converting to private ownership

Rich French explained that there are three street lights at Sandy Neck - one at the gatehouse and two at the air station. The county - through Cape Light Compact - has suggested that the lights be changed to LED lights. Currently, the lights are leased from NSTAR. Sandy Neck owns the poles which were installed with the bathhouse construction project. They installed new poles with new wiring. He is suggesting Sandy Neck buy the lights (for a nominal fee ~\$1) and have them retrofitted with LED lights since Cape Light Compact will do it for free. Bonus is the monthly cost for the electricity will be drop considerably, these new lights will focus/shine downward, and these lights are whitish not the orange glow from the sodium bulbs. The conversion program ends December 1<sup>st</sup>. The lights are guaranteed for 10 years.

On a **motion** by Nate King and seconded by Pete Sampou, the Sandy Neck Board unanimously voted to support the proposal presented to purchase the street lights from NSTAR and, once done, convert them to LED lights.

#### **Old Business:**

#### Continuation of fee discussion

Rich French reviewed the new proposed fee schedule (See attachment #3) He reiterated that the Board has stated they did not want a one-time big fee increase but rather wanted it to be a gradual increase over three years.

Last month, the Board voted in favor of these fee changes:

Nina Coleman addressed the Board and stated she was changing the overnight fee for Chase Vehicles to \$5 which would reduce the fee by \$3 per night (\$8 down to \$5). She also reviewed the Comparison Sheet. (Attachment #4) which averages about \$49/night. And reviewed the 2014 ORV sheet (Attachment #5).

#### There was a discussion among the Board Members. These are some highlights:

- > Still a good deal.
- The dune stabilization project is \$90,000 this year and approximately \$365,000 next year which comes out of surplus. Need to rebuild surplus. Engineering money already secured. Applied for grant money.
- Additional money needed for more staff.
- > The upper parking lot has the septic system. Must plan ahead to make sure do not lose more sand & parking lot.
- > Can Bodfish fees be increased? [REC controls those fees not MEA]. Sandy Neck gets a "weighed portion" from REC and could that portion be increased? [Nina Coleman stated it is under review.]
- ➤ Can an additional sticker fee be charged for the use of Sandy Neck an upcharge when you buy your town beach sticker? Can there be a fee and that money go to dune stabilization?

#### The public commented on these proposed changes:

- > Peter Thomas asked what the fee increases are for? Is there a deficit to justify this increase? Why isn't it spread across all user groups and not just an increase for ORV people.
- > Bob Lovell said be careful you do not price out the ORV users. Why not the increase the fee to the daytrippers?
- ➤ Wendy Paquette felt that you could not compare Sandy Neck fees with other campgrounds because you do not have water, electric or dump stations. Other towns have one fee only no overnight camping fees.

Nina Coleman clarified that the fees for chase vehicles were going down so it would be less - not more - per night. The overnight fees would be \$10 (resident) \$20 (non resident) and \$5 (chase) and it would generate approximately \$10,000 next year. That money would be used for more staff. And staff is utilized by all users.

- > Peter Thomas asked if there could be a daily charge for day trippers.
  - Nina Coleman stated that she could not handle a daily fee. She does not have the staff. If needed, the sticker price would increase rather than a daily fee. That will be looked at in the future.
- > Brewster Brown why is it difficult to charge day trippers?

Nina Coleman stated that she could not handle stopping each car and collecting a fee and processing it. It would be too cumbersome. Last time there were daily fees, cars would line up down the street. There were emergency response issues. The day tripper might be charged more next time we do fee increases but it would be an increase in the sticker price itself which in turn offsets not being charged each time.

#### The Board Members continued their discussion. These are some highlights:

- > Full support of increasing \$10 (resident) \$20 (non resident) and \$5 (chase).
- The recommendation for a separate sticker for resident day tripper use should be pursued.
- We need a fee structure for all fee sticker increase by all users. A certain percentage increase across the board. Are we spending too much time on details? We need money to run the beach.

#### The Chairman allowed more public comment:

- Judi Conners asked again why day trippers are not charged a daily fee.
- > Skip Crone said that chase vehicles only have 6 more hours on the beach than day trippers but chase vehicles have to pay to stay overnight.

A motion was made by Pete Sampou and seconded by Tom O'Neill to except the fee changes (as modified by Sandy Neck Park Manager Nina Coleman and presented tonight) entitled *Proposed Sandy Neck Fees for 2015* (draft 10/14/14). Vote: All voted yes except Nate King who abstained.

A motion was made by Pete Sampou and seconded by Nate King requesting staff investigate the potential for increasing the current percentage and amount of money Sandy Neck receives from the Town Recreation Program (REC) from the sale of the Town beach/parking sticker; currently the resident sticker is \$35. This is in light of the enormous expenses associated with Sandy Neck's sand restoration project that must be undertaken to protect the parking lot. Vote: All yes.

A motion was made by Pete Sampou and seconded by Nate King requesting staff investigate an additional sticker for day trippers only who utilize the ORV beach but do not stay overnight and do not buy overnight hang tags. And in addition, request staff investigate potential revenue that could be generated by collecting a surcharge for using the beach that would be used for beach replenishment only. This fee must include associated costs. **Vote**: All yes.

A **motion** was made by George Muhlebach and seconded by Pete Sampou to ask the Town Recreational Department to increase the Town beach/parking stickers; currently they are \$35. **Vote**: All yes.

A motion was made by Nate King and seconded by Pete Sampou to ask for \$200,000 from the Community Preservation Committee (CPC) to be used for the beach restoration project at Sandy Neck since CPC funds are used to restore and preserve historic resources such as Bodfish Park Beach at Sandy Neck. Vote: All yes.

#### **Old Business:**

Continuation of the Town of Sandwich fee discussion:

Nothing new to discuss at this time.

#### **Old Business:**

#### Update on dune nourishment project:

Nina Coleman reviewed the dune nourishment project. There is a request for \$90,000 from Sandy Neck surplus funds at Town Council on November 6<sup>th</sup>. This is a first reading – no discussion. On November 20<sup>th</sup>, there will be a discussion and a vote – if approved – there is a 30 day waiting period before the funds can be spent. The RFP will be for 4,000 cubic yards of sand, concentrating on the west side. Also there is an RFP for the design for soft scape which is Phase II. Those funds were secured last year. Engineering and permitting will start within the next year. Also, she has applied for a CZM grant for \$313,000.


I love and respect the beach. It takes a lot of work and money to get that beachfront property. Most campers are middleclass. With much respect we don't get those kinds of raises.

Also the 11:00 curfew is later than any camp and leaves time for people to party and then drive home. You need more staff for that.



#### Sandy Neck Beach Park

The uniqueness of Sandy Neck Beach Park "on the beach camping" cannot be overstated. This is a comparison of 2014 rates charged by like-kind campgrounds on Cape Cod. Any campgrounds allowing "on the beach camping" will be noted, otherwise the campsites will be considered close to, but not on, the beach.

Barnstable: Sandy Neck Beach Park:

Barnstable Resident: \$ 8 per night

Sandwich and Non-Resident: \$16 per night

All Chase vehicles: \$ 8 per night

**Bourne: Bay View Campgrounds:** 

May 1<sup>st</sup> through June 27<sup>th</sup> \$45 per night June 27<sup>th</sup> through September 1<sup>st</sup> \$58 per night September 1<sup>st</sup> through October 15<sup>th</sup> \$45 per night \*\***Average is \$49 per night**
