- There were 27 plover nests with 47 chicks fledged. That was good. Terns were not as successful due to predation. FYI plovers are federally listed/protected. Terns are state listed/protected.
- CoastSweep is Sunday September 23<sup>rd</sup> 9 am to noon. Everyone is welcome please come help.
- Also, hiking for Terrapin Hatchlings on Sandy Neck, Saturday, September 15, 10 am noon.

- The APP worked wonderfully this summer. Great informational tool.

# **Old Business:**

#### Bill Monroe reported:

- Still need to accomplish a few minor tasks and then will be complete. Some students from Pete Sampou's class may be available.
- Hoping for an October dedication. He explained the history of the projects.

# **New Business:**

#### Chairman Tom O'Neill introduced Town Manager Mark Ells and asked him to (1) explain what he sees as the role of the Sandy Neck Board and (2) what would he like to see regarding Long-term Coastal Resiliency Alternatives Report. These are highlights from what Mark Ells reported:

- ✓ The Sandy Neck Board is advisory to the Town Manager.
- $\checkmark$  They play a role to help preserve the beach.
- ✓ Need to work on continued communication need to have a good "back and forth".
- ✓ Rules and regulations, fees, management of resources are important issues that the Board should look at and have staff report any recommendations to the Town Manager (if needed).
- ✓ As for the resiliency plan it is not ready. He will see about how/when/if it should be brought forward. Need to keep the communication open. But more still needs to be done before it can be brought forward. Step back since there are questions that still exist about immediate and long range approaches. The plan came to him as a final alternative but he still wants to review all alternatives and see what conclusions he would come to as a capital project.
- ✓ Design and permitting money needs to be discussed. Gatehouse, trails and parking issued need to also be addressed. Need to protect Sandy Neck and don't lose parking in any more storms. What can we do to protect our assets.
- ✓ Continue to work with the State and keep an open mind. The Town Manager relies on his Staff. Also, we will look for grant money.
- ✓ Communication between the Board and Town Manager recently broke down and he does not want that to happen again. Please work with Nina Coleman and he will work with her as she is the Park Manager.

- ✓ Town Councilor Wallace said that when Tom O'Neill (as Sandy Neck Chairman) meets with the Town Manager he should request someone from Town Council also be present so that the communication between everyone is open.
- ✓ Bill Carey asked if a "clerk of the works" could be hired. "Why haven't we moved this further along. Why aren't other departments helping us along". Town Manager Ells said that we are not there yet. This project is still conceptual. It is not a construction project yet. Too early. Other departments will help if and when they are needed.

- > Public Outreach and Public Use & Participation = Bob Lovell, Bill Carey, and Bill Monroe.

### **New Business:**

#### Discussion regarding increasing the number of members on the Sandy Neck Board

Chairman O'Neill reported that this is a Town Council decision not a Board decision. This Board has no authority over the number of members on their Board and he has no interest in bringing the idea forward [to the Town Council] to increase that number. We should encourage people to come to the meeting and talk during public comment.
