Proposal: Proposed modification of Planning Board Special Permit No. 2016-03 to reflect changes to parking space layout; increased number of HC accessible spaces from 5 to 10; and, reduction of overall parking space count from 117 (previously-approved) to 112 on 0 Engine House Road. An interconnection with proposed new adjacent pay-to-park lot at 9 Engine House Road with revised emergency vehicle and fire truck access to both 0 Engine House Road and 9 Engine House Road is proposed. A new Planning Board special permit for lot at 9 Engine House Road will be required. Total number of pay-to-park spaces will be 224 (112 spaces on each lot).
Special Permits from the Planning Board will be required.

For your information the section of the M.G.L. that pertains to postings of meetings is as follows: Except in an emergency, in addition to any notice otherwise required by law, a public body shall post notice of every meeting at least 48 hours prior to such meeting, excluding Saturdays, Sundays and legal holidays. In an emergency, a public body shall post notice as soon as reasonably possible prior to such meeting. Notice shall be printed in a legible, easily understandable format and shall contain: the date, time and place of such meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting. Meetings of a local public body, notice shall be filed with the municipal clerk, and posted in a manner conspicuously visible to the public at all hours in or on the municipal building in which the clerk's office is located.
