SUMMARY

Maureen Niemi, Town CollectorDATE:January 24, 2011SUBJECT:Change in Town Clerk and Town Collector Fee Schedules

BACKGROUND: Fees were increased in 1988 for the Town Clerk, then subsequently a few items were increased in 2003. In the Clerk's office costs have increased, salaries have increased, and demands on staff time have increased. After thorough consideration of the time and efforts on all of the duties required for each of these, it is felt that the increases are minimal and fall within a cost of service structure.

The Town Collector feels that an increase in the demand fee and the fee charged for a Municipal Lien certificate would bring the Town of Barnstable within the scope that other surrounding communities are charging as the current fee structure is low. An increase in the Municipal Lien Certificate fee would cover the cost of producing same. An increase in the Demand fee may encourage more timely payments, which would help the Town's cash flow and budget. Both fees at present are low compared to numerous other Town's contacted and the new fee structure would still allow an additional increase if necessary according to Chapter 60 and Chapter 40 of the Massachusetts General Laws.

FISCAL IMPACT: The Town Clerk projects an annual revenue increase of just over \$1,000. The fees are in keeping with recommendations of the Massachusetts Town Clerks' Association.

The Tax Collector projects an annual revenue increase resulting from these fee increases are \$36,000 from MLC's and \$53,000 from demand fees. This revenue will be used to offset the costs of the Town Collector's operations.

BACKGROUND: The construction of the new Passenger Terminal Building requires the installation of a new permanent Main Terminal Aircraft Parking Ramp area immediately in front of the new Terminal and to cover areas previously occupied by recently demolished buildings; and to enable continued aircraft parking, during and following completion of the new building. This project will include the design and installation of the new pavement, which will serve as Phase I of the project scheduled for FY2013 to complete the reconstruction of the entire Main Terminal Ramp.

ANALYSIS: The project is necessary to provide a new permanent aircraft parking ramp for continued access to passenger aircraft at the new terminal building following construction of the new terminal; and it must be designed as a permanent 20-year structure to qualify for Federal Aviation Administration (FAA) Airport Improvement Program (AIP) and Massachusetts Department of Transportation (MDOT) Aviation Safety and Maintenance Program (ASMP) reimbursable grant funds.

It became apparent while exercising prudent planning for construction of the new Passenger Terminal that the demolition of the former operations building and Terminal II needed to be completed 3 years ahead of previous plans associated with the design and construction of the new main terminal aircraft parking ramp project (previously submitted by Town of Barnstable Capital Improvement Program projects AIR-11-4 and AIR-12-11) in order to facilitate safe aircraft operations and passenger handling from the new terminal. The demolition was completed within the new passenger terminal construction project budget. Construction of the new permanent Phase 1 aircraft parking ramp will be capable of handling all current and projected aircraft using the ramp.

Bids for this project as a "temporary" 5-year ramp were included in the main terminal construction bids as Guaranteed Maximum Price alternates; however, they were not accepted due to funding constraints. In order to qualify for FAA and MDOT reimbursable grants, this project must be rebid utilizing Federal bidding requirements as a "permanent" 20-year ramp.

FISCAL IMPACT: This appropriation of funds will be sufficient to complete the project and there are adequate airport enterprise reserve funds available until reimbursed by the FAA at 95% and MDOT at 2.5% of total eligible costs. This appropriation will not be added to the base operating budget of the airport enterprise fund going forward.

TOWN MANAGER RECOMMENDATION: The Town Manager recommends approval of this appropriation order.

BOARD AND COMMISSION ACTION: Project approved by the Barnstable Municipal Airport Commission as an FY2011 Supplemental CIP and as part of the FY2011 FAA and MDOT ACIP.

BACKGROUND: Massachusetts Housing Finance Agency, the proposed first mortgagee for this project, and is bound by HUD's risk-sharing regulations that do not allow the Town's affordability restrictions to survive a foreclosure of their first mortgage. However, there currently exists, and will be in first position after this transaction, a HUD restriction that requires 112 of the units to be affordable to households below 60% AMI. This transaction will extend HUD's restriction in first position until 2036 and that 112 units will be affordable for 25 years at under \$4,500 per unit. The Town's restriction will continue after 2036 unless there is a mortgage foreclosure. Worst case, without this transaction, another one would have to be put together before 2016 or Cromwell Court could convert to all market units after that.

The Community Preservation Committee recommends the approval of this request for the preservation of affordable housing at Cromwell Court.

BACKGROUND: Glenna Kohl was a longtime Barnstable Recreation Division employee whose life was cut short in November 2008 after a courageous three year battle with melanoma. Glenna was a much loved lifeguard at Dowses Beach prior to her diagnosis. Her colleagues in the Recreation Division have worked with Glenna's parents – Colleen and Bob – to ensure that the mission of the Glenna Kohl Fund for Hope is carried out. The mission is to carry on Glenna's work to bring awareness to everyone about the dangers of melanoma and the importance of early detection and prevention of this deadly disease. They held their first annual "Piggy Trot" on May 23, 2010. It was a 3.7 mile road race held at Dowses Beach in Osterville. There were 323 registered runners and over 400 people in attendance.

RATIONALE: Melanoma is the most serious type of skin cancer. It begins in skin cells called melanocytes. Melanocytes are the cells that make melanin, which gives skin its color. Melanin also protects the deeper layers of the skin from the sun's harmful ultraviolet (UV) rays. When people spend time in the sunlight, the melanocytes make more melanin and cause the skin to tan. This also happens when skin is exposed to other forms of ultraviolet light (such as in a tanning booth). If the skin receives too much ultraviolet light, the melanocytes may begin to grow abnormally and become cancerous. This condition is called melanoma. The lifeguard canopies were made by the Barnstable Canvas Company and are made of 100 percent acrylic fabric and welded with aluminum piping. The eight lifeguard tower canopies, added to those previously donated to Dowses, will provide lifeguards at Craigville Beach, Covell's Beach, The Loop and Millway Beach with protection from the sun and its harmful ultraviolet rays.
