**SUBJECT:** Acceptance of gift of six beach wheelchairs from SMILE Mass for Keyes (Sea Street),

Kalmus, Wequaquet, Hamblin's, Hathaway's and Sandy Neck Beaches.

**BACKGROUND:** SMILE Mass (Small Miracles in Life Exist) is a Massachusetts Chapter 501(c) (3) non-profit corporation. The mission of SMILE Mass is to help handicapped children and their families enjoy wonderful vacation experiences — for a day or for a week — that will create memories that will last a lifetime. For many of these families, this could be their very first family vacation.

Phase One of SMILE Mass's mission was to purchase and donate 100 beach wheelchairs to public beaches on Cape Cod. In 2012, they delivered 20 Mobi-Chairs to 20 beaches in 12 towns on Cape Cod. Last year, the Town of Barnstable received three additional chairs. This year, we were presented with six additional chairs.

Made by Mobi-Chair, the wheelchairs look much like beach recliners and are fully equipped with shockabsorbing wheels that can handle sandy terrain and even allow for flotation.

RATIONALE: This gift will provide access to the beach and ocean for handicapped children and their families. The Mobi-Chair is a high quality, amphibious rolling beach chair that high quality, amphibious rolling beach chair that provides a seamless transition from the parking lot, across the sand, and right into the water. The aluminum frame and stainless steel parts are corrosion free from salt water and the floatation wheels and armrests provide an unprecedented experience due to their stable buoyant design. Each chair costs approximately \$5,000. SMILE Mass has donated six Mobi-Chairs to the Town of Barnstable. Chairs from past years were given to Covell's Beach, Craigville Beach, Kalmus Beach, Veterans Park Beach, Dowses Beach, Loop Beach and Millway Beach. This year's chairs will be going to Keyes (Sea Street), Kalmus, Wequaquet, Hamblin's, Hathaway's and Sandy Neck Beaches.

**FISCAL IMPACT:** There is no fiscal impact.

**BOARD AND COMMISSION RECOMMENDATION:** The Barnstable Recreation Commission and the Barnstable Disability Commission recommend acceptance of this gift.

**TOWN MANAGER RECOMMENDATION:** The Town Manager recommends acceptance.

support the Barnstable Senior Services Division's Part-time Van Driver Position

**RATIONALE**: The Friends of the Barnstable Council on Aging recently received notification that it was the beneficiary of \$5,090.79 from the estate of Virginia Gorse of Centerville, who passed away on January 5<sup>th</sup>, 2014 at the age of 95. Mrs. Gorse was a longtime member of the Barnstable Senior Center and a regular participant in our programs. When she was no longer able to drive, she became a frequent client of the Senior Center's "Silver Express" transportation program and she often remarked how much of a lifeline the service was to her in maintaining her independence.

With the approval and support of the Friends of the Barnstable Council on Aging and the Barnstable Council on Aging, it was determined that the best use of the funds would be to help support our part-time van driver position. Since this position was established in 2011, we have relied on grant funding and the financial support of the Friends of the Barnstable Council on Aging to sustain it. Mrs. Gorse's bequest would allow us to continue funding the position through FY15. We are extremely grateful to Mrs. Gorse for her generous gift and to the Friends of the Barnstable Council on Aging for their continued support.

**FISCAL IMPACT:** There is no immediate financial impact to the Town's operating budget resulting from accepting this gift. However, in order to continue this service after the funds are exhausted the cost will need to be added to the Senior Services operating budget if another funding source is not obtained. Otherwise, the service will have to be eliminated.

**BACKGROUND:** The Town of Barnstable Department of Public Works has been awarded a \$62,000.00 grant from the Massachusetts Historical Commission's Round 20: Massachusetts Preservation Projects Fund. The Massachusetts Preservation Projects Fund was created in 1984 to aid nonprofit agencies in the conservation of property, landscapes, and cultural resources that have been listed as Massachusetts State Register of Historic Places.

**ANALYSIS:** The acceptance of this grant will allow the Department of Public Works to contract for the removal of exterior paint; restoration of the brickwork; repair and replacement of exterior ornamental ironwork and; restoration and repair of front entrance elements, including granite steps. This is a continuation of work completed under the Capital Improvement Program and Community Preservation Act to repair, improve, and maintain this historic structure.

**FISCAL IMPACT**: The grant requires 50:50 matching funds of \$62,000. Matching funds are available from funds that were provided for this project by the Community Preservation Committee and approved by the Town Council (Council Order 2014-143).

**TOWN MANAGER RECOMMENDATION:** Town Manager Thomas K. Lynch recommends acceptance of this grant.

SUBJECT: HYANNIS ARMORY LEASE TO 225 SOUTH STREET, LLC

BACKGROUND: Consideration of the future use of the Hyannis Armory has been the subject of considerable attention of Management and the Council over several years. After a Request for Proposals to lease the property was published, the result was a single bid received. The bid proposed to convert the property into an Archeological and Education Center named, "Real Pirates". The focus of the exhibits would be on the recovered artifacts of the pirate ship Whydah. The Request for Proposal established certain goals required to be achieved. The proposal was accepted by the selection committee, which was made up of town councilors, community members, and Town staff. The selection committee recommended acceptance of the proposal and that the Town should proceed with lease negotiations with the principals of the project. The Town staff has successfully completed negotiations for the lease of the property, which achieves the goals that were set out.

**ANALYSIS:** Some of the salient conditions of the lease include a term of twenty-five years, with the lease commencing on September 1, 2014, and the term commencing on March 1, 2015. The delayed commencement will allow for completion of tenant improvements at its cost.

The principal use of the property will be as a Museum focused on the pirate ship Whydah and it will be a state-of-the-art facility and will be operated in such a fashion to equal or exceed the standards and quality of the National Geographic Museum. The Museum will also appropriately commemorate the events surrounding the acceptance speech of President-Elect John F. Kennedy given at the Armory in 1960. The Museum may be closed for a maximum of 60 days per year.

The lease may not be assigned without the Town's approval, which may be withheld in the Town's sole discretion.

The rent schedule calls for \$24,000 for year 1, \$50,000 per year for years 2-5, \$80,000 per year for years 6-15, \$100,000 for years 16-20, and \$120,000 per year for years 21-25. There are two option periods for the tenant to extend the lease for 10-year windows, namely, at years 6 and 16. Starting in year two, rent will be reduced by the amount of real estate taxes paid to the town, but never to be reduced to less than \$24,000 per year.

The tenant will pay all utilities as well as repair and maintenance costs. The tenant will also be responsible for extensive insurance coverage and will indemnify the town for listed exposures.

**TOWN MANAGER RECOMMENDATION:** It is expected that the Museum will prove to be an attractive center for visitors and residents alike and will be a significant generator of direct and indirect economic benefit to the Town and Village of Hyannis.

The Town Manager recommends that the Town Council ratify the lease as negotiated.
