BACKGROUND: This project will design, permit, and complete construction to replace an existing culvert on Rosa Lane with a larger culvert for the purpose of improving passage for river herring along the Marstons Mills River on their way to spawn in Middle Pond and Mystic Lake.

The Town Council previously appropriated \$225,000 (Order 2023-078) for the purpose of design and permitting for the Rosa Lane Fish Passage Improvement Project. Additionally, the Town Council has previously authorized (2024-026) the acceptance of a \$400,000 grant from the United States Department of Agriculture (USDA) Natural Resources Conservation Service (NRCS), for the design, construction administration, construction. During design development, it has become clear that supplemental funding is necessary to complete the project. As a result, NRCS has agreed to provide a supplemental grant in the amount of \$317,500 to cover increased design, construction, and construction administration costs for a total grant amount of \$717,500.

The Town must provide a 25% non-federal match to the NRCS grant. In addition, the Town is solely responsible for the costs of permitting and any additional costs necessary to complete the project. This order includes an appropriation of \$90,000 in supplemental funds to cover these additional costs.

ANALYSIS: This grant will enable completion of the design and construction of the Rosa Lane culvert replacement to improve fish passage in partnership with the NRCS and Cape Cod Conservation District under the Watershed Flood Prevention Operations (WFPO) Program's Cape Cod Water Resources Restoration Project.

FINANCIAL IMPACT: This is a reimbursement grant. The Town must expend the funds upfront and subsequently submit for reimbursement. The Town's matching funds for this project will be provided from the Capital Trust Fund which has an available balance of \$10,054,082.

TOWN MANAGER RECOMMENDATION: Mark S. Ells, Town Manager, recommends approval of this appropriation order and grant acceptance.

BACKGROUND: The Commonwealth of Massachusetts Division of Marine Fisheries (DMF) administers a small grant program designed for the legally recognized entities to provide funding towards projects that will create, revitalize, or enhance recreational fin-fishing opportunities in marine waters within Massachusetts. The Town of Barnstable applied for and was awarded \$25,000 for the Millway Boat Ramp Parking Lot Resurfacing Project to resurface the failing driveway and parking lot approaching the Millway Boat Ramp. While a match is not required, the grant will not cover the full expense of the project, which is estimated at \$50,000.

ANALYSIS: Acceptance of this grant and authorization of the appropriation request will fund costs associated with resurfacing the failing driveway and parking lot approaching the Millway Boat Ramp. This is a reimbursement grant. The Town is required to submit records of all activities associated with the project, copies of all invoices, and a certificate of project completion.

FISCAL IMPACT: To fully fund this project, \$25,000 of appropriated funds are being requested from the Capital Trust Fund which has an available balance of \$9,964,082. This grant is a reimbursement grant in the amount of \$25,000. The Town must expend and request reimbursement of the costs. All costs associated with this grant must be expended prior to June 30, 2028.

SUBJECT: Authorizing and directing the Town Manager to submit a waiver request to the Massachusetts Cannabis Control Commission to prohibit the delivery of Marijuana or Marijuana products within the Town of Barnstable for a period not to exceed two years

BACKGROUND: Under M.G.L. c. 94G, Section 4(b), as amended by Section 25 of Chapter 65 of the Acts of 2026, delivery of marijuana or marijuana products is authorized statewide, including in municipalities that do not otherwise allow retail marijuana establishments. However, a municipality that does not authorize retail marijuana establishment licenses within its boundaries may request a waiver from the Massachusetts Cannabis Control Commission (Commission) to prohibit such delivery activity within the municipality, and such waiver request shall be granted by the Commission for a period not to exceed two years.

This waiver would allow the prohibition of delivery of adult-use marijuana or marijuana products to residents 21 years of age or older within the Town of Barnstable for a period not to exceed two (2) years. Waivers may be renewed in two (2) year increments upon request of the Town, at the discretion of the Commission. If the waiver expires and is not renewed, delivery of adult-use marijuana or marijuana products shall be permitted within the Town in accordance with applicable law. Delivery of medical marijuana and medical marijuana products to registered patients may not be prohibited.

To provide more process and notice to the residents, this item will be given two reads even though it is not a “measure”, as defined by the Town Charter, which would require two reads.

FINANCIAL IMPACT: Marijuana delivery operators remit sales tax to the municipality in which they have a host community agreement. As there are no retail recreational marijuana stores with host community agreements with the Town of Barnstable, prohibiting marijuana delivery would have no impact on Barnstable’s municipal finances.

BACKGROUND: Due to the passing of Councilor John Crow (Precinct 5) on September 9, 2026, a vacancy exists on the Town Council.

Section 2-5 of the Town Charter provides that if a vacancy occurs in the office of councilor “during the first forty-four months of a term, it shall be filled by a special election. If a regular Town election is scheduled to be held within 120 days, but more than fifty days, after the date vacancy occurs, it shall be filled by a special election within that regular election; otherwise, the council shall schedule a special election to be held as soon as is practical to fill the vacancy for the balance of the unexpired terms.”

There is no upcoming regular Town election within this timeframe, so a special election needs to be scheduled. The Town Clerk recommends that the special election be held on December 29, 2026.

FISCAL IMPACT: Costs to the Town are anticipated to be approximately \$6,000.

Re: Commonwealth Builder Program-Letter of Support for Homes at Centerville Cove

Dear Manager Carlson:

On behalf of the Barnstable Town Council (the “Council”), this letter shall serve to express the Council’s support for Commonwealth Builder Program funding for the Homes at Centerville Cove, a proposed affordable housing development in the village of Centerville in the Town of Barnstable.

As you know, Centerville Cove is a proposed affordable home ownership development consisting of thirty-five newly constructed 3-bedroom single-family homes. These homes will be offered to first-time homebuyers and priced for families earning 80% to 100% of Area Median Income.

The proposed Centerville Cove neighborhood is centrally located and walkable to public transportation, shopping, dining, and professional services. The Town of Barnstable, through its departments and boards, has worked cooperatively with the developer, including the project’s public sewer connection. On July 8, 2026, the Town’s Zoning Board of Appeals voted unanimously, by a vote of 5-0, to grant a comprehensive permit for the project (Comprehensive Permit No. 2025-025). The appeal period has expired with no appeals filed, and the permit is now final.

As the legislative body of the largest town and the only Gateway City on Cape Cod, we are keenly aware of the housing challenges facing our region and the Commonwealth. The Town of Barnstable’s recently updated Local Comprehensive Plan and Housing Production Plan both reflect these challenges. Both Plans seek to identify strategies to support workforce housing and promote attainable and affordable long-term homeownership opportunities, such as those subsidized through the Commonwealth Builder Program.

Specifically, we hear from our residents how the goal of owning a home has slipped away from their families due to the massive increase in home prices. Centerville Cove is uniquely positioned to address this need, by providing stable, affordable single-family home ownership opportunities, which will enable individuals and families to build equity and a long-term foundation in the Town of Barnstable.

The Commonwealth Builder Program is a vital component of making these much-needed ownership opportunities a reality. To that end, we strongly urge you to approve the application and funding request for the Homes at Centerville Cove.

BACKGROUND: The Homes and Centerville Cove project is a proposed affordable housing development in Centerville consisting of the construction of 35 new 3-bedroom single-family homes that will be offered to first-time homebuyers and priced for families earning 80% to 100% Area Median Income.

On July 8, 2026, the Town's Zoning Board of Appeals voted unanimously, by a vote of 5-0, to grant a comprehensive permit for the project (Comprehensive Permit No. 2025-025).

As a part of financing for the project, the developer is applying to the State's Commonwealth Builder Program. Funding from the Commonwealth Builder Program can be used to help build affordable single-family homes and condominium units for first-time homebuyers in historically underserved communities. The program application requests a letter of support from the community in which the project resides.

The attached letter of support is being requested by the applicant.

This project aligns with Goal 3A in the Housing Chapter of the Town's recently completed Local Comprehensive Plan, which states a community priority to: *Identify strategies to support workforce housing and promote attainable and affordable, equity and wealth building, long-term homeownership opportunities such as the Commonwealth Builder Program.*
