Paul Niedzwiecki highlighted the efforts of the land and water use database, and regionalizing wastewater management.

Cape Cod Water Protection Collaborative, Executive Director Andrew Gottlieb introduced "Evaluating the Merits of a Regional Approach to Wastewater Management," utilizing public input.
