

# Town of Barnstable Town Council Meeting



quorum being duly present, Council President Debra Dagwan called the December 20, 2012, Regular Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Dagwan regarding the meeting being televised live and questioning if anyone was actively taping the session.

The Pledge of Allegiance was led by President Dagwan, followed by a Moment of Silence in which she asked that we remember those lost at the shooting in Sandy Hook and the people of Newtown, CT.

President Dagwan gave a statement wherein she thanked the councilors and former President Chirigotis and Vice President Barton. She stated that she and Vice President Rapp Grassetti hope to work with the council on putting together a balanced budget that highlights public safety, schools and many other municipal issues. She set forth her new workshop schedule. She stated that she believes that we have a unified council.

### Performance by the Barnstable High School Chamber Chorus with Choral Director Marcia J. Wytrwal

### Recognition—Division 1 State Championship winners—The Barnstable High School Girls Varsity Volleyball Team

Steve Francis, from the BHS Sports Department, acknowledged the BHS Football team that were 10-0 in regular season and beat Lincoln/Sudbury. He noted they were one of the best teams. He gave credit to Chris Whidden and all the coaches as well as the team members. They had a great senior class with good leaders.

The Girls Varsity Volleyball team won a 15<sup>th</sup> State Championship. Coach Turco and the girls were present to receive recognition from the Town Council. Coach Turco acknowledged the teamwork of the girls and was so proud of them. President Dagwan read and presented the certificates to the students along with Coach Turco and Vice President Rapp-Grassetti.

Councilor Janice Barton was given a plaque in honor of her years as Vice President. Councilor Frederick Chirigotis was also given a plaque in honor of his leadership and his legacy of bringing forward a unified and strong council. President Dagwan said she appreciated his hard work for the last 4 terms.

Alan Burt – National Homeless Persons' Day – he announced the service at the Federated Church, the press conference; and that Patrick Princi is going to try to work on the county level to incorporate other communities. (He gave a handout attached as Exhibit A).

Kim Amaral – thanked the council for the conservation restriction on the island in Shallow Pond. It has been re-named Simser Island, after David H. Simser, whose estate helped to purchase it. Ms. Amaral was present with Liz Lewis from the Orenda Wildlife Land Trust. (See Exhibit B).

John Alden – the village of Hyannis absorbs the homeless problems. The problem of mental illness has stood out in recent issues. People have to talk to each other and work out situations together. Good luck.

- Write to legislators to consider a stay on the law until regulations are promulgated. She asked President to write our legislative delegation.

Councilor Barton updated council on School Committee safety actions.

- They are making sure buzzers are at front doors of all schools;
- Their leadership council has met:
- Resource officers are in the schools and visible.

President Dagwan said we are members of the Cape Cod Selectmen's Assoc. That association has sent a letter to legislators; but we will also draft one.
