Town Council Meeting March 23, 2017





A quorum being duly present, Council President Eric Steinhilber called the March 23, 2017, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Steinhilber regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

**PRESENT**: Frederick Chirigotis, James Crocker, Jr., William Crocker, Jr., Jennifer Cullum, Sara Cushing, Debra Dagwan, John Flores, Paul Hebert, John Norman, Jessica Rapp Grassetti, Eric Steinhilber, James Tinsley, Jr., Philip Wallace.

The Pledge of Allegiance was led by President Steinhilber, followed by a Moment of Silence.

### PUBLIC COMMENT:

Kyle Pedicini questioned the resistance against marijuana shops and the need to ban them. He felt regulation would be helpful and mentioned there was a need for medical marijuana as it was a better option than opioids for pain.

Gene Guill, President of Tales of Cape Cod, discussed the proposed \$85,000 grant. He noted the money would go towards restoring and improving the Old Colony Courthouse. He added the grant was contingent on receiving \$40,000 from the Massachusetts Prevention Project Fund.

John Littlefield, board member of Tales of Cape Cod, discussed the historical importance of the Old Colony Courthouse. He mentioned that the courthouse was one of only two surviving historical courthouses in Massachusetts. He urged Council to support the grant.

Bo Chu explained he likes to live in the woods. He was not happy living at the Noah Shelter or other facilities. He wanted to remain living in the woods.

Greg Masterson, board member of Tales of Cape Cod said he was supportive of the \$85,000 Town grant and the \$40,000 Massachusetts Preservation Project Fund grant.

Any resident who are interested in applying for a vacant board seat should go to our website to view all the opportunities. The Youth Commission second annual Youth Summit was about building self-esteem. This is a great lesson that everyone needs to learn to help combat drug and alcohol abuse.

### • Presentation from Glenn Cannon, Technical Services, Cape Cod Commission on the Route 28/ Yarmouth Road project

Glenn Cannon, Director of Technical Services, Cape Cod Commission gave an overview of the PowerPoint presentation. He explained the changes, widening and taking of property by MassDOT. He noted that the project was funded by MassDOT and they would control the project. He discussed the project moving from 2019 to 2020.

# **Councilor Comments and questions:**

The culvert pipe in Marstons Mills for a cost of \$7.5 million could be a great fill in project if the aforementioned project is moved out to the year 2020. Mark Ellis suggested keeping the project in the 2019 year. He explained it was major corridor and MassDOT needed to proceed on time. Tom Curry, project manager and Rob Hicks, project designer spoke about the project design regarding new sleeves for sewer, bringing the utility poles underground, and upgrading pipes. Councilors suggested this project be considered a priority project.

Ted Barnicle, Chairman Board of Water Board gave the rationale. He explained the bidding process and suggested a continuance of this agenda item.

David Albright, Principal Civil Engineer and Zack Farkes, Project Developer from Borrego Solar who had won the Town's bid, said they had several public meetings and had meet with the community to address any concerns. They mentioned there was no opposition to this 14/15 month project until this week. They presented their solar project to Town Council and the audience.

#### Open public hearing

Paul Sebra, who was opposed to the ground mounted solar photovoltaic overlay district, felt the Water Department's main concern should be the stewardship of our water

Amy Kates, who was supportive of the ground mounted solar photovoltaic overlay district, referred to the solar map and noted the property was not owned by the Town rather it was owned by the Water Department.

Jay Spence, who was opposed to the ground mounted solar photovoltaic overlay district, felt the Cotuit Water Department should not fund raise to create revenue.

Lauren Kanzer, who was opposed to the ground mounted solar photovoltaic overlay district, but was supportive of solar energy, felt there were better alternatives than the ground mounted solar.

Don Campbell, Water Commissioner, who was supportive of the ground mounted solar photovoltaic overlay district, explained the project was to help make fees affordable for all residents. He suggested meeting with residents to get a better understanding of their position and the project.

Janet Milkman, Executive Director of the Barnstable Land Trust, who was opposed to the ground mounted solar photovoltaic overlay district, encouraged council to vote against the amendment.

Edith Labran, who was supportive of the ground mounted solar photovoltaic overlay district, felt council should approve the amendment to help keep the water rates at a reasonable rate.

Scott Horsley, who was opposed to the ground mounted solar photovoltaic overlay district, felt this was a serious step backwards as removing the vegetation would not allow filtering of rain water for better water quality.

Cynthia Gardner, who was supportive of the ground mounted solar photovoltaic overlay district, felt council, should vote in favor of this amendment.

James Kinney, who was opposed to the ground mounted solar photovoltaic overlay

district, felt it would endanger the quality of the drinking water.

Sue Flanagan, who was opposed to the ground mounted solar photovoltaic overlay district, suggested subdividing the land to just 32 acres and not all 150 acres.

Mike Ferrill, who was opposed to the ground mounted solar photovoltaic overlay district expressed his opposition to the agenda item being continued to another meeting.

Denise Larner, who was opposed to the ground mounted solar photovoltaic overlay district, felt it was counterproductive to clear tress for the solar project.

Dianne Parker, who was opposed to the ground mounted solar photovoltaic overlay district, felt property values would decline with this zoning.

Dave Morin, who was opposed to the ground mounted solar photovoltaic overlay district, felt it was wrong to clear cut the trees.

Councilor Cullum was voting no on this agenda item as she felt the community had expressed their opposition.

Councilor Flores thanked the Water Board in trying to generate revenue to cover the shortfall but felt he could not support this agenda item.

Councilor Norman suggested bifurcate the overlay item.

Elizabeth Jenkins, Interim Director of Growth Management, discussed the zoning map. (EXHIBIT B)

**Article 3**. Has appointed a town official to represent the city within the district partnership of said cultural district. This official is the Growth Management Economic Development Program Arts & Culture Coordinator.

**Article 4.** Encourages all who own property or businesses within said cultural district to involve themselves and participate in the full development of the cultural district.

**Article 5.** Directs town agencies to identify programs and services that could support and enhance the development of the cultural district and ensure that those programs and services are accessible to the cultural district.

# **SECTION 1.**

**WHEREAS**, by vote at the State election on November 8, 2016, the voters of the Commonwealth approved a law regulating the cultivation, distribution, possession and use of marijuana for recreational purposes. The law provided that it is effective on December 15, 2016 and the Cannabis Control Commission was required to issue regulations regarding implementation by September 15, 2017

**WHEREAS,** Chapter 351 of the Acts of 2016, approved by the Governor on December 30, 2016 and effective immediately as an emergency law, extended the time period for the issuance of regulations by six months until March 15, 2018 (Section 11 of Chapter 351 of the Acts of 2016)

**WHEREAS**, currently under the Town's Zoning Ordinance Recreational Marijuana Establishments and Marijuana Retailers are not permitted uses

**WHEREAS**, any regulations promulgated by the State Cannabis Control Commission are expected to provide guidance to municipalities in regulating Recreational Marijuana Establishments and Marijuana Retailers

**WHEREAS**, the regulation of Recreational Marijuana Establishments and Marijuana Retailers raises novel and complex legal, planning and public safety issues and the Town needs time to study and consider the regulation of Recreational Marijuana Establishments and Marijuana Retailers **WHEREAS**, the Town needs adequate time to address the novel and complex issues associated with the regulation of Recreational Marijuana Establishments and Marijuana Retailers, as well as to address the potential impact of the state regulations on local zoning and to undertake a planning process to consider amending the Zoning Ordinance regarding the regulation of Recreational Marijuana Establishments and Marijuana Retailers and other uses related to the regulation of recreational marijuana

**WHEREAS,** the Town intends adopt a temporary moratorium on the use of land and structures in the Town for Recreational Marijuana Establishments and Marijuana Retailers so as to allow the Town sufficient time to engage in a planning process to address the effects of such structures and uses in the Town and to adopt provisions of the Zoning Ordinance in a manner consistent with sound land use planning goals and objectives.

### SECTION 2.

That Chapter 240, Article XIII of the Zoning Ordinance is hereby amended by adding a new §240-129.1 as follows:

§240-129.1 Temporary Moratorium on Recreational Marijuana Establishments and Marijuana Retailers and Associated Activities.

A. Definitions.

As used in this §240-129.1, the following terms shall have the meaning indicated:

"Marijuana accessories" Equipment, products, devices or materials of any kind that are intended or designed for use in planting, propagating, cultivating, growing, harvesting, manufacturing, compounding, converting, producing processing, preparing, testing, analyzing, packaging, repackaging, storing, containing, ingesting, inhaling or otherwise introducing marijuana into the human body

"Marijuana cultivator" An entity licensed to cultivate, process and package marijuana, to deliver marijuana to marijuana establishments and to transfer marijuana to other marijuana establishments, but not to consumers

"Marijuana establishment" A marijuana cultivator, marijuana testing facility, marijuana product manufacturer, marijuana retailer or any other type of licensed marijuana-related business

"Marijuana Manufacturing" To compound, blend, extract, infuse or otherwise make or prepare a marijuana product.

"Marijuana products" Products that have been manufactured and contain marijuana or an extract from marijuana, including concentrated forms of marijuana and products composed of marijuana and other ingredients that are intended for use or consumption, including edible products, beverages, topical products, ointments, oils and tinctures "Marijuana product manufacturer" An entity licensed to obtain, manufacture, process and package marijuana and marijuana products, to deliver marijuana and marijuana products to marijuana establishments and to transfer marijuana and marijuana products to other marijuana establishments, but not to consumers

"Marijuana testing facility" An entity licensed to test marijuana and marijuana products, including certification for potency and the presence of contaminants

"Recreational Marijuana retailer" An entity licensed to purchase and deliver marijuana and marijuana products from marijuana establishments and to deliver, sell or otherwise transfer marijuana and marijuana products to marijuana establishments and to consumers

- B. No building permit, special permit, variance, site plan approval decision or other permit may be issued under this zoning ordinance for Recreational Marijuana Establishments and Marijuana Retailers or associated activities as those terms are defined herein.
- C. The moratorium shall be in effect through and including June 30, 2018.
- D. During the moratorium period, the Town shall undertake a planning process to address the complex and novel planning, legal and public safety issues related to the Recreational Marijuana Establishments and Marijuana Retailers, to consider the Cannabis Control Commission regulations regarding Recreational Marijuana Establishments and Marijuana Retailers and related uses, determine whether the Town shall restrict any, or all, licenses for Recreational Marijuana Establishments and Marijuana Retailers, determine whether the Town will prohibit on-site consumption at Recreational Marijuana Establishments and Marijuana Retailers and shall consider adopting new provisions of the Zoning Ordinance to address the direct and secondary impact and operation of Recreational Marijuana Establishments and Marijuana Retailers and related uses
- E. Applications for permits submitted after the first publication of the notice of the public hearing which results in the adoption of this moratorium but before its effective date shall be dealt with in due course until the effective date of this moratorium, and if a permit or other relief is granted prior to such effective date, it shall be subject to the effectiveness of this moratorium and shall be issued subject to any reliance thereon being at the peril of the recipient. During the effective period of this moratorium, any application shall be denied on the basis of this moratorium. In no event shall any permit or other relief applied for after the first publication of the notice of the public hearing create or result in any protections with respect to the land, its uses or structures upon it
- F. Unless extended, continued or modified by a subsequent action of Town Council, this section shall cease to be effective on July 1, 2018.
- G. Severability. The provisions of this ordinance are severable. If any provision,

paragraph, sentence, or clause of this ordinance or the application thereof to any person, establishment, or circumstances shall be held invalid, such invalidity shall not affect the other provisions or application of this ordinance VOTE: REFER TO PLANNING BOARD - PASSES UNANIMOUS
