

Town Council Meeting May 18, 2017



A quorum being duly present, Council President Eric Steinhilber called the May 18, 2017, Town Council meeting to order at 7:00 p.m. in the Hearing Room of Town Hall, 367 Main St., Hyannis, MA.

An announcement was made by President Eric Steinhilber regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by President Eric Steinhilber followed by a Moment of Silence.

PUBLIC COMMENT:

Karen Rezendes, Library Committee Chair, thanked the Finance Department for supporting the budget and urged Council to approve the budget.

John Julius passed two petitions (Exhibit A) to the clerk and spoke about the neighborhood concerns regarding the Homeless Not Hopeless residence on Chase Street.

Laura Wentzel mentioned ninety percent of the Homeless Not Helpless pro activists do not reside in Barnstable. She added there were 172 incidents where police were called to the three Homeless Not Hopeless residences.

Sue Comer discussed Homeless Not Hopeless not paying taxes on the three residential homes.

Laura Cronin member of the Greater Hyannis Civic Association supports helping other less fortunate but was not in favor of the Homeless Not Hopeless organization.

Ed Kulma explained he supported the program but did not want the residence in his neighborhood.

Susan Dubuc discussed the police call received regarding criminal activity on Ocean Street. She was concerned about who will be moving into the area.

Jon Marchant explained this is not an issue of not caring rather it is about over saturation of one village.

Nicola King, who was representing her father, spoke about trying to sell her father's property which is located next door to proposed Homeless Not Hopeless residence. She explained the offer was rescinded after the buyer was informed of the Homeless Not Hopeless residence.

Alan Berg, Founder of the Homeless Not Hopeless organization, discussed the successful residence in Falmouth MA. He was concerned about the prejudice against the homeless.

Steve Patalano read aloud his letter, dated May 18, 2017, regarding overtaxing emergency services and the over proliferation of social services in the Village of Hyannis. (Exhibit B)

Joyce Flavin mentioned her letter, dated May 18, 2017, and reiterated her thoughts on helping the homeless rather than handing out services to them. She felt Hyannis is so beautiful that people need to earn the right to live in Hyannis. (Exhibit C)

Alan Eric Feltham read from his letter, dated May 18, 2017, explained although he supported helping those in need he did not support any form of social service agencies in the Village of Hyannis. He felt social service agencies are big business and he considered them global for-profit corporations. (Exhibit D)

David Still, Communication Coordinator for the Cape Cod Commission, spoke about the One Cape Summit and invited Council to attend this conference.

Paul Hebert read aloud a letter from Felicia Penn, dated May 16, 2017. She supported the Homeless Not Hopeless residence and urged all people to take care of each other. (Exhibit E)

Councilor response to public comment:

We will follow up and we follow the letter of the law. Proud of Hyannis and it's my village as well; it is good to hear what people have to say; we are saturated in Hyannis. Decisions are made way above us; can have critical thought but zero discrimination. Homeless Not Hopeless is a good organization. All neighborhoods are special; your life investment is your home; understand your concerns; we want Hyannis to be safe for all to come and enjoy.
