#### Councilor questions and comments:

Always asking for Mass DOT to clean-up the state roads, especially Route149 and Route 28; [Town Manager will request a clean-up of the state roads through Mass DOT]; regarding the osprey platforms, new Lombard field has some great new lights, can we get the osprey platforms [we will add that to the list] Youth Summit is next Friday [all are invited] A new offering at Cape Cod Community College, a Funeral Directors program, with the new green burials, that should perhaps be part of the program. Issue of the Water Management Plan, the body needs to become weighted due to the size of each community and this should be dollar in dollar out.

Cape Cod & Islands Water Protection Funds (CC&IWPF):

A motion was made and duly seconded to be in support of our fair share of the CC&IWPF coming back to Barnstable on the 2.75%, dollar in dollar out share for Barnstable

The Council President asked for a discussion regarding the job description/title for the Cape Cod and Islands Water Protection Fund Management Board (CC&IWPF) and nominations for the representative. This item will come before the Council at the next meeting.

The first nomination that was duly seconded was for Public Works Director, Dan Santos to serve; the second nomination that was duly seconded was for Town Manager, Mark Ells to serve in this capacity.

**Councilor Discussion**: How do you feel about being nominated; [my belief is that when a group is being formed it will cover potential modifications to the act, you would be best served by having the town manager, or a town councilor for the first three critical years] You are not determining which projects will be funded, you will be determining rate of the subsidies. [Yes]

A motion was made and seconded to withdraw Dan Santos' name from the nominations.

Attached is the Summary of the CC&IWPF currently appointed members (Exhibit B); we are fortunate to have someone that has long understanding water issues, when Mark joined the Town of Barnstable he started at the Sewer Committee. We are going to fill this out today and bring it forward to the next meeting.

# Presentation by Alan Mandl, Esquire on Municipal Permitting of Wireless Communications Facilities:

Assistant Town Attorney Charles McLaughlin introduced the Attorney Alan Mandl; regarding how we go forward with 5G installations. The changes and demands for wireless services and technology are ever expanding. The government has we have only begun to see the concerns from the residents the strong position asserted by the government, how we go forward with the 5G installations, Attorney Alan Mandl will be presenting the changes in the demand for wireless services, and technology. (Exhibit C)

#### Public Comments:

Anthony Ambrogio questioned if there are pending cases of historical districts and zoning bylaws that restrict cell installations are currently under review [a set of standards are a part of this process, how do you reconcile a zoning permit and a historical district]

Building Commissioner, Brian Florence you can imagine this is not an easy thing for a permitting authority to weed through this process. Close public comments

#### Councilor questions and comments:

Can you tell us how much research has been done, on how the radio frequency affects

human beings [I take the law as I find it, I am concerned personally; tremendous amount of mistrust, I don't have an answer, serious issue, hopefully the law will catch up to the science] Advise us as a community, where we could get some facts [I do not know] There is a huge body of literature, there is a spike in young girls with breast cancer, because girls have put the phones in their bras, the FCC is steamrolling municipalities; in regards to fees, what do we bring in revenue wise; looks so bleak, do you see some legitimate options to formulate protections for our community [there is hope, safety standards are still recognized by the FCC; and a utility may refuse connections due to other connections currently residing on the poles] If a town does not conform to the stop clock, or does not allow the company to put up a wireless connection, what is the recourse [Mandl, realistically, you can get sued] so the cost would be for undergoing litigation, but not damages [it depends] FCC needs to be held accountable. If a carrier wants to come into an area, build a tower, there is nothing that the municipality can do, if we don't want it, what is the risk to the municipality, are there towns in litigation for doing this same thing [gave an example, a promise was made that there would be no tower farm, then the carrier went to a golf course, then they went to private property; finally it went to court, then the town was forced to allow the wireless carrier to go to the original site (ten years later), that is just one example] So our hands are tied. Our hands are tied from regulations, radio frequency admissions, unseen potential problem, we don't know what may happen with the level of emissions, where does it fall within the Federal regulations; [if the town comes up with a more stringent standards, the wireless carrier could then go to the FCC claiming the town violated federal law, take it to the legislature to update the standards] Are you aware of any class action suits that may be out there right now? [not that I am aware of] shot clock can that be extended by both parties [Yes] On page 5 and 6, have these examples been tested or can we use these to adopt our own zoning bylaws [pole heights, scenic roads are found in many municipal ordinances, if they want to attach to a current utility pole, that will be up to the utility] fee versus taxes, is \$270.00 the cap or can there be another revenue stream [you can charge personal property taxes] [\$270 per location, plus personal property taxes]

We have 119 active capital projects right now. We are confident in moving forward, we have taken into account the strategic plan, water supply, dredging, waste water, schools, airport, etc. There are some projects not in the CIP, as some are Community Preservation (CPC) funded we are waiting for the CPC funds to come forward first.
