

Town Council Meeting December 17, 2020



The December 17, 2020 meeting of the Barnstable Town Council was physically closed to the public to avoid group congregation.

A quorum being duly present, President Paul Hebert called the December 17, 2020 Town Council meeting to order at 7:02 PM from a remote location.

An announcement was made by President Hebert regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by Vice President Rapp Grassetti followed by a moment of silence.

#### **PUBLIC COMMENT:**

Stuart Hickman endorsed Matthew Levesque for Town Council President for 2021.

Tracy McEnroe called in to endorse Matthew Levesque for Town Council President, as he is committed and dedicated to the people of this town. She then read a letter from Steven Xiaharos.

Peter Scarafile called in to support Matthew Levesque, very active in supporting events, do anything that it takes to promote Barnstable and will do anything for the Vets.

#### **Councilor Response to Public Comment:**

(Levesque) thanked the constituents that spoke in favor of his bid for Town Council President. (Bogan) Had video problems this evening, spoke to the endorsements for Levesque.

### TOWN MANAGER COMMUNICATIONS:

Update December 4<sup>th</sup> through December 17th (Exhibit A)

Katie Service, Airport Manager provided a update on the Airport Re-branding using a PowerPoint presentation (Exhibit B)

• Bogan having issues with WIFI, and is off the zoom meeting.

(Atsalis) Have you identified why over 200,000 passengers have not used this airport (Servis) we have lost a lot of the rider ship when the fast ferries came into town. American Airlines does not have a large presence in Boston and are looking at other airports including ours. To entice airlines to come to Hyannis, we have to pitch to them, airlines often bypass municipal or regional airports. (Rapp Grassetti) Thank you Katie, took a moment to remember Commissioner Mary Smith for her dedication as she served on the Airport Commission. Limited size of the airlines that come in, does that have an impact? (Servis) Jet Blue has been a big boon to us; lots of folks don't like to fly in smaller aircraft. A thrifty-five passenger aircraft would provide more of an opportunity. (Cullum) Kudos on all your thoughts and actions and planning to bring about these changes (Servis) it has been a joint effort. (Shaughnessy) love what is happening bringing more businesses to the airport, this is the Town of Barnstable's airport, so not in favor of losing the name of Barnstable. Will the costs to fly come down, sometimes it is faster to take the bus? (Servis) Depends on the time of year, more people on the flight, the cost will go down, the cost to keep your car at a parking lot in Hyannis versus taking a flight out of Boston and parking there. (Dagwan) How soon will the name change and what would that look like? (Servis) New year, new name and then changing it in phases, the signage, logos on the vehicles and uniforms. (Levesque) Sad to see the Barnstable name going out, very excited about new possibilities, thank you for your hard work (Hebert) have you been able to attract the "Jet Set" (Servis) Good thought we have started small and we are starting to look at enticing our corporate clients (Steinhilber) Throw back merchandise opportunity (Rapp Grassetti) Are you keeping the HYA maybe you should change it to BAR (Clark) will your presentation be available on the website (Servis) Yes.

(Ells) We have been getting calls about WIFI issues, thanked Vice President Rapp Grassetti for her commitment and work as Vice President

Dan Santos, Director of Public Works, provided an update on the Comprehensive Wastewater Management Plan (CWMP) (Bogan back on at 8:04 PM)

(Schnepp) should we be at all concerned about the delays with Vineyard Wind (Santos) they apparently know what they are doing and it will not affect the schedule (Ells) spoke with Vineyard Wind today, because they have a new supplier it is a procedural withdrawal and submittal. They would have been required to do this, not a withdrawal of the project. (Atsalis) Mayo shared the same information with me. (Clark) please make the PowerPoint available to the public (Ells) we will have a link on the home page, to let our public find the information they may be looking for and readily available.

- Special Town Council meeting of December 10<sup>th</sup> for Fiscal Policy Review on the CWMP
- Proposed Process for Draft Sewer Assessment Ordinance:

(Starr) If this Is the draft sewer assessment ordinance I found this difficult to read, this is more like a legal document we could do better (Ells) Agree with you it is a draft ordinance, we are working on getting this document into laypersons terms, there will be several different documents to help us reach out to the public, members of the Youth Commission gave him the same feedback. (Schnepp) Are you at any point going to give us an idea of what this public process is going to look like? (Ells) virtual is definite, we have many active groups we will be speaking with, such as our civic groups, 11,800 properties are involved, we have to reach out to everybody, We will keep Councilors directly informed, my intent was to start with the Councilors, time is critical, bringing on additional consultants to assist us.(Steinhilber) misinformation is out there, there is a group currently saying this project is going to cost individuals 100,000 dollars each; we need to articulate the correct information and pull together to educate our public. (Rapp Grassetti) During this outreach the cost has to be well articulated these projects and how we are going to finance them, and the consequences of the different types of financing? We are going to need to see some comparison, how that is going to play out with our community, and how it will affect each of us. (Cullum) We have an opportunity with radio stations of exactly what the cost will be and we should use every outlet to get the word our there. This is a great tool to use. (Clark) As you get feedback, will you be rolling out variations of this presentation (Ells) Yes, we are listening (Clark) When you are rolling out an advanced version will you be letting us know and the public (Ells) Yes, this is just a piece of the information, we need to fund the gap, we have a few different scenarios, it will be a back and forth process. (Hebert) all up and down Cape Cod the towns have voted yes for wastewater projects, hopeful our town is going to carry this out in good measure.

Luc-Andre Sader from the Youth Commission, invited the Councilors and the public to be 7<sup>th</sup> Annual Substance Abuse Prevention Forum, on January 12, 2021 at 6 PM on zoom Lucas McCauley from the Youth Commission explained the links to the flyer will be on the town website as soon as possible

(Levesque) Attended the Substance Abuse Prevention Forum last year, a worthwhile very informative program on what is going on in our schools as far as drug use and the paraphernalia how kids bring it into school, trailer showing a teenagers bedroom; worth watching, applaud everyone in the Youth Commissions great work. (Atsalis) repeat the date again please (McCauley) January 12<sup>th</sup> at 6PM. (Cullum) Explain to the newer Councilors what you have done in the past (McCauley) 7<sup>th</sup> graders it was the Youth Summit program was different this one is for adults, the speakers are there to answer parents questions, hope parents register and ask the questions (Machado) we did a seventh grade youth summit two years ago we did it the night before and the next day with the 7<sup>th</sup> graders, this allowed the parents to see the paraphernalia the 7<sup>th</sup> graders will

be seeing, and to educate the parents as well. If your child loses their license and cannot drive again until they are 26 years old it is a huge impact on the family. New stuff changes all the time, you need to know what is out there. Climate change programs (McCauley) Town Manager Ells, asked us to review the strategic plan of the town and how can we be more in line, so we are working on wastewater and are going to bring it to the next youth commission meeting (Cullum) this is your Barnstable, you make a difference. (Dagwan) commended Councilor Cullum as she dug into this program many years ago, we have learned so much then and each year since, we had started at the high school level and needed to go to younger students. (Rapp Grassetti) Opiods were a topic of discussion for most of our meetings, this has cost many lives, how are you two dealing with the pandemic and remote learning, is it taking a toll? (Sader) on line learning started out a little rough, but now everything has smoothed out and we are adjusting, I have been lucky, but friends have had a tough time. (McCauley) More of an independent person, so on line is not a issue its balance not cutting yourself off completely, keeping in touch with friends, it is lonely. (Hebert) MMA in January, the meeting is going to be held virtually this year, on the 21<sup>st</sup> and the 22<sup>nd</sup> of January, if you cannot attend please call Cindy. Most of the Councilors have returned the Town Manager evaluations, the top score is a 5, Town Manager Ells evaluation is a 4.5 (Ells) Thank you for that supportive review, look forward to next years. Plan to continue to engage the youth. (Hebert) Thank you to the Police officers for helping get the people off the street with the help of the Duffy Health Center (Sonnabend) Thank you to all the people we work with, thank you for the recognition (Hebert) Thank you to Councilor Shaugnessy who heads up the Homeless Committee, and her concern to make sure we have a warm shelter (Levesque) Thank you to the Police Department for their efforts after a State Trooper who was wounded. Farmers to Family that has been on going, will be moving to the Barnstable Airport next week or the beginning of the new year, this is not a Veterans only program, anyone in need can come down and get a fresh box of food. (Schnepp) Last night the Zoning and Regulatory Advisory Committee met finished discussion for draft ordinance regarding accessory dwelling units, had some public comment and some good suggestions, committee decided to report it out to the full Council in January 2021 (Clark) will make sure the draft is on the town website under planning an development.

#### **Councilor questions and comments:**

(Bogan) with regard to the President of the Council, both candidates are excellent. With regard to inviting civic involvement, was disappointed with three previous meetings regarding auxiliary dwelling unit, appears the discussion had gone on for three months, however, notices were not published, no minutes posted on the website, or what was discussed. Due process is necessary to keep the public aware, people didn't know they were meeting, voted on items no minutes posted. (Neary) Will this item bring another person on staff, (Florence) the purpose of this is not to hire additional staff. (Rapp Grassetti) will you be giving us monthly reports, (Florence) we will be looking at enforcement issues, will be happy to provide information to the Council (Rapp Grassetti) Is the \$90 fee for long term rentals, is that the same case for short term rental (Florence) All rentals fall under fee schedule (Cullum) Is this going to be recurring expense for upgrades, will this be continuing (Florence) it is a yearly fee, we may not need all the items, the program pays for itself, it is an annual fee (Cullum) the menu items you are referring to is that on the agenda (Clyburn) potential contract with a potential vendor, we have to go through the procurement process, we cannot give that detail until it is done. (Schnepp) This would be for all rentals in Barnstable, are there different advertising platforms (Florence) Year round and long term rentals are advertising on those platforms (Schnepp) This would handle the correspondence to those entities that are renting that are not in compliance (Florence) Yes, we write the letter (Schnepp) Can we add a fine to those who were not registered? All the Agendas were posted under the Official Agendas, and all meetings were recorded and up on the website. We are and advisory to the Council, this is not a completed item. (Starr) Registering the rentals is an upfront cost to get everyone into the system, there is a 24/7 complaint hotine is that a person, (Florence) they have a person answering. (Starr) Monitoring rental activity and can figure out if occupancy limits have been exceeded (Florence) Don't know how but the answer is yes. (Neary) as a point of information AirBnb is now a publicly traded company

#### **SECTION 1**

By amending Article III, Section 16.1(F) by striking in the first sentence "25%" and replacing it with "18%" so it reads as follows:

F. Affordable Units. At least **18%** of the dwelling units shall be affordable units, subject to the following conditions:

#### **SECTION 2**

By amending Article III, Section 16.1(I) by striking in the definition of AFFORDABLE UNIT the phrase "as defined in §9.2 of the Code" and replacing it with the phrase "as defined herein" so it reads as follows:

AFFORDABLE UNIT

A dwelling unit reserved in perpetuity for rental or ownership by a qualified affordable housing unit tenant or purchaser as defined herein and priced to conform with the standards of the Massachusetts Department of Housing and Community Development (DHCD) Local Initiative Program Guidelines, in order that such affordable units shall be included in the DHCD Subsidized Housing Inventory.

#### **SECTION 3**

By amending Article III, Section 16.1(I) by adding a definition of "Qualified Affordable Housing Unit Purchaser or Tenant" as follows:

#### QUALIFIED AFFORDABLE HOUSING UNIT PURCHASER OR TENANT

A. An individual or household with total annual income that does not exceed the following percentages of the area median income for the Town of Barnstable, as determined annually by the United States Department of Housing and Urban Development:

(1) For the purchaser of a condominium unit: 50%.

(2) For the tenant in a rental unit: 50%.

#### **SECTION 4**

By amending Article XI Growth Management, Section 116 by adding the following:

(G) Development permitted under the Multifamily Affordable Housing Residential District.
