

Town Council Meeting November 21, 2024

A quorum being duly present, Vice-President Craig Tamash called the November 21, 2024, Town Council meeting to order at 6:00 PM.

An announcement was made by Councilor Starr regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 8 or Channel 1072.

PRESENT: Charles Bloom, Seth Burdick, Kristine Clark, John Crow, Matthew Levesque, Betty Ludtke, Paul Neary, Paula Schnepp, Craig Tamash, Kristin Terkelsen **ABSENT**: Jeffrey Mendes **ZOOM**: Felicia Penn and Gordon Starr (6:07 PM)

Councilor Clark invited veteran Sean O'Neil to the podium, to lead the Pledge of Allegiance, which was followed by a moment of silence. Vice-President Tamash urged residents to remember all who are near and dear to us.

Vice-President Tamash mentioned the second Town Council meeting on December 19th has been moved to December 12th. He noted there will be no third week meeting of the Town Councilors in December 2024.

PUBLIC COMMENT:

In-Person:

William H. Smith believes everyone has a voice in this community. He felt the 2023 zoning laws were a mistake. He stressed there were flaws in it but felt there was time still to make changes before finalizing it. He said confidence was lost, and everyone can make mistakes, but it would be a crime to let it continue.

Rick Brigham felt the turbines were taller than some of the buildings in Boston Massachusetts. He noted the turbines contributed to the damage of the ecosystem and the fisheries would suffer as well. He added there were 410 whale death since 2016 which coincides with the turbine companies working in the same area.

Susan McLean felt the artist community, which was a part of the tourist industry, would be affected by Avangrid threatening our beaches. Please rescind the June 13th vote.

Maryanne Noddin felt the closed meetings appeared suspicious. If the big wind is so good, why hide the meetings. She said the big wind companies would be protected by their Limited Liability Company if anything went wrong. The Town would not be protected and is open to all liability.

Catherine Bean urged the Council to rescind the June 13th vote. She hoped there would not be any more wind projects. She noted Councilors Jeffrey Mendes and Matthew Levesque did not use their town email address.

Kathleen Vail was very upset with the vote taken at the June 13th meeting which was not taken in public. The secret vote is wrong and against the Open Meeting Law. She urged the Council to rescind the vote and adhere to the Open Meeting Act.

Liam Moynahan urged the Council to rescind the vote and repel the act. He voiced his concerns about turbines off Nauset. He noted we have the opportunity to revisit this vote.

Shelley Sterling hoped the Council would take the opportunity to rescind the vote from the June 13th meeting. Avangrid never answered any questions and is owned by an Iranian company.

Elaine Brigham felt the wind turbines would not generate as much electricity as it took to construct them.

Roberta Mauch spoke about the expensive energy, its unreliability and going forward our electrical bills will be double. Please rescind this vote.

COUNCIL RESPONSE TO PUBLIC COMMENT: (Levesque) spoke about the extensive outreach, public hearings, robust discussions, the 10 Councilors voted for it and an amendment regarding the form-based code. We were trying to redevelop blighted property that was the reason for passing the form-based code. (Neary) These decisions happen overtime, and we try to balance all information. We make decisions for the Town with the information we had at the time. If we rescind the vote the agreement is still enforceable. We voted on the agreement to protect the Town. (Ludtke) said she voted for form-based zoning and regretted it. Looking forward to changes and the role of the residents. The June 13th meeting left out the citizens. (Schnepp)felt the legal concerns outweighed any open meeting concerns. (Bloom) felt the Citizens' petition has merit. He voted for the agreement, his responsibility but it needs to be out in the open. (Crow) Felt the vote was rushed. He said he made a mistake. We need to read the information carefully and come back to another meeting for the vote. (Terkelsen) We need to ask better questions and slow down the process. Then come back into public and take the vote.

Discussion: (Ludtke) The opioid settlement great settlements and grants please keep this item front and center. Is it going to be here (Ells) Spoke with Leadership and it will be brought forward and presented and will come back with an answer. (Poyant) reporting as task force another round on December 31st. (Schnepp) getting grants with matching funds – great job! How about an update on sewer connections since May. (Ells) asked Dan Santos, Public Works Director, to report on this item. (Santos) Said 45 people had connections with 25 active permits and we were actively working on waivers.

(Kirk) spoke about the Citizen's Petition. He was concerned about the process and felt the Citizen's petition was ignored. He noted the last three (3) years of the Council have deprived the citizens of their rights. This petition gives you that opportunity to be open. Please deliver public access, vote should have been done in public, some councilors did not even know what they were voting on, we were deprived of our referendum rights as well. We are not asking for merit, just asking to rescind the vote taken at the June 13th meeting. (Nober) Language of the petition is verbatim. The Council needs to vote on whether the petition has merit. This petition has no merit. If Council voted yes, then what steps are to be taken. The vote taken on June 13th in the Executive Session was a valid vote. Town entered into an agreement due to this vote. The signed agreement cannot be cancelled. Even if you change the vote the agreements still stand. The easements per the agreement were released earlier this week. You should vote no the petition does not have merit. (Carroll) The agreements should not have been signed and the easements should not have been released. Our rights have been violated; the citizens of Barnstable have been robbed. Look at Centerville-Osterville-Marstons Mills Fire District, all their meetings with Avangrid have been held in public. (Brigham) The contract with Avangrid was signed under false pretenses. Town Council did not have the information. Do the right thing. (Bean) suggested the Town should say no to Avangrid, let them sue us as contracts are made to be broken. There is nothing to win and everything to lose let Avangrid go somewhere else. (Vail) The private vote taken in the Executive Session was not valid according to our Open Meeting Law, thus the contract should not be valid. (OConnor) Felt Article 97 was given away by the Council, we are asking to redress this decision. This is an Open Meeting law violation. (McLean) Where are the Article 97 protections renegotiate the offshore wind turbines. (Conley) The June 13th Executive Session had discrepancies in the documentation and the language. Please talk with each other. The release of those easements is disputable. (Morin) felt the Town's use of Executive Session was abused and it needs to stop. The reason for the Executive Session was a litigation strategy which is invalid from the outset as it was not stated correctly.

(Moynahan) How did we get to this point so fast – thanked all who are advocating for the citizens. Please protect our sole source water, please listen to all the people tonight and make a good decision on behalf of your constituents. (Sterling) There are health problems with the wind turbines. This needs to be fixed.

Mark Milne, Director of Finance, gave the rationale. He mentioned David Anthony, Director of Asset Management, was available for questions.

Discussion: (Schnepp) Please elaborate on the expenses already spent. (Anthony) the \$400,000 has funded the property manager position to help with the backlog of our town owned properties. As well as title certificates, appraisals, wetland delineation and the board walk. (Schnepp) Not comfortable with an open-ended fund. Will offer an amendment restrict to \$50, 000. (Anthony) This restriction will limit the ability to do the work. If it is amended, can we come back to Council for more money

Upon a motion, it was duly made and seconded it was to amend the spending limitation for Fiscal Year 2025 to \$50,000 for the Asset Management Revolving Fund.

Discussion: (Crow) Can you explain (Schnepp) Once this fund is spent there is no more money. We owe public scrutiny of how this money is spent. (Ells) concurs with transparency, concern with unknown amount of evaluation of site, etc. We could keep the \$500,000 cap transfer \$265,000 but vote for spending and it would be open to the public to understand. (Milne) Yes, we can treat it as a appropriations with a first and second reading (Ells) How about first reading then come back to vote; one vote not two votes. (Milne) We can do this like revolving funds then come back with one vote. (Schnepp) Property Assessment Management – broad territory (Ells) If we keep \$50,000 the \$210,000 goes back to the General Fund and it can be spent elsewhere (Ells) We can bring it back for two reads (Nober) We can postpone it (Schnepp) withdrew the amendment. The first section is described in a Barnstable County Commissioners' layout and order of taking dated September 5, 1931, and recorded in the Barnstable County Registry of Deeds in **Book 483, Page 449**, and shown on a set of plans of land recorded in said Registry in Plan Book 44, Pages 111 (sheets F-1 and F-2), 113 (sheets F-1 and F-2) and 115 (sheets F-1 and F-2).

The second section is described in a Barnstable County Commissioners' layout and order of taking dated April 18, 1969, and recorded in the Barnstable County Registry District of the Land Court as **Document No. 129,144**, and shown on a plan of land dated August 21, 1967, referenced in this document and filed therewith.

It is the intent thereby to render said sections of the County highway a Town way by operation of M.G.L. c. 82, § 5; and further, that said petition request that the discontinued sections of said County highway remain a public way. The Town Manager is authorized, on behalf of the Town, to file the petition with the County Commissioners and to execute and deliver any documents necessary to effectuate this resolve.

Upon a motion duly made and seconded it was

RESOLVED: That the Town Council hereby approves of filing a petition pursuant to M.G.L. c. 82, § 5, with the County Commissioners of Barnstable County to formally discontinue two sections of County highway that together comprise the entire length of Bumps River Road and a portion of Park Avenue in the villages of Marstons Mills, Osterville and Centerville, as follows:

Both sections constitute the entire area described in a Barnstable County Commissioners' layout and order of taking dated February 2, 1928, and recorded in the Barnstable County Registry of Deeds in **Book 450**, **Page 364**, and shown on a set of plans of land recorded in said Registry in Plan Book 22, Pages 85 (sheets F-1 and F-2), 87 (sheets F-1 and F-2), 89, (sheets F-1 and F-2), 91 (sheets F-1 and F-2) and 93 (sheets F-1 and F-2). The involved portion of Park Street, including at its intersection with Old Stage Road and Main Street, was the subject of a prior discontinuance made by the County Commissioners as recorded in **Book 36144**, **Page 247**, which petition was made by the Town pursuant to Item 2024-051, approved on October 19, 2023. However, that resolve contained an incorrect deed reference and an unclear description by referring to an unrecorded plan.

The intent of this resolve is to achieve the discontinuance of Bumps River Road, confirm the prior discontinuance of the portion of Park Avenue, and render said sections of the County highway a Town way by operation of M.G.L. c. 82, § 5; and further, that said petition request that the discontinued sections of said County highway remain a public way. The Town Manager is authorized, on behalf of the Town, to file the petition with the County Commissioners and to execute and deliver any documents necessary to effectuate this resolve.
