

# Town Council Meeting April 17, 2025

A quorum being duly present, President Craig Tamash called the April 17, 2025, Town Council meeting to order at 6:01PM.

Councilor Ludtke introduced and welcomed veteran Lester August to lead the pledge of allegiance followed by President Tamash with a moment of silence for the memory of the two servicemen that passed away at the border.

President Tamash announced emails were received and shared with the Councilors.

John C Vieira II came to discuss the Barnstable Transfer Station taking advantage of the citizens of Barnstable, with the current price of \$335 dollars a year for trash disposal. He described his experience while trying to dispose of fencing. (**Exhibit A**)
