

## Town Council Meeting October 23, 2025

A quorum being duly present, President Craig Tamash called the October 23, 2025, Town Council meeting to order at 6:02 P.M.

An announcement was made by President Tamash regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 8 or Channel 1072.

Councilor Ludtke introduced and welcomed, veteran Ed Lambert to lead the pledge of allegiance followed by President Tamash who asked all to remain standing for a Moment of Silence. He asked that we keep Councilor Levesque and his family whose father passed away in our thoughts and prayers and for all the service men who have given their lives for our country.

### **PUBLIC COMMENT:**

President Tamash asked all who would like to comment, to sign in, wait to be recognized by the presiding officer, and direct your comments to the Town Council.

David Abelman spoke about a discussion with Ells and Unrue regarding the pollution of Long Pond. He felt there was no time to waste and there was a need to commit to action. He discussed a possible pilot project for Long Pond. He hoped if this was not this solution then another company may have one.

Rebecca Edson Medeiros spoke about the pollution in Long Pond. Talked about not being able swim in the pond and having to make sure the dogs stayed away from the pond. Urged Council to find an immediate solution for this problem.

Larry Morin spoke about agenda item 2026-039 He felt it was time for the public to have the same public comment and free speech in the Town's Boards and Committee meetings. He urged Council to let the public participate on certain Ad Hoc committees.

Amanda Jacob from Hopeful Outreach of Cape Cod spoke about helping 463 individuals and offering sober living scholarships. Her organization offered access to recovery programs and housing resources.

Vicki Marchant who is an abutter to the Hyannis Honda property, had concerns with the parking lot. She felt the parking lot as it was a very busy area. She hoped the lot would fit into the aesthetics of the residential area.

Tim O'Neill felt it was most important to conduct a fair legal hearing process. He felt the town was struggling on multiple fronts and hoped Council could focus on issues that matter most to the residents

Barry Sheingold felt there needed to be quick action on the sewer and cyanobacteria issues in the town. He was glad the Town Council and staff will be addressing these issues. He supported the changes in the Stretch Code – moving the date.

Peter Hanson was very thankful for the additional funding to complete the Osterville playground. He Page 1 of 11

hoped all Councilors would vote to approve this item. The playground park will be named after former Councilor Jim Crocker who wanted the park.

Cliff Carroll thanked Ed Lambert for his service to the county and his radio show. He also thanked the 4 outgoing Councilors for their time and effort during their terms of office. He spoke about the proposed deadline for extension to the Stretch Code. He wished this was discussed earlier at the subcommittee level prior to the approval vote. He urged Town Council to accept the new implementation date. He noted there were millions of dollars in the engineering phase and if the Stretch Code goes in to affect and they cannot pull their permit before the January date they will have to go back and re-engineer their projects. We need to keep drinking water as a priority with all projects

John Richmond spoke about summarizing the email content sent from the public to the town councilors, move the controversial items earlier in the meetings, and hold the Executive Sessions after all the agenda items. He felt no chairperson should not have the power to approve a project on their own and every item should have a public hearing.

### ZOOM

Tim Kirk felt pesticides and herbicides usage should be eliminated from Barnstable and leaf blowers as well due to the noise pollution. He asked for a new update on the watershed permit – what is going on down in Washington D.C. and with the Environmental Protection Agency (EPA). He added the mechanism is being wiped out in favor of fossil fuels and how will this affect the timing or phasing of the sewer project.

Paul Phalan opposed agenda item 2026-001. He felt with the airport's 15-million-dollar reserve should not be given as carte blanche in regards to spending the funding. He said there were no agreements with any of the airlines to come back to Barnstable.

Christopher Kuhn sent emails to Council, Legal, Planning and Building directors regarding the conflict of what is proposed and to be built at 201 Main Street and 307 main Street. He spoke about the missing landscape buffer for the project. He questioned how the projects could be approved without the required buffer.

## **COUNCIL RESPONSE TO PUBLIC COMMENT:**

(Ludtke) thanked Tom O'Neil for his thoughts on Long Pond and felt we should focus our energy on the water pollution issue. She agreed with taking Executive Sessions at the end of the Town Council meetings. (Mendes) said if he was in attendance during the stretch code agenda item he would have voted no in theory but not in implementation. He said he has not heard anything positive about the stretch code. He said the infrastructure and buildings need funding for repairs. He felt the stretch code will cost us money. Get ready taxes will be raised. (Schnepp) supported cleaning up Long Pond and she was happy to hear about the successful meeting with Mark Ells and staff. She gave a shout out to Amanda Jacobs and her group for receiving opioid recovery funds. (Crow) agreed with the controversial items should be brought up at the beginning or earliest part of the Council meeting. (Tamash) clarified that public comment during the Town Council was included in the meeting minutes.

(Schnepp) Commended Director Kupfer and staff for the presentation regarding listing of all projects for the last eight years. She was glad for approval of funding for inclusionary zoning to help create more affordable housing. (Ludtke) asked about the Quality-of-Life group and how public comments at meetings should be made. She thanked Stephen Robichaud, Chair of the Planning Board, for all his hard work and felt he was the heart of Barnstable. (Bloom) Said Steve Robichaud should give classes on how to run a meeting. (Schnepp) questioned a sign at the Barnstable Public High School regarding Jesus.

### **MINUTES:**

### **Councilor Discussion:**

(Terkelsen) felt there was not enough data and letters should have more information. (Ludtke) asked if there was state training for the Planning Board (Robichaud) there is town and state training. (Schnepp) lots of work thank you. Review recommending zoning ordinance possible review committee. (Robichaud) more collaboration between Planning Board and other boards.

 Presentation on the Allocation of the Fiscal Year 2026 Tax Levy – Adoption of a Residential Exemption and Residential Factor, Mark Milne, Director of Finance, and John Curran, Director of Assessing

(Milne) have an overview of the allocation of fiscal year 2026 Tax Levy adoption and residential exemption. (Curran) discussed the PowerPoint presentation.

### **Councilor Discussion:**

(Schnepp) asked about the Home Rule petition for year-round rentals. (Curran) explained the local option needs to be voted on. (Ludtke) asked about the five-day public disclosure. (Curran) noted the website had posted values on second home owners. (Ludtke) felt there was no trust in compliance everything should be on website so trust can be done for people. (Curran) yes, we will look at it on the web it will be more robust. (Ludtke) what about the exemption for those that are renting (Curran) Not sure how to get it approved (Milne) Local option available – affordable housing - Council must set the amount those decisions are decided with Town Council. Bring forward local exemption option. (Tamash) Will it be different for renting. (Milne) Yes it works differently, Town Council must decide.

Jim Kupfer, Director of Planning and Development, gave the rationale.

Open Public Hearing

Bob Schulte explained the redline amendments. He spoke about eligibility and not excluding residents in these Council exclusive groups. He noted some citizens would be helpful in the Appointments Committee. He felt this item needs to amended. Please do not make these two committees Council only members.

Larry Morin agreed with Bob Schulte. He would like to see some of the public people as part of the Appointments Committee. He felt there should be more members. The public member should not be necessarily barred from being the chair of the Appointments Committee. Morin has attended the last two years of their meetings and disagrees with some of Kupfer's language in this ordinance.

John Richmond agreed with Bob Schulte and added both committees are completely unnecessary.

### **Councilor Discussion:**

(Neary) said he is not sure where he stands on this issue. He noted a small fraction of people are paying attention and they are being heard. (Tamash) Is there the provision for public comment in every meeting (Kupfer) Yes and subcommittee would have public comment. (Mendes) Struggled with this item. Committees not equitable in every village. We need to bring younger people into these committees because the decisions that are made will affect them. I would love for the public to be a part of it, but I need it to be equitable. (Schnepp) Challenge with including citizens – Appointment Committee works well with five Councilors. The Zoning Regulatory Committee involves lots of public interaction. (Crow) impetus to change but does not remember citizens being on the committee. Zoning Regulatory Committee has five councilors seven would be a better number. (Terkelsen) felt councilors should serve for the length of their term and residents could make a three years term. Keep it streamlined. (Ludtke) Add a human resources person to the Appointments Committee. (Bloom) Leave the Appointments committee as it is. (Nober) the amendment adds two more members to the Zoning Regulatory Committee. (Schnepp) then the Appointments Committee stays as is (Nober) language clarification – left alone the advertising language and the interview candidates for reappointment. These are different than the Ad Hoc Committees. Appointments are made by the President but approved by the entire council. (Mendes) What can be done (Nober) Council can out vote the President you are the elected officials. Never seen a member of the public on the Appointments Committee. (Burdick) What is the language of the proposed amendment. He feels it strikes a balance between the Town Council and people who are in the know, who have the expertise.

Councilor Ludtke read aloud the proposed amend for item 2026-039. To amend section 1 of item number 2026-039 by inserting in article 1, section 37 -2 membership following language after the words, Town Councilors, provide that the membership of the Zoning and Regulatory Committee of the Council shall include the chair of the Zoning Board of Appeals, or his or her designee and the Chair of the Planning Board or his or her designee, for a total of seven members. So as amended, section 37-2 would read as follows: Each Standing Committee of the Town Council shall consist of five Town Councilors provided that the membership of the Zoning and Regulatory Committee of the Council shall include the chair of Zoning Board of Appeals or his or her designee, and the chair of the Planning Board or his io her designee, for a total of seven members.

President Tamash asked Councilor Ludtke to re-read the motion. This is the proposed amendment to item 2026-039. This is the motion to amend section 1 of item 2026-039 by inserting in article 1, section 37-2 membership the following language after the words, town councilors provided that the membership of the Zoning and Regulatory Committee of the Council shall include the chair of the Zoning Board of Appeals or his or her designee, and the chair of the Planning Board or his or her designee, for a total of seven members.

Upon a motion duly made and seconded it was to amend Section 37-2 would read as follows each Standing Committee of the Town Council shall consist of five town councilors, provided that the members of the Zoning and Regulatory Committee of the Council shall include the chair of the Zoning Board of Appeals or his or her designee and the chair of the Planning Board or his or her designee, for a total of seven members.

(Crow) added we are trying to have a wide range of councilors on this position, and we can maybe modify that to say that those two seats from the Zoning Board and the Planning Board can be permanent advisors or some other aspect and have seven members.

Upon a motion duly made and seconded it was to amend the amendment to have seven councilors, not a nine-member committee with two permanent advisors one from Zoning Board of Appeals and one

from the Planning Board (No second – no vote)

Upon a motion duly made and seconded it was the amendment read by Councilor Ludtke VOTE: PASSES 9 YES I NO (CROW) 1 ABSTAIN (BLOOM)

(Nober) mentioned if there was concern about a committee being stacked this is an advisory committee. They will not get the final say on anything. They will be doing the work to bring something before council and the full council is the check on that possible stacked committee.

(Starr) what about reappointed members (Nober) no existing standing committee or Zoning Regulatory Committee should be for more than one year. It was suggested that the Planning Committee should be for a longer period due to the issues. (Terkelsen) two years is not enough time to serve. It should be for the duration of your term. (Tamash) Everyone will not have four-year term. Should we eliminate all reference to the Appointments Committee or leave it as is. (Nober) Advertisement and inviting the public these paragraphs have been added. Current Appointments Committee there are five members with three out of the five should be councilors. (Tamash) would it make sense to remove within section 1 reference to Appointments Committee and write amendment tonight. (Nober) Continue to next meeting and redraft it. (Ludtke) add a sentence to the amendment in section 37-2 that the Appointments Committee could include up to two (Nober) Provided further that the membership of the Appointments Committee may include up to two members of the public. The section 37-2 membership to include after the language that was just voted on provided further that the Appointments Committee of the Town Council may include up to two members of the public for a potential total of seven members.

**SECTION 1.** By repealing Article I, Appointments Committee, in its entirety and inserting the following new Article I, Standing Committees of the Council, in its place:

"Article I. Standing Committees of the Town Council

§ 37-1 Standing Committees of the Town Council.

The following committees shall be Standing Committees of the Town Council:

- A. An Appointments Committee of the Town Council
- B. A Zoning and Regulatory Committee of the Town Council.

§ 37-2 Membership.

Each Standing Committee of the Town Council shall consist of five town councilors, provided that the members of the Zoning and Regulatory Committee of the Council shall include the chair of the Zoning

Board of Appeals or his or her designee and the chair of the Planning Board or his or her designee, for a total of seven members. Membership of Appointments Committee of the Council may include up to two members of the public for a total of up to seven members.

§ 37-3 Term of office.

The members of the Appointments Committee of the Town Council shall serve for one year commencing after the annual reorganization of the Town Council. The members of the Zoning and Regulatory Committee of the Town Council shall serve for two years commencing after the reorganization of the Town Council following a regular Town election.

§ 37-4 Appointment of members.

The Councilors serving on Standing Committees of the Town Council shall be appointed by the President of the Council from a list of names of those Councilors who have indicated that they wish to serve on such committees. The total Council will be apprised of the names of those Councilors who are willing to serve. The full Council will have the final vote on all appointments to the Standing Committees of the Council.

### § 37-5 Appointments Committee.

- A. Purpose. In accordance with Council rules, the Appointments Committee recommends to the Town Council a slate of persons to be reappointed or appointed to volunteer boards.
- B. The Appointments Committee will advertise on the Town website and on digital and social channels as needed throughout the year, inviting Town residents to submit letters of interest to the Town Council Administrator indicating the areas in which they would like to serve and requesting letters of interest for openings on specific multi-member boards, committees and commissions.
- C. Resumes will be gathered along with letters of interest from each candidate, and interviews will be conducted with new candidates as well as with candidates for reappointment whenever there are other applicants for the position for which a candidate is seeking reappointment. At the discretion of the Committee, interviews may be conducted with candidates for reappointment when they are the only applicants for the position for which they are seeking reappointment.

## § 37-6 Zoning and Regulatory Committee.

- A. Purpose. The Zoning and Regulatory Committee will review and make recommendations to the Council regarding proposed zoning amendments and other proposed regulatory ordinances and amendments submitted to the committee by the Town Manager or by one or more Councilors. The Zoning and Regulatory Committee, on its own initiative, may submit to the Council proposed zoning amendments and other proposed regulatory amendments and ordinances.
- B. All meetings of the Zoning and Regulatory Committee shall include a period for public comment."

**ORDERED:** That, pursuant to the provisions of the Community Preservation Act, G. L. c. 44B, the amount of Three Hundred Seven Thousand and Five Hundred Dollars (\$307,500) be appropriated first from the amount set-aside for Open Space and Recreation within the Community Preservation Fund and secondly from the Community Preservation Undesignated Fund for the purpose of the Town, acting by and through its Town Manager, acquiring a perpetual Conservation Restriction (CR) from Barnstable Land Trust, Inc. on a 25.74± acre retired cranberry bog located at 301 Parker Road, West Barnstable, shown as Assessors Map 176, Parcel 019, for open space, conservation and passive recreation purposes pursuant to G.L. c. 184, sections 31-32. The Town Council authorizes the Town Manager to negotiate the terms of the CR subject to minor changes to be made by the Secretary of Energy and Environmental Affairs. It is further ordered that the Town Manager is authorized to expend the amount appropriated on behalf of the Town for the acquisition of the CR, subject to oversight by the Community Preservation Committee, and to negotiate, accept, approve, execute, receive, deliver and record any written instruments to effectuate this Order and complete this transaction.
