<u>Council Liaison:</u> Frederick Chirigotis	II. MINUTES: Motion was made and approved to accept the minutes of November 24, 2009.

	 V. OLD BUSINES: Barnstable Bulkhead. Eric Shufelt reported to the committee regarding the Barnstable Harbor bulkhead repair that the State has offered the Town of Barnstable \$3.75m. Last year the Town had allocated \$725k toward the project. The Marina Enterprise Program will contribute \$525k in the form of a 15 year bond. The DPW has an estimated construction period of 270 days. The start date is unknown at this time. We have advertised with the Central Register which will appear in a week. The bid process will continue shortly after that. Marina operations at Barnstable Harbor for 2010 are unknown at this time. No impact to the other marinas is foreseen at this time. He will update the Committee at the monthly meetings.

	VIII. HARBORMASTER REPORT:

Joe Gibbs reported to the committee that the Town Manager is favorable to the change recommendations to the mooring and marina fees. Waitlist renewals will be going out shortly. The mooring renewal fee will now be \$10 per entry. There are currently 1417 people on the mooring waitlists. They are due in the office by March 15th. Mooring renewals will be mailed out the beginning of February due in the office by March 31st. Our boats are out of the water for the season as well as most of our buoys.

Eric Shufelt reported to the committee that marina waitlist renewals will be going out January 1st due back in the office by March 15th. He will be sending out the slip deposit notices to all marina slip holders except for Barnstable Harbor. Those will be held until more is known. The slip deposit is \$200 and is due by the end of January. Slip contracts will be sent out the beginning of April.
