VIII. HARBORMASTER REPORT:

Mooring and Marina updates

There will be a lottery for the displaced slip holders from Barnstable Harbor on May 4, 2010 at 10am at Town Hall. There are 3 vacant slips at Barnstable Harbor, 4 at Bismore, 2 at Gateway and 7 small slips at The Marina at Prince Cove. They will be given the option to go into one of those marinas for this year and pay that marina rate. Staff will be starting

May 1st in Hyannis, seasonal staff will start May 8th at The Marina at Prince Cove and Barnstable Harbor. Transient slips are available at Bismore, Gateway and The Marina at Prince Cove. They are currently working on updating signage for Barnstable Harbor marina for the season, the traffic flow and parking at the green

space which will only be for the slip holders and the charter customers – no trailers will be allowed there during construction. Transient dockage is \$1.50/ft for commercial fishing boats and \$2.75/ft for recreational. There are no reservations and they are allowed to stay up to 3 weeks.

This year 134 people have not renewed their mooring permits of which 20 have notified the office that they are not renewing and various servicers have removed an additional 10 tackles, there are 50 renewals from open areas. For those wishing to renew have until May 14th with an additional \$25 late fee. Notices have been sent out to all those who didn't renew to remove their mooring tackle. A letter will be sent out to those from the waitlists where there is space for moorings. They will have 2 weeks to notify the office that they are interested. If they do want a mooring they will have 2 additional weeks to get their paperwork in order. The buoys are being put in, the 2 patrol boats are on location at Barnstable Harbor and Hyannis.
