V. OLD BUSINES:

Workshop recap from October 9th:

Mooring Special Use Permit/Fees/Regulation changes and impact/Transient and rental moorings/Moving Mooring and Waitlist deadlines up/Open Waitlists/Online Waitlists.

Fee hearing will be held the first week of December. Recommendations must be submitted by November 8th. Proposing a fee increase which will help with service enhancements, additional staffing, wait list mailings, etc. The Mooring program is self sufficient and also helps support the Harbormaster operations. Proposed increases: Individual mooring fee from \$70 to \$100, Commercial rental secondary moorings from \$150 to \$175, New mooring waitlist applicant \$20 initial fee then \$10/yr to renew, Mooring transfer fee \$25.

VIII. HARBORMASTER REPORT:

Mooring, Marina and Harbormaster updates

Dinghy removal regulation has been expanded to include Hyannisport – Fortes Beach, East Bay Landing, Cotuit Oyster Co. at the end of Little River Road, Popponesset Bay - Santuit Road in addition to Ropes Beach. All dinghies must be removed from these areas by November 15th. The results of the waitlist lottery – the addition of just under 200 entries total - will be available by the end of the week. Moorings will be offered in some areas this fall and in the spring.

IX. PUBLIC COMMENT:

Ken Kevorkian commented on the reconfiguration at Dockside and Lewis Bay boat ramp area, urging them to look into what is necessary to prove the extension in the reconfiguration zone. Because it is so tight there, he thinks it should be limited to where it is right now. Regarding the increase of mooring fees – he would like to see it justified.
