Background

Gateway Marina is located at 135 South Street. Features in the area include a parking lot, a board walk, oyster project (tank), four (4) bulkhead ladders leading to the water to transfer goods into the boats along the board walk and two (2) docks. The boat slips can be used only by slip holders which can be bought from the town.

The vehicular entry point to the parking lot is from South Street. The parking lot has 23 spaces with no accessible parking space. The parking is only for slip holders and requires a permit to park at the lot. Additional pedestrian access points to the board walk are from Bismore Park, Spanky's restaurant, Aselton Park and Pleasant Park.

Key Accessibility Issues

Exterior Accessible Routes

Accessibility issues at walkway includes changes in level, lack of firm, stable and slip resistant surface, surface openings more than permitted, and lack of an accessible route to docks and display.

Parking

Accessibility issues include identification signs installed lower than the minimum allowed, lack of a van accessible parking space with an ISA sign having "Van Accessible" and lack of prominent stripping designating parking spaces.

Gangways

Accessibility issues at gangways include lack of an accessible route to the ramp, lack of edge protection at ramp, lack at least a 60" wide clear space at the boat slip and lacks edge protection at boat slips.

Order of Magnitude Cost Estimates

- Provide a firm, stable and slip resistant path between Aselton Park and Spanky's restaurant: \$8,000
- Provide a van accessible space with sign: \$1,850

Total: \$14,788

*Note: Because of the excessive and difficult accessibility issues cost to provide an accessible route at the start of the gangways, to widen the existing gangways, and to address other issues with the gangways are not included.

Best Practice & Inclusive Design

Best practice and inclusive design recommendations include elements that are not required in the standards but may create enhanced experiences for all users.

Recommend restriping parking spaces.

• Recommend providing a 36"min. x 48"min. clear floor space adjacent to the bench located near the parking lot.

 Recommend lowering bottom of exhibit frame located near Spanky's restaurant to be between 24"-26".
