Background

Aselton Park is located at the corner of South Street and Ocean Street, north of Bismore Park. The park does not have a designated parking lot. It is used by families for picnics, but also by the Town for local events such as festivals, markets, pet drives, and yoga classes. The park consists primarily of a large lawn lined with paths and benches, and a stage at the southeast edge of the park.

The main access point to the park is on a large brick area at the corner of South Street and Ocean Street. There are two (2) sets of stairs leading into the lawn. Two (2) pathways lead downhill along the sides of the lawn. One path leads south along Ocean Street, and leads into the walkway along the Marina. There are two (2) benches located along the south side. The other path leads east along South Street into the parking lot next to the Cape Cod Maritime Museum. There are four (4) benches located along the north east side.

The stage is located on the southeast side of the park. Alongside the stage are two small buildings on the west side. IHCD team has been informed that the buildings are only for employees.

Key Accessibility Issues

Exterior Accessible Routes

Accessibility issues with exterior accessible routes include walkways with running and cross slopes that are greater than allowed, excessive changes in level, and surfaces that are not maintained in operable working condition. In addition, vertical clearance of 80" minimum is not provided at the west route due to the presence of a sign. Additional issues include lack of an accessible route to the stage and to an area with accessible seating in front of the stage.

Additional Accessibility Issues

- Benches are not connected on an accessible route.
- Transition at curb ramps is not flush and cross slope is greater than the maximum allowed.
