OCEAN STREET PARKING PERMIT PROCEDURE

PURPOSE:

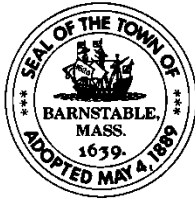
To provide parking options to residents and local businesses requiring spaces in addition to what is required for said business at Ocean Street Lot while also balancing visitor parking needs.

PROCEDURE:

The Town of Barnstable Parking Program has adopted the following procedure regarding issuance of parking permits for the Ocean Street Lot:

1. Ocean Street Parking Permits are valid only for the Ocean Street Parking lot.
2. Town of Barnstable employees, businesses on Ocean Street, businesses located in the former Town Hall, residents abutting the lot, or educational institutions on Main Street are eligible for a parking permit.
3. Permits will be issued **only** at 200 Main Street, Hyannis through Parking Management.
4. Only ten (10) permits may be issued per allowed business.
5. Fees associated with Ocean Street Parking Permits are approved by the Town Manager through a public hearing and are subject to change.
6. All Resident and Business Ocean Street parking permits expire on December 31st of each year.
7. Private parking lot businesses may only use Ocean Street Parking Permits for employee use.
8. Businesses requesting a “floating” permit (assigned to a business rather than a specific vehicle) must submit a written request to be approved by the Parking Management.
9. Permits issued to an individual or specific vehicle associated with an eligible business must provide a copy of valid vehicle registration.
10. The Ocean Street Parking Lot is open to the public with timed metered parking. Parking is on a first come first serve basis. An Ocean Street Parking permit does not guarantee a parking space at the Ocean Street Parking Lot.
11. Parking permits are issued at the discretion of Parking Management per approval of the Town Manager and may be cancelled or revoked for failure to comply with these rules, regulations, municipal, state, or federal laws.
