TOWN OF BARNSTABLE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG) NOTICE OF DOCUMENT AVAILABILITY, PUBLIC MEETING AND COMMENT PERIOD

The Town has completed the 2025 program year for the Community Development Block Grant (CDBG) program and is preparing the Consolidated Annual Performance Evaluation Report (CAPER) for the period of July 1, 2025 through June 30, 2026. The Town was not awarded any new federal funds from the U.S. Department of Housing and Urban Development (HUD) during this time period, but utilized past resources to address the goals and objectives of the Town of Barnstable's 2025-2030 Consolidated Plan. The CAPER is a year-end report that outlines the accomplishments of the Town's CDBG program and is available for review and comment before the Town submits to HUD for formal approval.
