2024 SMALL BUSINESS HAZARDOUS WASTE COLLECTION FORM

There are an estimated 4,300 small businesses on Cape Cod that use chemicals for processes. Once these wastes are no longer needed, they must be disposed of properly.

These are examples of small businesses that are [Very Small Quantity Generators \(VSQGs\)](#) Painters, Landscapers, Jewelers, Artists, Non-profits, Motels/Hotels, Inns/B & Bs, Woodworking, Farmers, Fishermen, Charter Boats, Private Schools, Boatyards, Contractors, Paint Supply, Storage, Junk Cleanouts

Cape Cod towns invite you to participate in this year's hazardous waste collections if you need to dispose of hazardous products from your small business (<220 lbs. or 27 gallons per month and NO acutely hazardous waste). The schedule on this form list 2024 collection dates, times, locations, and contact numbers.

You may participate in collections in your town, or in other town's collection for the disposal costs. **IMPORTANT: You are required to register by calling or emailing at least two weeks in advance of the collection date to discuss the type and quantity of materials you plan to bring. The hazardous waste contractor cannot accept that is not pre-authorized so it is important that you register and receive appointment and pay before attending!**

Steps for participation

- 1.) Call for authorization and quote: 774-487-8802. Authorization may take up to 2 weeks. Plan accordingly.
- 2.) Receive appointment date and time from Barnstable County.
- 3.) Pay Barnstable County for waste by check or credit card (fees apply).
- 4.) Attend your appointment. Bring this form with you to your appointment.
- 5.) Receive receipt for disposal 7 business days after participation from Barnstable County.

As per Department of Environmental Protection and Transportation regulations: you may transport only waste generated in your business, may transport no more than 55 gallons or 440 pounds per trip, must keep a copy of the VSQG registration in the vehicle during transport, must obtain a receipt from the hazardous waste contractor, and must keep the receipt for three years.

In addition, you must bring a cell phone in case of emergency; absorbent material for spills, a shovel and broom, and a container into which the absorbent materials will be placed in the event of a spill.
