### Multi-site Health Study



- Funded by Centers for Disease Control and Prevention (CDC) and Agency for Toxic Substances and Disease Registry (ATSDR)
- Includes communities in 7 states with PFAS contamination of drinking water supplies
- Goal: improve understanding of PFAS-related health effects



### MA PFAS and Your Health Study



- Hyannis and Ayer, MA
- Aiming to recruit 1000 adults and 300 children (ages 4-17)
- Enrollment started Fall 2021
- Including current and former residents of Hyannis



### What are PFAS?

- Per- and poly<u>f</u>luoro<u>a</u>lkyl <u>s</u>ubstances
- Class of over 9,000 compounds
- Extremely resistant to degradation
- Mobile in environment
- Used in consumer products since 1950s
- Emerged as common drinking water pollutants around 2010-2015







### **Exposure and health concerns**



#### **PFAS** exposures are common

• PFAS have been detected in over 99% of Americans







#### Harmful health effects linked to PFAS exposures

- Cancer (kidney, testicular)
- Elevated cholesterol
- Developmental effects
- Ulcerative colitis

- Thyroid disruption
- Decreased birth weight
- Changes in liver enzymes
- Preeclampsia
- Immunotoxicity, including decreased vaccine response

# Why is this study important?



- Certain PFAS have been linked to a range of health outcomes
- Gaps in our understanding of full range of health effects and effects of PFAS mixtures
- Results of the Massachusetts study will be combined with results from 6 other states
- Overall findings will inform drinking water standards and other future regulations

# PFAS in Hyannis drinking water

**2010**: Silent Spring found 2 PFAS in Hyannis public wells and in other Cape public wells.

**2014**: PFOS levels found above U.S. EPA guideline. Carbon treatment installed.

2016: U.S. EPA issued new guideline.
 Temporary advisory in Hyannis
 Purchasing agreements with other water supplies

After Additional treatment to meet new stricter Mass.

**2016:** regulations

**2020**: New Mass. standard (20 ppt) in October 2020

#### **Important note**

Hyannis drinking water is now being treated to remove PFAS chemicals and meets the new strict Massachusetts standard



### Who is eligible?



#### • Adults (ages 18+):

Lived in Hyannis between May 2006 and July 2016

#### Children (ages 4-17):

- Lived in Hyannis between May 2006 and July 2016 and/or their mothers lived in Hyannis during this time prior to child's birth
- Firefighters and others exposed through their job are <u>not</u> eligible
- Multiple members of same household can participate
- Former residents may be eligible



### What we'll ask you to do



#### Office visit

- Blood and urine sample
- Body measurements (height, weight, blood pressure)

#### Questionnaire (by phone)

- Residential and work history
- Water consumption patterns to reconstruct exposures
- Health history

### Neurobehavioral tests (children ages 5-17)

Activities to assess learning, memory, and attention







# What are we testing for?




- Core elements (required by ATSDR, all participants)
  - 12 PFAS chemicals measured at the CDC lab
  - Markers of health effects (such as cholesterol, thyroid hormones, sex hormones, markers of liver function)
- Additional tests (some participants)
  - Additional measures of PFAS exposure (such as non-targeted analysis, total organofluorine)
  - Other measures of health effects (such as metabolomics, cholesterol subfractions, COVID antibodies)

### What will participants receive?



- Satisfaction of supporting a high-impact study on chemicals of widespread concern
