

Private Road Workshop Overview


- Public/Private Roads in Barnstable




- Statistics on Roads in Barnstable
 - Public Roads
 - 250 miles of public roads
 - 700 public roads
 - 58% of our residents live on public roads
 - Private Roads
 - 200 miles of private roads
 - 1,100 private roads
 - 42% of our residents live on private roads

- Budgeted support for public roads
 - Public Roads Program (250 miles)
 - Capital Budgets FY 2023 \$3.75M
 - Pavement Management Program
 - Operating Budgets FY 2023
 - Admin & Engineering budget \$1.9M
 - Highway \$2.5M
 - Private Roads (200 miles)

- Some of the primary and collector private roads
 - Flint Street, Marstons Mills
 - Independence Park Drive, Barnstable
 - High Street, West Barnstable
 - Wakeby Road, Marstons Mills
 - Portions of Mary Dunn Road, Barnstable
 - Portions of Old Strawberry Hill Road, Hyannis
 - Asa Meigs and Millrace Roads, Marstons Mills
 - School Street, Marstons Mills
 - Patriot Way, Centerville

- Private Roads Program
- In 1994 the Town Council appointed a Roads Committee:
 - To study and make recommendations for a continuing list of private roads to be repaired under the revolving betterment program.
- In 1996 the Town Council broadened the Roads Committee's responsibility:
 - Tasked with developing a workable process for the layout and acceptance of private roads as town ways.

- Town proceeded with a layout and acceptance of private roads program until 2004.
- In 2004 the program ceased and went under review by a Town Council Roads Committee:
 - Temporary Repair to Private Roads Program continued
 - Town Council approved a modification to the sewer Trust Fund to include certain private roads and the Legislature adopted that change in October 2014

The Comprehensive Financial Advisory Committee (CFAC) has commented and continues to comment in their annual review of the Town Proposed Capital Improvement Program that further discussion at the policy level is needed regarding private roads.

• Given the significant investment in roadway infrastructure as a result of implementing the Comprehensive Wastewater Management Plan, it is in Barnstable's best interest to establish policy regarding post construction management of said pavement to maximize the assets' (i.e. roadway infrastructure) useful life.

- Town Manager is requesting a continued discussion(s) with Town Council to review and modify policy where appropriate regarding private roads.
- Initial areas of discussion
 - Private roads identified in the Comprehensive Wastewater
 Management Plan
 - Primary and collector private roads
 - Private roads that have been recently repaved by Town
 - All other private roads
