Three reasons to separate FOOD WASTE from trash





Reduce methane emissions from landfills Increasing costs of solid waste disposal

Generate compost to promote plant growth, and remove carbon dioxide from air

Methane

- Municipal landfills are the third largest source of methane emissions in the U.S. (14.5%)*
- Annual methane emissions from landfills are the greenhouse gas equivalent of the exhaust from 20 million cars driven for one year.*
- Slowing flow of food waste into landfills is an easy and low-cost way to reduce climate change.

Solid Waste Management

- Cape Cod Commission study notes that solid waste disposal capacity is declining throughout Massachusetts and prices are increasing rapidly
- Food waste represents 25% of waste stream and is biggest opportunity for reduction

Environmental Benefits of Compost

- Reduces need for chemical fertilizer and irrigation
- Promotes habitat revitalization by improving compacted and marginal soil
- Makes plants grow faster and removes more carbon dioxide from the air

Three Action Items to support separating **FOOD WASTE** from trash

Collect food waste generated by commercial and institutional establishments

Support ongoing collection of food waste at transfer station



Work with Cape Cod Commission to develop composting facility in Barnstable County

COMPOST

Acceptable Items

All Vegetable and Fruit Waste * Paper Towels and Napkins * Baked Goods *
Pasta * Meat and Bone Scraps * Coffee Grounds * Pumpkin & Sunflower Seeds *
Corn Cobs & Husks * Tea Bags * Dairy Products * Tofu & Soy Milk * Egg Shells
Fish * Grains (rice, oats, barley, etc.) * Grease Drippings *
Nut Shells (peanuts & pistachios, NO WALNUT)

Support Ongoing Collection of Food Waste at Transfer Station

- With strong support from transfer station staff Barnstable residents are already collecting 600 lbs. per week
- MassDEP recycling grant funds are being used to provide free counter-top bins and liners
- Potential for enhancement if town communications department promotes this on town social media sites
- Monitor progress towards goal of getting all food waste out of trash by 2030 consistent with MassDEP target

Collect Food Waste Generated by Commercial and Institutional Establishments

- Make local businesses and institutions aware of MassDEP rule prohibiting disposal of half ton or more of food waste per week in general trash
- Support commercial and institutional establishments to develop plans to achieve compliance with MassDEP rules within reasonable time

Work with Cape Cod Commission to Develop Composting Facility in Barnstable County

- Explore possible location of composting facility at Joint Base Cape Cod
- Commission is currently working with the Town of Yarmouth on building an anaerobic digester
