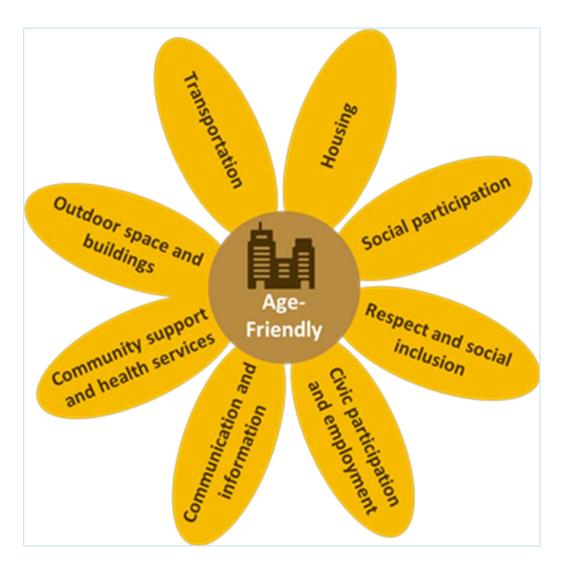


## **An Age Friendly Community**

An "age-friendly community" optimizes opportunities for health, participation, and security for all people, to ensure quality of life and dignity as people age.



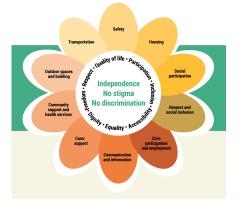
## 8 Domains of an Age Friendly Community



- Promotes health and personal independence
- Builds resources for those who can no longer live independently
- Supports aging in place
- Enables people of all ages to participate in activities
- Treats everyone with respect, regardless of their age
- Fosters meaningful connections in the community

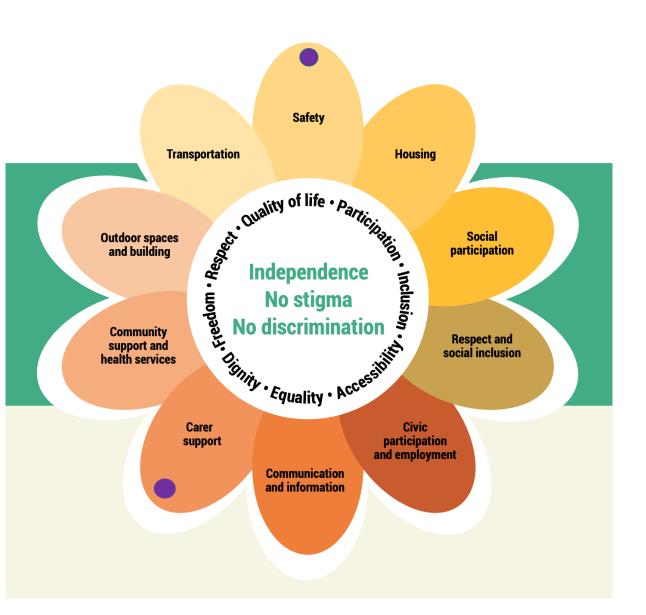
## **Dementia Friendly Framework**

- ► As the population ages, the number and proportion of Americans living with dementia is projected to rise
- ► In 2021, WHO enhanced the Age Friendly Framework and launched a toolkit for establishing and scaling-up dementia-friendly community initiatives

- Meaningful engagement in accessible environments
- Healthcare and supports along the dementia care continuum
- Educational opportunities to build awareness, support, safety, and respect in the community

## Barnstable's Age-Friendly Progress

- Age-Friendly Action Plan completed May, 2023
- Accepted into the Age-Friendly Community network in June, 2019
- September, 2015 Community Needs Assessment completed in partnership with the CSDRA
  - Aging in Place in the Town of Barnstable: Striving for High Livability in a Cape Cod Community.



## Strategies for Learning about Barnstable

- Review of 2015 needs assessment and demographic profile
- Review of documents completed by or referencing the Town of Barnstable about their current age friendly practices and future goals
- Five Community Planning Work Sessions, January, 2022
  - 1. Housing
  - 2. Transportation, walkability, and outdoor spaces
  - 3. Community supports and health services
  - 4. Social participation, respect, and inclusion
  - 5. Civic engagement and employment

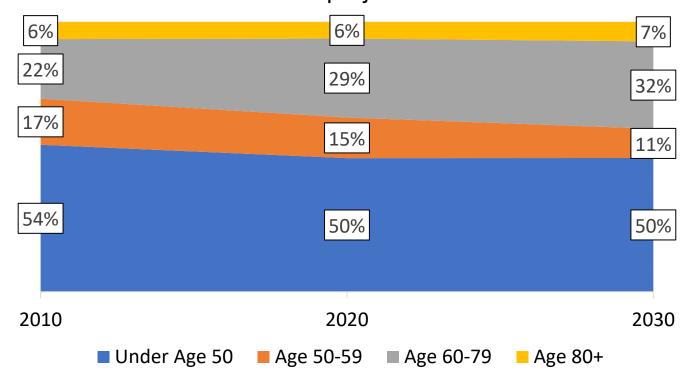






# By 2030, 39% of Barnstable's population is expected to be age 60+

## **Housing - Action Items**

#### GOAL #1

Increase advocacy and advance initiatives that create affordable and diverse housing options

- A. Promote awareness of housing options across the lifespan
- B. Encourage developers to create downsizing stock
- C. Identify space and partnerships to increase housing capacity for homeless individuals
- D. Explore shared housing arrangements for older adults

#### GOAL #2

Foster access to aging in place resources including property tax relief, home modifications, and maintenance supports

- A. Build a network of volunteers and contractors to support home modification needs
- B. Establish partnerships that support home maintenance needs including yard care, trash and snow removal



## **Transportation - Action Items**

#### GOAL #1:

Enhance existing transportation options

- A. Expand transportation discounts to include informal caregivers
- B. Ensure that vehicles offer wheelchair accessibility and comfort while reducing stigma against riding on a van
- C. Enhance bus stops with shading, seating, and signage



## **Transportation - Action Items**

#### **GOAL #2:**

Improve communication and education on transportation options among partners and residents

- A. Engage a focus group of healthcare providers to discuss challenge related to accessing healthcare facilities
- B. Educate frontline workers on transportation options for older adults
- C. Collaborate with medical providers to expand medical transportation services
- D. Offer travel training programs
- E. Build public awareness about the value, convenience, and environmental impact of public transit
- F. Promote driver safety programs
- G. Convene regional non-profits to build coordination and economies of scale across available transportation resources



## Walkability/Outdoor Spaces- Action Items

GOAL #1: Support the Complete Streets
Initiative, making roads safe and accessible for drivers, pedestrians, bicyclists, and transit users of all ages

- A. Establish a Complete Streets committee to foster collaborative efforts
- B. Conduct village- specific walk audits
- C. Conduct a geographic analysis of accident data to prioritize intersection improvements and traffic calming solutions

GOAL #2: Improve accessibility of outdoor spaces and provide a broad mix of active and passive recreational opportunities

- A. Create age friendly recreation trails through advocacy and volunteer efforts
- B. Provide age friendly walking trails maps that identify curb cutouts and seating
- C. Promote accessibility and age friendly/intergenerational features at parks
- D. Ensure beaches are pedestrian-oriented and accessible



## Community Supports & Health Services-Action Items

#### GOAL #1

Continue to build access to supports and expand training to address challenges.

- A. Increase awareness of aging in place and caregiver resources
- B. Explore the expansion of health and wellness services for older residents
- C. Create solutions to support residents in need of adult day and respite programs
- D. Conduct training and outreach to address access challenges related to language barriers
- E. Encourage local businesses to adopt age friendly practices



## Respect and Social Inclusion- Action Items

#### GOAL #1

Expand programming and events for older adults while increasing communication efforts to facilitate access to learning and wellness-promoting activities

- A. Increase access to offsite programming and events
- B. Increase lifelong learning opportunities
- C. Build social engagement and enrichment opportunities for caregivers
- D. Increase engagement options for homebound residents
- E. Develop an "Adopt a Grandparent/Grandchild" program
- F. Offer intergenerational conversation hours at the COA and libraries
- G. Expand Dementia Friendly practices



## Civic Engagement and Employment – Action Items

#### GOAL #1

Expand opportunities for employment and volunteering among older adults

- A. Increase access to training and opportunities for purposeful work and meaningful civic engagement
- B. Encourage local businesses to become Age Friendly employers
- C. Create support and incentives for caregivers

#### GOAL #2

Expand opportunities for additional engagement vehicles among older adults

- A. Create a centralized online platform and host a volunteer fair to inform residents of volunteer opportunities
- B. Explore programs that connect generations through community service work and shared learning A. C. Ensure that the needs and interests of older
- A. C. Ensure that the needs and interests of older adults are represented on Town Boards and Committees







## Building Awareness, Engagement, and Community Impact

Guided by the Steering Committee, build outreach and collaboration among residents, Town Staff, Boards, and other Stakeholders

- Announce Barnstable's Age and Dementia Friendly Steering Committee
- Host a workshop among Town departments and committees to:
  - Foster creative discussions around intersecting goals and identify feasible, visible ways to introduce this initiative
  - Discuss priorities, funding opportunities, and establish preliminary timelines
- Host a community launch event to introduce residents and stakeholders in the community to the action plan and impactful journey ahead
- Keep the community informed while recognizing and celebrating progress through local social media, newsletters, and other news channels
