## **SOCIAL DISTANCING**

### **What does it mean?**

## **Barnstable Town Council – Thursday, April 16, 2020**

***The April 16, 2020 meeting of the Barnstable Town Council was physically closed to the public to avoid group congregation. The Town provided three methods (Zoom, email, and telephone) of remote communication for those who wanted to participate. Agenda Chaptering is not currently available for this meeting.***

Last night's Town Council Meeting began with Town Council President Paul Hebert presiding over the meeting which began with the Pledge of Allegiance and a Moment of Silence. Public Comment was received through Zoom and phone. Town Manager Mark Ells presented the following items during Town Manager Communications for the period April 3-16, 2020:

1. Meg Mayo-Brown, Barnstable Public Schools Superintendent, provided an update relative to Barnstable Public Schools during the COVID-19 situation. (See Dr. Mayo-Brown's letter below)
2. We are proceeding with the tasks in the budget action calendar for FY 2021 as scheduled. On April 1, 2020 in accordance with Section 6-2 of the Town of Barnstable Charter, the Barnstable School Committee approved the FY 2021 Barnstable Public Schools Operating Budget and submitted to the Town Manager on April 7, 2020. On April 10, the Town Manager approved FY 2021 user fees for the Department of Public Works Water Pollution Control and Water Supply Divisions, and the Community Services Department Hyannis Youth & Community Center. Proposed fee changes to the Department of Public Works Solid Waste Division were not approved. The Town Manager plans to submit the recommended FY 2021 Operating Budget to the Town Council on May 12, 2020. For information on our fiscal year budgets please view the Town's Open Budget website at <http://budget.townofbarnstable.us>.
3. The Town Council appointed the Town Manager as its representative on the Cape Cod & Islands Water Protection Fund Board. The Bylaws and Regulations subcommittee met on April 14, 2020. We continued discussion of draft regulations and expect to continue discussions through the second quarter of 2020. The full Board is not scheduled for its next meeting at this time. The website for the Board has been created by the Cape Cod Commission staff and the link to the current webpage is: <https://www.capecodcommission.org/our-work/cciwpf-bylaws-regulations-committee/>. We will keep you advised on the progress of this Board.
4. The Cape Cod Commission in coordination with the National Estuary Programs are developing a list of shovel-ready, or near shovel-ready, projects that will improve estuarine health, in an effort to include such projects as part of anticipated COVID-19-related stimulus funding. Commission staff is working to provide a list of wastewater, stormwater, and other water quality related projects. The Town of Barnstable submitted a list of over \$70 Million dollars in projects in support of this effort. We also submitted the same list to Senator Warren, Senator Markey, and Representative Keating for their supportive efforts in providing stimulus funds to clean water efforts on Cape Cod. We will keep you advised of this effort as it progresses.
5. On Monday, April 13, Mr. Ells had a conversation with Vineyard Wind regarding the status of the Phase I and Phase II projects. Vineyard Wind continues to work with Barnstable staff regarding both Phases of the project. They anticipate commencing construction on Phase I in the spring of 2021 and proceeding with permitting on Phase II in 2020. We will keep you advised as this project progresses.
6. Katie Servis, Airport Manager, provided a status report on recent federal aid package.
7. Dan Santos, Director of Public Works, provided a status report on the Comprehensive Wastewater Management Plan (CWMP).

Town Manager Mark Ells joined by DPW Director Dan Santos and Solid Waste Supervisor P.J. Kelliher presented a **Workshop on the Barnstable Recycling Program**. **OLD BUSINESS** began with **Agenda Item**

**2020-138** Appointments to a Board/Committee/Commission: Community Preservation Committee; Disability Commission; Infrastructure and Energy Committee; Trust Fund Advisory Committee; Youth Commission which was approved. Airport Manager Katie Servis presented **Agenda Item 2020-140** Supplemental Appropriation and Transfer Order in the amount of \$**101,000** for the Fiscal Year 2020 Airport Enterprise Fund Capital Budget which was approved. Under **NEW BUSINESS**, the Town Council moved two items to Public Hearings on Thursday, May 7, 2020: **Agenda Item 2020-141** Appropriation and Transfer Order in the amount of \$**425,000.00** Community Preservation Funds for the creation and acquisition of a conservation restriction on three wooded lots addressed at 150 and 180 Great Marsh Road and 55 Hayes Road, Centerville 6.2 Acres and **Agenda Item 2020-142** Supplemental Appropriation in the amount of \$**36,000** for the Barnstable Police Department Fiscal Year 2020 Operating Budget for the purpose of funding the costs associated with the hiring of Patrol Officers to fill current vacancies. Town Manager Mark Ells presented **Agenda Item 2020-143** Resolve approving the **Appointment of Derek Lawson as Director of Marine and Environmental Affairs** which was approved. Mr. Lawson thanked the Town Council for their support and received a virtual round of applause from the Council. **Agenda Item 2020-144** Resolve authorizing the acceptance of Personal Property for COVID-19 Related purposes was approved. ***The next Town Council meeting will be held on Thursday, May 7, 2020 at 7:00 PM. At this time, we do not know if the May 7, 2020 meeting of the Barnstable Town Council shall be physically closed to the public to avoid group congregation. ## **Barnstable Public Schools Update from Superintendent Dr. Meg Mayo-Brown— April 15, 2020**

Dear BPS Community,

In Massachusetts, each school committee is responsible for establishing the school year calendar for its schools, and may adjust the school calendar to meet the needs of its community. Earlier today, the Barnstable School Committee voted to cancel April vacation, and continue our BPS Remote Learning Plan through next week. Their decision was informed by 1633 households and 452 staff who responded to yesterday's phone survey (and additional emails). Of those responding, more than 76% of BPS staff and 77% of families preferred to continue teaching and learning through next week. Since Monday is a holiday, students will be expected to continue to participate in the BPS Remote Learning Plan Tuesday through Friday.

We thank our families and staff who were able to participate in the survey, and for those who emailed and called with their perspectives. The next School Committee meeting is May 6. During the May 6th meeting, the School Committee will revisit the 2019-2020 school calendar to determine if additional adjustments are necessary. With today's vote, our last day of school, either in person or remotely, will be June 18, representing the required 180 days of instruction. We will offer another survey, closer to the May 6 meeting, to seek input on whether additional adjustments are necessary. One example, of a future adjustment discussed today by the School Committee, was to extend the Memorial Day weekend to create a longer break. As we get closer to May 6, I will send out information as to how families and staff can once again provide input.

## Town Manager Extends Payment Due Dates for Town Bills and Exemptions and Tax Deferral Applications

Town Manager Mark Ells, acting under newly granted authority by the Legislature and Governor, is



announcing the extension of due dates for the following real estate and personal property bills, motor vehicle excise bills, water and sewer utility bills, and exemption and deferral applications:

**Fourth Quarter Real Estate and Personal Property Tax Bills:**

- Original Due Date: May 1, 2020
- New Due Date: **June 1, 2020**

**Motor Vehicle Excise Taxes:**

- Any bills issued with a due date of March 10, 2020, or later are now due on **June 1, 2020**, regardless of the due date printed on the bill

**Water\* and Sewer Utility Bills:**

- Any bills issued with a due date of March 10, 2020, or later are now due on **June 1, 2020**, regardless of the due date printed on the bill

**Property Tax Personal Exemption and Tax Deferral Applications:**

- Original Due Date: April 1, 2020
- Extended Due Date: **June 1, 2020**

In addition to extending the due date for payments, The Town Manager is also waiving the payment of interest and other penalties in the event of late payment of any real estate, personal property, motor vehicle excise, boat excise, and water or sewer utility bills for an additional month, giving Barnstable taxpayers until June 30, 2020, to make payment without incurring interest or demand late fees.

Please note that this newly granted authority only allows municipal chief executives to extend statutory payment deadlines and waive statutory interest and penalties through the end of the fiscal year on June 30, 2020. Under the new state legislation, payments made after June 30, 2020 will be subject to interest and penalties back to June 1, 2020.

During the COVID-19 emergency, the office of the Treasurer/Collector is closed to the public. However, there are several optional payment methods available:

1. Mail checks using the envelop provided or to the Town of Barnstable, PO Box 40, Hyannis, MA 02601
2. Online thru the Town of Barnstable website under Quicklinks/Pay bills online
3. Leave check payments in the outside drop box located next to the walkway leading to Town Hall. Please do not leave any cash in the drop box, checks only.

**\*Finance Director Provides Further Clarification Regarding Payment of Water Utility Bills and**

**Motor Vehicle Excise Tax Bills** Finance Director Mark Milne would like to provide further clarification on the extension due dates for water utility bills. The new due dates and the waiver of interest and penalties only apply to the Hyannis Water System utility bills and do not apply to water utility bills issued by the Barnstable Fire District, Centerville-Osterville-Marstons Mills (COMM) Fire District and Cotuit Fire District. Any questions regarding water utility bills within the Fire Districts should be directed to their respective Water Department. In addition, the Town of Barnstable will be mailing Motor Vehicle Excise bills dated April 9, 2020. These bills have already been printed. The due dates on the tax bills will indicate May 8<sup>th</sup>; however, taxpayers will have until June 30, 2020 to pay the bill without interest and penalties. ## Notice of Additional Changes at Transfer Station & Recycling Center

- Effective Monday, April 13, 2020, the Transfer Station and Recycling Center will be temporarily closing the facility on Tuesdays and Wednesdays through May 4, 2020.
- Also effective Monday, April 13, 2020, the Recycling Area at the Town of Barnstable's Transfer Station will be temporarily closed through May 4, 2020. On the busier days, despite our best attempts, this area does not provide for appropriate social distancing. These measures are being done to provide a safe environment for our employees and our residents.
- These measures create redundancy in staffing and assist in continuing the ability to provide essential services throughout this difficult time. Social, or physical, distancing is one of the key elements being used to combat COVID-19.
- Recycling is not considered an essential service during a State of Emergency.
- Recycling Sticker holders will be limited to disposal of scrap metals, disposal of yard waste, and access to free compost.

### A Reminder:

- The Transfer Station is an essential operation to residents of the Town of Barnstable.
- Current sticker holders may continue to utilize the facility to dispose of trash.
- The Office and Gate House at the Transfer Station & Recycling Center will be closed to the public and all person-to-person transactions suspended. Staff will be available to answer phone calls at 508-420-2258.
- The acceptance of chargeable recyclable items has been temporarily suspended. These items include but are not limited to mattresses, TVs, white goods, and toilets.
- The Construction & Demolition (C&D) Area will be accepting material with restrictions. All vehicles disposing of C&D material will be required to weigh the material on the scale. The Gate Attendant will direct the vehicle on how to proceed via the intercom system. Payments for C&D material will be accepted **BY CHECK ONLY**. Cash and electronic payments will **NOT** be accepted. Check payments will be placed inside a designated box/container at the intercom system. Receipts and weigh slips will not be issued during this time.
- These measures follow the recommended guidance of social and physical distancing. The Town and Transfer Station employees are working to limit the amount of disruption these changes may cause. Thank you for your cooperation and understanding throughout this serious situation.

The Town of Barnstable's Water Pollution Control Division requests that you please do not flush any disinfecting wipes down the toilet. These wipes clog sewage pumps inside of the Town's sewage pumping stations. This requires staff to manually remove the wipes from the pump in order to put the pump station back into operation. Flushing wipes down the toilet endangers the health and safety of Town employees and increases the risk of a sewage overflow, putting public health at risk. Please discard all used wipes into a trash can. Thank You.

## ROAD WORK UPDATES

*As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.*

### MassDOT Route 28 Pavement Repairs, Centerville

Lawrence-Lynch Corp, as a contractor for MassDOT, will be repairing pavement along two sections of Route 28 starting April 21, 2020. The work will include repairing deteriorated asphalt within Route 28 from the Phinney's Lane to Richardson Road and from 1675 Falmouth Road to Richardson Road. Weather pending, construction will be on-going, Monday through Friday from 7:00 AM to 3:30 PM until completion of the work. Work within Route 28 is anticipated to start on April 21, 2020 and be completed by April 28, 2020. Lane restrictions will be controlled by police details.



### Roadway and Sidewalk Improvements Parkway Place in Hyannis, MA

Roadway and sidewalk improvements are scheduled to commence on Parkway Place in Hyannis on Wednesday, April 8, 2020. The improvements include removal of the existing roadway surface, installation of new sub-base material, installation of a new paved road surface, replacement of existing curb and sidewalks and restoration of any areas disturbed during construction. The Town's contractor for this project is Lawrence Lynch Corporation out of Falmouth, MA. Normal work hours will be between 7:00 AM to 5:00 PM, Monday through Friday. Construction is expected to be completed by April 24, 2020. Through traffic will be maintained throughout construction. Any lane closures will be supported

with police details to direct traffic. Motorists are advised to seek alternate routes to avoid the construction work.

### **Drainage and Pavement Improvements on Straightway in Hyannis**

Drainage and pavement improvements began on Straightway in Hyannis during the week of March 23, 2020. The improvements include installation of new drainage systems, expansion of existing drainage systems, pavement milling and overlay, and restoration of disturbed areas. The work will focus on the section of Straightway between Candlewick Lane and Craigville Beach Road. The Town's contractor for this project is Lawrence Lynch Corporation out of Falmouth, MA. Normal work hours will be between 7:00 AM to 5:00 PM, Monday through Friday. Construction is scheduled to continue until April 17, 2020. Through traffic will be maintained throughout construction. Any lane closures will be supported with police details to direct traffic. Motorists are advised to seek alternate routes to avoid the construction work.

### **Pavement Improvements on Old Kings Road in Cotuit**

Pavement improvements began on Old Kings Road in Cotuit during the week of March 30, 2020. The improvements include reclamation of the existing pavement, grading and compacting of the sub-base material, installation of a new paved road surface within the footprint of the existing pavement, and restoration of any areas disturbed during construction. The Town's contractor for this project is Lawrence Lynch Corporation out of Falmouth, MA. Normal work hours will be between 7:00 AM to 5:00 PM, Monday through Friday. Construction is expected to be completed by April 24, 2020. Through traffic will be maintained throughout construction. Any lane closures will be supported with police details to direct traffic. Motorists are advised to seek alternate routes to avoid the construction work.
