Town Council Meeting – Thursday, December 17, 2020

The December 17, 2020 Barnstable Town Council Meeting was physically closed to the public to avoid group congregation. The public was able to view through Live Streaming on the Town of Barnstable's website or Comcast Channel 18. Agenda Chaptering is not currently available for this meeting.

Town Council President Paul Hebert began last night's <u>Town Council Meeting</u> and Vice President Jessica Rapp Grassetti led the reciting of the Pledge of Allegiance which was followed by a Moment of Silence. Mark S. Ells, Town Manager, presented his Town Manager Communications for the period of December 4-17, 2020:

- 1. Katie Servis, Airport Manager, provided an update on Airport Rebranding.
- 2. This is the last meeting that Vice President Rapp Grassetti would be serving as Vice President of the Council. Thank you for your leadership.
- 3. As a reminder the Town of Barnstable continues to follow the Orders and Directives of our Governor. The Governor continues to frequently update these Orders and Directives. I

encourage everyone to go to the Mass.gov COVID website or the Town of Barnstable website and read these Orders and Directives. The Town of Barnstable is now designated as "red" (higher risk) by the MA Department of Public Health. We have experienced an increase in the average number of positive cases (double digit) in Barnstable requiring continued attention by our residents to following proper safety protocols regarding personal hygiene, physical distancing, limit gathering size, wearing a face mask, and in general taking personal responsibility regarding this matter. We are in Phase 3 Step 1 of the Governor's four phase recovery plan in Barnstable. After the recent Thanksgiving Holiday and an extended remote learning period our schools have returned to in class learning for all or part of their school week. Upon returning to school after the upcoming holiday recess it is anticipated that they will follow these same respective schedules. Please continue to watch for updates from our School Superintendent. Thank you for your continued adherence to these requirements.

- 4. We are proceeding with the tasks in the updated budget action calendar for FY 2022 as scheduled. We are using the preliminary state budget with the assumption of level funded state aid until such time as the final state budget is approved. The proposed Calendar Year Fee hearing was held on November 17, 2020 via Zoom. The proposed fees are posted on the Town's website Home page under In the News section as Proposed Fee Hearing Notice. I approved the fees as proposed today. We anticipate holding the joint meeting/workshop with the Town Council/School Committee to review the financial condition of the Town on January 21, 2021. For information on our fiscal year budgets please view the Town's Open Budget website at http://budget.townofbarnstable.us.
- 5. We have commenced the review of capital project submissions for the next 5 year plan covering FY22 through FY26 and they total \$468 million. Of this amount, \$124 million represent the Enterprise funds' request; \$203 million are General Fund request and \$141 million are requests associated with the Comprehensive Wastewater Management Plan. A total of 170 projects were submitted for funding. The capital planning Task Force which is primarily comprised of Department heads from all departments met on Thursday, December 10th to review and categorize the projects requesting funding for the FY22 budget year. Projects were categorized as must do, should do, could do, or nice to do. A total of 54 projects were presented and will be ranked by the Task Force in accordance with 10 specific criteria that correlate to the Town Council's Strategic Plan. The Comprehensive Financial Advisory Committee (CFAC) has been provided with access to all capital plan submissions as well as a video recording of last week's Task Force meeting. CFAC's report is scheduled for March 8, 2021 and will accompany the Town Manager's submission of the FY 2022 Capital Improvement Program to Town Council. The Town Manager takes the recommendations of the Task Force under consideration as the FY2022 Capital Improvement Program is finalized. The 5 year capital plan as well as the FY 2022 Capital Improvement Program is scheduled to be submitted to the Town Council on March 8, 2021.
- 6. The Town of Barnstable Years of Service Awards is on Friday, December 18, 2020 via Zoom. 2020 has been a year unlike any other we have experienced in recent memory. I will be thanking the Town of Barnstable employees for their dedication and commitment to quality service especially during these difficult times. We will be gathering virtually under the guidance of our Human Resources Department and recognizing staff in 5 year increments of service. I want to publically thank this year's honorees and an all our staff as we move through the recovery phases of this pandemic with focus on a high quality of service during a time of change to remote, contactless and safe provision of public services to our residents, businesses and visitors.
- 7. Dan Santos, DPW Director, provided an update on the Comprehensive Wastewater Management Plan.

8. On December 10, 2020 the Town Council held a Special Town Council meeting on Fiscal Policy Review on the Comprehensive Wastewater Management Plan (CWMP). In our effort to develop fiscal policy relevant to the CWMP, Mark Milne, Director of Finance, provided a Fiscal Policy presentation regarding the CWMP that was focused on several financial options for Town Council consideration. We have taken under advisement the comments and directions provided by our Town Council and have developed a draft Sewer Assessment Ordinance for public review. I have referenced the link to the draft ordinance that can be found on our web page under Departments, Town Manager, Office Updates 2020-12-17 Initial Draft Sewer Assessment Ordinance. We plan to bring a final draft ordinance to Town Council for consideration after a public review process. In our continued efforts to achieve the desired communication outcome to maintain the professional credibility of the Town's government with its residents and stakeholders. The Town's citizenry should be active, involved, and feel heard on all aspects of our government and specifically on the Comprehensive Wastewater Management Plan. We anticipate a robust effort to engage our citizens in the review of this significant planning effort even with the challenges of COVID upon us. The time to proceed is now and we will use both traditional and nontraditional communication methods to achieve our desired outcome of engaging our public in this effort. We will keep you advised of our progress and bring back a final draft sewer assessment ordinance for your consideration upon satisfactorily completing a public process.

During Council Communications, Lucas McCauley and Luc-Andre Sader of the Barnstable Youth Commission invited the Town Council to save the date for their 7th Annual Community Prevention Forum which will be held on January 12th (see more information below). **OLD BUSINESS** began with a Public Hearing for Agenda Item 2021-047 Appropriation Order in the amount of \$90,000 for the Inspectional Services Department Fiscal Year 2021 Operating Expense Budget to fund a contract for the comprehensive monitoring of rental properties which was presented by Building Commissioner Brian Florence, The item was approved. A Public Hearing was held for Agenda Item 2021-055 Appropriation Order in the amount of \$148,953.25 for the purpose of paying operating expenses of the Solid Waste Division for the disposal of household hazardous waste, construction and demolition material, municipal solid waste and recyclables which was presented by DPW Director Dan Santos. The item was approved. **NEW BUSINESS** began with Barnstable Police Chief Matthew Sonnabend presenting five grants for the Police Department: Agenda Item 2021-048 Acceptance of a Federal Fiscal Year 2020 Bulletproof Vest Partnership Grant in the amount of \$8,000 from the United States Department of Justice Office of Justice Programs; Agenda Item 2021-049 Acceptance of a Fiscal Year 2021 State 911 Department Training Grant in the amount of \$16,912.26 from the Commonwealth of Massachusetts Executive Office of Public Safety and Security; Agenda Item 2021-050 Acceptance of a Federal Fiscal Year 2020 Emergency Management Performance Grant in the amount of \$15,500 from the Commonwealth of Massachusetts Emergency Management Agency; Agenda Item 2021-051 Acceptance of a Fiscal Year 2021 911 Department Support and Incentive Grant in the amount of \$270,026 from the Commonwealth of Massachusetts Executive Office of Public Safety; and Agenda Item 2021-052 Acceptance of a Fiscal Year 2021 State 911 Department Emergency Medical Dispatch Grant in the amount of \$20,299.98 from the Commonwealth of Massachusetts Executive Office of Public Safety and Security. Chief Sonnabend also introduced Lena Bevilacqua, Administrative Assistant to Investigative Services, who assisted with the grants. All items were approved. DPW Director Dan Santos presented Agenda Item 2021-056 Transfer Order in the amount of \$65,000 from the Fiscal Year 2021 Public Works Department Personnel Budget to the Fiscal Year 2021 Public Works Department Operating Expense Budget for the purpose of funding Municipal Solid Waste Collection Services which was approved. Town Councilor Matthew Levesque presented Agenda Item 2021-057Appointments to a Board/Committee/Commission: Mid

Cape Cultural Council for which the Town Council voted to suspend the rules and then voted to approve. Two items were referred to the Planning Board: Agenda Item 2021-058 Amending the Zoning Map of the Town of Barnstable to expand the Multifamily Affordable Housing District to include Map 250 Parcel 160 at 3 Whitehall Way, Hyannis, MA; and Agenda Item 2021-059 Amending Article III, Chapter 240, Section 16.1 of the Zoning Ordinance to modify the required percentage of affordable units and revise the definition of affordable unit and Article XI, Chapter 240, Section 116 of the Zoning Ordinance to exempt development under the Multifamily Affordable Housing (MAH) from Growth Management. A first reading was held for Agenda Item 2021-060 Reappointments to a Board/Committee/Commission: Town of Barnstable's Representative to the Steamship Authority's Board of Governors: Robert Jones, as a regular member to a term expiring 12/30/21; Town of Barnstable's Representative to the Woods Hole, Martha's Vineyard and Nantucket Steamship Authority Port Council: Eric Shufelt, as a regular member to a term expiring 12/30/21. The Town Council voted to approve the 2021 Town Council Calendar of Meetings. Next on the agenda was Town Clerk Ann Quirk presiding over the Town Council Election of 2021 Officers. After speeches from candidates and their supporters, Matthew Levesque was elected President and Paula Schnepp was elected Vice President. The gavel was passed to newly elected President Matthew Levesque to adjourn the meeting. The next regularly scheduled Town Council Meeting will be held on Thursday, January 7, 2021 at 7:00 PM. Barnstable Elderly & Disabled Taxation Aid Fund

Background

The Barnstable Town Council has accepted Massachusetts General Law, Chapter 60, Section 3D which allows the Town to establish a fund to defray the real estate taxes of low income elderly and disabled persons. Taxpayers contribute to the fund through a voluntary check off on their real estate tax bills. The funds collected are distributed to needy individuals through an annual award process. To be considered for this annual award, potential recipients need to meet the following eligibility requirements and complete and submit the attached application form.

Eligibility

2 65 years or older on July 01, 2020

OR

- Disabled- Applicant must be receiving benefits from a State or Federal recognized disability entity. (example: Social Security Administration, Veterans Administration)
- Total gross household income shall not exceed \$35,000.00 single, or \$40,000 married. Other assets must be less than \$40,000. Other Assets are the value of personal property and other real estate excluding domicile. This includes cars, boats, savings and checking accounts. Gross household income is income earned in the calendar year ending 12/31/2019 and should include all income received from all sources by the applicant as well as any additional residents in the household. Please be advised that we refer to the official Town Census Listing to confirm household residents.
- Applicant(s) must be the titled owner of the property or hold a life estate in the property on July 01, 2020. If Title is held by a Trust, the applicant must be both a trustee and at least a 50% beneficiary of the trust in order to qualify. The property must be the applicant's primary residence.
- Please provide proof of income by attaching copies of all the following that apply:

Social Security Benefits Award letter	Bank/Investment Account Statements
IRS Form W-2	IRS Form 1099
Pay Stubs	IRS Form 1040

Timeline

Applications will be accepted through **January 15, 2021**. Awards will be announced by January 30, 2021 and will be applied directly to the applicant's residential tax bill. Applications are available at the Barnstable Senior Center, on the Town of Barnstable Website or by calling the Town of Barnstable Treasurer's office at 508-862-4656.

What To Do If You Find A Cold-Stunned Turtle

It is very important to recover these stranded turtles as quickly as possible. Do not assume a turtle is dead—turtles that appear lifeless are often still alive. If you come across a stranded sea turtle on the beach, please follow these simple steps:

- 1. Move the turtle above the high tide line. Never grab or hold the turtle by the head or flippers.
- 2. Cover it with dry seaweed or wrack.
- 3. Mark it with an obvious piece of debris—buoys, driftwood, or branches.



4. Call the Wellfleet Bay Wildlife Sanctuary hotline at 508-349-2615 x6104. Sea turtles are federally protected under the Endangered Species Act; as such, it is illegal to harass sea turtles or transport them without a permit.

Route 6 Renumbering

The Massachusetts Department of Transportation is getting ready to swap the exit signs along Route 6 to a mileage-based system. On Monday, crews will begin making the changes on Route 6. That work will begin in Bourne and proceed eastward to Orleans for a week before reversing direction to do the westbound side. Work on Route 6 is scheduled to primarily occur between 8:00 PM and 5:00 AM. The exit numbers are being changed by MassDOT to comply with federal highway mandates, which require mile-based exit signs. Massachusetts is one of three states that have not yet begun any sort of conversion to the mileage-based system. Delaware and New Hampshire are the other two states. The old numbers will remain on the signs for at least two years.

Meals for Barnstable Public School Students

Barnstable Public Schools is providing FREE breakfast and lunch for any student free of charge. (No ID is required). All children are welcome regardless of town of residence or school attended. All meals will be offered in compliance with USDA standards and will be a "Grab and Go" option. We will be providing both breakfast and lunch at the same time. Students are encouraged to take one breakfast and one lunch. **NOTE:** Fridays we will be handing out 3 breakfast and 3 lunches to each student for the weekend. All schools will have grab and go breakfast and lunch set-up outside from 11:30 AM-12:30 PM. This will be available until the end of the year. This is free to all students in Barnstable. **We must stress the importance of social distancing during meal pick up**. You can just drive up and we will bring the meals to you. Please do not congregate at meal sites, and please remain 6 feet from those around you at meal pick up. Our BPS educators and staff are also leading efforts to collect non-perishable food items, and we will begin distributing those items at meal sites as well. Barnstable Public Schools' Food Services and Transportation are once again partnering on a food delivery program for our Barnstable Families that can't access grab and go sites. Multiple meals, 5 breakfast and 5 lunches will be handed out to students and parents/guardians at specific bus stop locations on Wednesdays.

ABOUT THE HYANNIS HYARTS ARTIST SHANTY PROGRAM:

Artist shanties are located in the Hyannis HyArts Cultural District, on Ocean Street, along the Walkway-to-the-Sea from Hyannis Main Street to Hyannis Harbor. Seven shanties are located at Bismore Park, 180 Ocean Street, and steps away five shanties are located at the Harbor Overlook, 51 Ocean Street, at the corner of South and Ocean Street, overlooking Aselton Park and Hyannis Harbor. The expansion of the Hyannis HyArts Artist Shanty program to two locations creates an additional attraction for



visitors walking from Main Street to Hyannis Harbor through the Hyannis Village Green along the Walkway-to-the-Sea and, at the same time, provides more affordable selling space and increased exposure for local artists and artisans. The Hyannis HyArts Artist Shanty Program began in 2005, as the first in a series of arts-oriented strategies designed to provide opportunities and exposure for local artists; enliven the economic climate in downtown Hyannis; and establish an important vibrant backdrop for year round residents and visitors. The shanties are open weekends May through mid-June; seven days a week through end of September; October weekends and special events in November and December. Artist work is hand-made, hand crafted or designed and all artists are from Cape Cod. A variety of work is represented including jewelry, paintings, photography, visual art, woodcarving, fiber arts, ceramics, rope work, glass work, literary art, mixed media, and more. This artist program is made possible in cooperation with the Town of Barnstable, and its Cultural District partners including the Cape Cod Art Center (CCAC), Hyannis Main Street Business Improvement District (BID), the Greater Hyannis Area Chamber of Commerce, the JFK Hyannis Museum and Cape Cod Maritime Museum and the Cape Cod Regional Transit Authority.

ROAD WORK UPDATES

As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.

NEW Sewer Construction on Hyannis Avenue and Marstons Avenue

Robert B. Our Co., Inc. will be starting construction on a privately funded sewer extension on Hyannis Avenue and Marstons Avenue from 10 Hyannis Avenue to Nob Hill Road. The work will consist of the installation of approximately 1,250 feet of new sewers which, upon completion of the work, will become part of the municipal sewer system, and allow for adjacent properties to connect to the municipal sewer system. The disturbed roadways will be trench patched (temporary pavement) for the remainder of the winter. In the spring, the disturbed roadways will be milled and paved for the full road width. Weather pending, work is scheduled to begin on December 21st and the work is anticipated to take six (6) weeks to complete. Work will be performed from 7 AM to 5 PM, Monday through Friday. Temporary detours will be necessary during the work. Police details and signage will direct motorists around the construction crews. Drivers are advised to seek alternate routes. As always, please slow down and use extreme caution when traveling through the construction area, and follow posted safety signs.

UPDATED Water Works Construction On Longview Drive In Hyannis

The water works construction project, originally scheduled to start December 14th, is now scheduled to start January 4, 2021 on Longview Drive in Hyannis. This project will install approximately 500 feet of 8 inch water main and move the temporary interconnection with the COMM water system to a vacant lot on Longview Drive. The metal container will be enclosed in a building appropriate for the neighborhood. Normal works hours will be between 8:00 AM and 4:40 PM.

UPDATED Drainage Improvements on Lake Shore Drive in Marstons Mills

Drainage improvements on Lake Shore Drive in Marstons Mills are on hold due to winter conditions. Contractor will be demobilizing until spring 2021.

CONTINUES MassDOT Schedules Intersection Improvements at Falmouth Road (Route 28) at Osterville West Barnstable Road

MassDOT Construction operations on the intersection at Falmouth Road (Route 28) at Osterville West Barnstable Road will continue through to April 2021. The road has been redesigned to include exclusive left turn lanes and improve bicycle and pedestrian accommodation as part of the proposed safety improvement work. The work to be done consists of furnishing and installing of new traffic signal equipment at the intersection including emergency vehicle pre-emption system, bicycle and vehicles loop detectors, construction of ADA compliant wheelchair ramps, sidewalks, and driveways, box widening, pavement milling and resurfacing, new pavement markings and signs, drainage improvements, water distribution modifications, existing utility pole relocations, installation of granite curbing, loam and seeding. Work will be performed during the day, Monday through Friday 7:00 AM-3:30 PM. Traffic control will include all required signage, channeling devices for lane shifts and alternating one-way traffic as required. Police details/ flaggers will be used as needed. Visit <u>www.mass511.com</u>, a website which provides real-time traffic and incident advisory information, and allows users to subscribe to text and email alerts for traffic conditions. Follow MassDOT on Twitter @MassDOT to receive regular updates on road and traffic conditions. Download MassDOT's GoTime mobile app and view real-time traffic conditions before setting out on the road.

UPDATED Drainage & Pavement Improvements on Huckins Neck Road in

Centerville/Barnstable Village

All drainage work is completed. The contractor will be demobilizing and returning in spring 2021 to complete roadway paving.

CONTINUES National Grid Service Road

National Grid has completed the installation of new gas main on Service Road in Barnstable. The gas line was activated on December 3rd, and the contractor will start demobilizing from the site in by mid-December. Work will be performed during the day, Monday through Friday from 6:00 AM to 6:00 PM. Service Road will remain open with one-lane of traffic. Police details/ flaggers will be used as needed. Final re-paving of Service Road is anticipated to be completed in spring 2021.

CONTINUES Bumps River Bridge Repairs on South Main Street in Centerville/Main Street in Osterville

Work on the bridge supports is scheduled to continue through the beginning of January 2021. Normal work hours are 7:00 AM to 5:30 PM, Monday through Friday; however, the work may be performed during nighttime and weekends based on tidal cycles and weather conditions. The contractor is expected to deploy their construction craft from McCarthy's Landing (aka Hayward Landing) at 40 Hayward Road in Centerville. This may create brief delays for other users when the contractor is using the landing. The ramp will still be available for public access. The contractor is responsible for maintaining small vessel navigational access under the bridge at all times during construction. Mariners are urged to use caution and go slow when approaching and moving through the work area. It is expected that divers will be in the water during construction operations. Mariners are required to maintain proper distance from Dive and Alpha flags based on Maritime law. The bridge will remain open to traffic throughout construction. During this work there may be temporary single-lane closures with signs and police officers to direct traffic past the work zone.

CONTINUES Sidewalk, Traffic Signal, Water Distribution, and Associated Improvements on Independence Drive in Hyannis and Barnstable Village, and on Portions of Mary Dunn Road, Kidd's Hill Road, and Attucks Lane in Barnstable Village

Construction is scheduled to end in May 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Work will include a new sidewalk and additional drainage systems the full length of Independence Drive, on Mary Dunn Road a short distance south of Independence Drive, on Kidd's Hill Road from Independence Drive to Merchants Way, and on Attucks Lane from Independence Drive to Wilkens Lane. The work will also include a new traffic signal system at the intersection of Attucks Lane & Wilkens Lane; a watermain extension on portions of Attucks Lane and Independence Drive; and additional street lights on portions of Independence Drive and Kidd's Hill Road. During active construction there will be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zones.

UPDATED Roadway Improvements on Portions of Main Street (Route 6A) and Mill Way in Barnstable Village

Construction is scheduled to continue into spring 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Remaining work includes utility line transfers and pole removals in a few locations (by utility companies); constructing a sidewalk from Main Street to the County Complex parking lot east end; installing street lights; refurbishing traffic signals; and other associated work. During active construction there will be lane closures or temporary detours with signs and police details or flaggers to direct traffic past or around the work zones.

CONTINUES Survey and Map five of the Phase 1 Sewer Expansion Projects

As the first step in a multi-year planning and design effort, the Barnstable Department of Public Works has contracted with multiple land surveying firms to survey and map five of the Phase 1 Sewer Expansion Projects identified in the Town's Comprehensive Wastewater Management Plan. The projects include the mapping of dozens of roadways, including many residential areas for the following Phase 1 projects:

- Phinney's Lane Sewer Expansion Project which includes Phinney's Lane from Route 132 to Route 28 including residential roads to the east and west of Phinney's Lane
- Long Pond Area Sewer Expansion Project which includes all roadways between Old Stage Road /Park Avenue (western limits) and Strawberry Hill Road (eastern limits) and including the residential areas on the north and south side of Pine Street
- Route 28 East Sewer Expansion Project which includes Route 28 from the Water Pollution Control Facility property to Phinney's Lane
- Route 28 Centerville Sewer Expansion Project which includes Route 28 from Phinney's Lane to East Osterville Road and includes East Osterville Road and Old East Osterville Road
- Route 28 Marstons Mills Sewer Expansion Project which includes Route 28 from East Osterville Road to Old Post Road

Citizens can expect survey field crews to be working within the project areas at various times throughout the summer and fall. In the coming weeks, property owners within the project areas will be receiving notifications from the survey consultants which provide further detail on the survey project. Sign up <u>here</u> today. **What is CodeRED and why is it important to me?** CodeRED is an emergency notification service by which town officials can notify Barnstable residents and businesses by telephone, cellular phone, text message, or electronic mail about time-sensitive emergency situations or important community alerts. The system is capable of sending messages only to specific neighborhoods or the entire town. Only authorized officials are allowed access to use the system.
