Town Council Meeting – February 4, 2021

The February 4, 2021 Barnstable Town Council Meeting was physically closed to the public to avoid group congregation. The public was able to view through Live Streaming on the Town of Barnstable's website or Comcast Channel 18.

Town Council President Matthew Levesque began last night's <u>Town Council Meeting</u> with asking Town Councilor Jessica Rapp Grassetti to lead the reciting of the Pledge of Allegiance which was followed by a Moment of Silence. Mark S. Ells, Town Manager, presented his <u>Town Manager Communications</u> for the period of January 22-February 4, 2021:

- Chief Sonnabend provided an overview of the events of February 2, 2021 recognizing the heroic efforts of Barnstable Police Officers Nelson Souve, Gustavo Eloy, Marcus Cunningham, and Michael Lima.
- 2. Andy Clyburn, Assistant Town Manager, provided an update on COVID vaccination efforts.
- 3. As a reminder, the Town of Barnstable continues to follow the Orders and Directives of our Governor. The Governor continues to frequently update these Orders and Directives. I encourage everyone to go to the <u>Mass.gov COVID website</u> or the <u>Town of Barnstable website</u> and read these Orders and Directives. As shared by our Assistant Town Manager, key officials of the Town continue to meet daily to plan and implement proper actions which are in step with the Governor's orders and MA DPH guidelines. We continue to remind everyone to follow the State guidelines and to take these basic precautions which include:
 - Wear a face covering;
 - Wash your hands frequently;
 - Maintain proper physical distancing:
 - Stay home from work, school, sports and other activities when ill.
- 4. We are proceeding with the tasks in the budget action calendar for FY 2022 as scheduled. For information on our fiscal year budgets please view the Town's Open Budget website at http://budget.townofbarnstable.us.
- 5. On February 2, 2021 Standard & Poor (S&P) assigned a AAA rating with a stable outlook to our next bond issue and reaffirmed a AAA rating to all our outstanding debt. We plan to issue a \$2.8 million taxable bond this month for private road repairs and a \$10.8 million non-taxable bond in March for FY20 and FY21 capital projects. S&P will issue another report in March for our \$10.8 million issue next month. Finally, I want to thank our Finance Director Mark Milne with specific thanks to Treasurer/Tax Collector Deb Blanchette who performs much of the work with our financial advisors structuring the bond issue and providing bond counsel all the information they need to certify those bonds that are non-taxable.
- 6. The COVID-19 pandemic necessitated a work force to transition to a remote work environment in order to provide continuity of operations. While working remotely it has become apparent that access to archived paper files is necessary to be effective but they were inaccessible to those working remotely because they were not digitized. It was determined that the best way to access those documents was to have the archives scanned and put into a database that could be accessed remotely. After a trial run using building permits we determined that completing such a project in-house would take years and would not address our immediate or future needs so we contracted for this service. With the assistance of our Finance Director it was determined that digitize over 8,000,000 documents and make them available not only to our staff but to our public as well. The benefits to this project are immeasurable and will continue to benefit our organization and Barnstable residents here forward.
- 7. In late December Town Council appropriated funding for a rental registration monitoring system. The system by Host Compliance was acquired in January and staff is in the planning phase of implementation with the vendor. This system will help ensure all rental property operators come into compliance with existing regulations. Historically we have used a strictly complaint driven enforcement process. This tool will allow us to take a more active approach towards achieving compliance. Additionally, this system will help provide decision-makers data; data that will better inform any future decisions that may be brought forth on regulating rentals in our community. The vendor is currently working with our Assessing and I.T. staff to obtain Assessor's records required for this effort. Additionally, Inspectional Services staff are working with the vendor this

month to implement the monitoring system which we anticipate will be ready for testing in March. The following is a tentative Implementation timeline: April – May 2021: Implement Online registration and monitoring; June 2021: Initiate the Complaints Hotline and testing, compare / contrast the DOR list of registered tax payers with the Host Compliance and notice non-registered persons shifting towards active enforcement. We will keep you advised of our progress on this effort.

- 8. In our efforts to consider all options for meeting Criterion 5 of the Green Communities Act the Town is looking into alternative energy compliance methods that are stricter than 780 CMR the Massachusetts State Building Code which by reference standard uses the 2018 International Energy Compliance Code. In order for the Town of Barnstable to be able to adopt a stricter standard than what is codified in 780 CMR it would have to do so in a manner that is consistent with M.G.L. c. 143 § 98 which provides that *The Town Manager may recommend to the board the adoption of rules and regulations imposing more restrictive standards than those established by the state building code.... In this case it would be a proposal for a more restrictive Energy Code. The Building Commissioner is preparing a letter from the Town Manager to the Board for the adoption of such rules and regulation. We plan to submit said letter in February 2021 and keep the Town Council advised of our progress on the matter. The Town Council has also requested a workshop to discuss the stretch code to gather a broader understanding of said code and its applicability here in Barnstable. We are prepared to schedule that workshop.*
- 9. Town Manager update on proposed fiscal policy and associated public communication for the Comprehensive Wastewater Management Plan.
- Elizabeth Jenkins, Director of Planning and Development, provided information on <u>Zoning</u> <u>Ordinances & Amendments: Process, Communications, and Updates</u> and <u>Local Comprehensive</u> <u>Plan: Overview and Phase One - Data/Existing Conditions and Community Visioning</u>.

OLD BUSINESS began with Planning & Development Director Elizabeth Jenkins and Attorney John Kenney presenting Agenda Items 2021-058 Amending the Zoning Map of the Town of Barnstable to expand the Multifamily Affordable Housing District to include Map 250 Parcel 160 at 3 Whitehall Way, Hyannis, MA and 2021-059 Amending Article III, Chapter 240, Section 16.1 of the Zoning Ordinance to modify the required percentage of affordable units and revise the definition of affordable unit and Article XI, Chapter 240, Section 116 of the Zoning Ordinance to exempt development under the Multifamily Affordable Housing (MAH) from Growth Management which were approved. DPW Director Dan Santos presented Agenda Item 2021-067 Appropriation Order in the amount of \$45,000 for the purpose of acquiring an easement on a portion of the property located at 528 Craigville Beach Road, Barnstable (Centerville) Massachusetts shown on Assessors Map 246 as Parcel 071 to be associated with the construction of new sewer infrastructure which was approved. Planning & Development's Housing Coordinator Arden Cadrin presented Agenda Item 2021-068 Order authorizing a Housing Development Incentive Program Tax Increment Exemption Agreement between the Town of Barnstable and Pearl Street Holdings, LLC for 9 new market rate residential units located at 39 Pearl Street, Hyannis, MA which was approved. NEW BUSINESS began with a First Readings of Agenda Items 2021-070 Appointments to a Board/Committee/Commission: Barnstable Historical Commission; Comprehensive Financial Advisory Committee; Human Services Committee; Licensing Authority; and Zoning Board of Appeals and 2021-071 Supplemental Appropriation Order in the amount of \$29,800 for the Fiscal Year 2021 Airport Operating Budget for the purpose of funding Airport Website Redevelopment Services which were referred to a Second Reading on February 18, 2021. Town Manager Mark Ells presented Agenda Item 2021-072 Authorizing the Town Manager to enter into and execute on behalf of the Town an employment contract with Mark A. Milne to serve as the Director of Finance which was approved.

First Readings for <u>Agenda Items 2021-073</u> Authorization of a Tax Increment Financing Agreement among the Town of Barnstable, WORDSMITH INK, INC. and SB NOMINEE TRUST for the property located at 1254 Main Street, Osterville, MA. Assessors Map 119 and Parcel 056 and <u>2021-074</u> Supplemental Appropriation Order in the amount of **\$37,726** for the Barnstable Police Department Fiscal Year 2021 Operating Budget for the purpose of funding the hiring of three current patrol officer vacancies were referred to Public Hearings on February 18, 2021. *The next regularly scheduled Town Council Meeting will be held on Thursday, February 18, 2021 at 7:00 PM. Town Manager Mark Ells' Community Update

Town Manager Mark Ells continues to provide updates through Channel 18 to keep people informed with accurate information about what is going on in the Town of Barnstable. In his latest <u>Community</u> <u>Update</u>, Mr. Ells shares information related to the state's 3-Phase rollout of the COVID-19 vaccine. Vaccinations started in December and Phase II began February 1st for those who are 75 years and older. It is important that we all be patient and continue to follow the protocols put in place to keep us all safe. Assistant Town Manager Andy Clyburn's presentation to the Barnstable Town Council on February 4, 2021 follows this update. Mr. Ells asks that you stay up-to-date on Governor Baker's orders and directives as they change daily. The MRC helpline team can also walk residents through more complex questions, directing them to the right resources in their local communities and in other state government departments. Volunteers cannot provide individual clinical advice or a diagnosis through the helpline. If you believe you have been exposed to COVID-19 and are symptomatic, call your health care provider. **The helpline will be taking calls beginning next Tuesday, Monday through Friday, from 8:00 AM to 4:30 PM at 1-774-330-3001.** Barnstable County wants to ensure residents that a coordinated response is taking place in our region. Reopening, Temporary Capacity and Gathering Limits Update

Yesterday, Governor Baker and Lt. Governor Polito announced updates to reopening and the temporary capacity and gathering limits:

- 1. **Temporary Capacity Limits Lifted** The 25% temporary capacity limits order will expire on February 8th at 5:00 AM.
 - All businesses in the list below, currently limited to 25% capacity, will return to 40% capacity, as previously allowed (industry guidance effective in December 2020 will apply).
 - Arcades and Recreational Businesses
 - Driving and Flight Schools
 - Gyms/Health Clubs
 - Libraries
 - Museums
 - Retail
 - Offices
 - Places of Worship
 - Lodging (common areas)
 - Golf (indoor areas)
 - Movie theaters (no more than 50 people per theater)
 - Restaurants will now be limited to 40% of their seated capacity, but as under the 25% capacity rule, employees will not count toward their capacity limit
 - Close Contact Personal Services will now be limited to 40% capacity, but as under the 25% capacity rule, employees will be not count toward their capacity limit
 - A limit of 8 people per 1000 sq. feet applies for smaller businesses without an available fire occupancy capacity limit
- 2. Gatherings Order Gatherings remain at no more than 10 people indoors and 25 people outdoors.
- **3. The Commonwealth remains in Phase 3 Step 1 of Reopening (Order No. 58)** Indoor performance venues and indoor recreation businesses like roller rinks and trampoline parks remain closed.

Barnstable Police Officers Rescue Woman in Centerville House Fire

On Tuesday, February 2nd at approximately 3:16 AM the Barnstable Police were dispatched to 844 Shootflying Hill Road in Centerville regarding a house fire. The reporting party, a paper delivery person, informed police dispatch that he could see flames in the window of the home. Officer Marcus Cunningham arrived on scene first and also reported seeing flames inside the home through the front bay window. He attempted to gain access to the front door, but it was locked. Cunningham then went around the side of the home, gained access to an attached sunroom and discovered an interior side door that was unlocked. Officer Nelson Souve had arrived on scene shortly after Cunningham and went to his location to assist. Despite the fire and heavy black smoke that came barreling out of the home when they opened the side door, both officers went inside and located an unconscious 69 year old woman on the kitchen floor. The two officers then carried the unconscious female out of the house, set her down near the driveway and began to tend to her medical needs along with Officer Michael Lima and Officer Gustavo Eloy. The four officers then moved the victim to a location across the street due to the heat and heavy smoke that was pouring out of the home, making it difficult for them to treat her. The officers continued to administer rescue breaths to the still unconscious woman until Centerville-Osterville-Marstons Mills (COMM) Fire Department arrived on scene and took over her care. While being treated by COMM Fire rescue personnel, the female regained consciousness and was transported to Cape Cod Hospital. She was later moved to a Boston area hospital for further medical treatment concerning the smoke inhalation she had suffered as a result of the fire. The above four police officers were later evaluated and treated for smoke inhalation at Cape Cod Hospital and then released.

Public Input Sought for Placemaking Activation Strategies in Downtown Hyannis

The Town of Barnstable, in partnership with MassDevelopment's Transformative Development Initiative [TDI], invites local Barnstable stakeholders, such as year-round and seasonal residents, business owners, nonprofit organizations, and their employees to participate in an on-line survey to share their opinions regarding the potential for existing public spaces in downtown Hyannis to become more vibrant, safe, and active. The goal is to better utilize these public spaces in order to improve the pedestrian

connection between important assets within the neighborhood. The Downtown Hyannis Public Spaces Activation Survey is designed to facilitate decision-making and brainstorming around design and activation strategies in three key sites of downtown Hyannis: the East End of Main Street; the Village Green and Main Street; and Harbor Overlook and Aselton Park. The survey results will help inform recommendations from the consultant, Utile Architecture & Planning. There are three sections of the survey, one section for each site. In each section of the survey, there is a site map that identifies major zones for design and activation. Survey participants are asked to locate design improvements, activation strategies and programming ideas within these zones. The survey allows for more than one option as well as space to write in other ideas. The survey should

ROAD WORK UPDATES

As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.

UPDATED Drainage Improvements on Long Beach Road in Centerville

Drainage structure installations on Long Beach Road in Osterville will be ongoing starting the week of February 1st and ending the week of February 8th. New drainage system structures and castings will be installed within the roadway between house #'s 153 and 177 for collection of stormwater. The disturbed section of the roadway will then be repaved and any areas disturbed during construction will be restored. This work is expected to take up to two weeks, weather permitting. Police details will be on site to assist traffic through the construction zone.

CONTINUES Renovations to Oyster Harbor Bridge

The Town of Barnstable's contractor, MAS Building and Bridge, Inc. (MAS), is under contract to complete a rehabilitation project to the Oyster Harbors Bridge. The project will involve structural and safety repairs to the bridge, including replacement of steel stringers, replacement of abutment joints, repairs to columns supporting the bridge tender's house, and replacement of safety railings on the machine platform. To complete the improvements, one-lane of traffic will need to be closed for the duration of the project. Temporary traffic signals will be installed to manage traffic during this time. The project is scheduled to be completed by May 1, 2021. Once the lane closure begins, the draw-bridge will not be able to be opened for marine vessels passing under the bridge, until the completion of construction. Vessels that would require the draw bridge to be opened to pass under will need to seek an alternate route. Vessels that do not require the draw bridge to be opened will be able to continue to pass under the bridge. Marine vessels operating in the area should monitor the Notice to Mariners for updates and further detail relative to this project. Typical work hours will be Monday through Friday, 7:00 AM to 4:00 PM, though work during weekends may be necessary. Traffic will be impacted as a result of the lane closure and residents are encouraged to plan accordingly when traveling in this

area. As always, please slow down and use extreme caution when traveling through or near construction areas, and follow posted safety signs.

CONTINUES Sewer Construction on Hyannis Avenue and Marstons Avenue

Robert B Our Co., Inc. will be performing construction on a privately funded sewer extension on Hyannis Avenue and Marstons Avenue from 10 Hyannis Avenue to Nob Hill Road. The work will consist of the installation of approximately 1,250 feet of new sewers which, upon completion of the work, will become part of the municipal sewer system, and allow for adjacent properties to connect to the municipal sewer system. The disturbed roadways will be trench patched (temporary pavement) for the remainder of the winter. In the spring, the disturbed roadways will be milled and paved for the full road width. Weather pending, work is scheduled to begin on December 21st and the work is anticipated to take six (6) weeks to complete. Work will be performed from 7 AM to 5 PM, Monday through Friday. Temporary detours will be necessary during the work. Police details and signage will direct motorists around the construction crews. Drivers are advised to seek alternate routes. As always, please slow down and use extreme caution when traveling through the construction area, and follow posted safety signs.

CONTINUES Water Works Construction on Longview Drive in Hyannis

The water works construction project is ongoing on Longview Drive in Hyannis. This project will install approximately 500 feet of 8 inch water main and move the temporary interconnection with the COMM water system to a vacant lot on Longview Drive. The metal container will be enclosed in a building appropriate for the neighborhood. Normal works hours will be between 8:00 AM and 4:40 PM.

CONTINUES MassDOT Schedules Intersection Improvements at Falmouth Road (Route 28) at Osterville West Barnstable Road

MassDOT Construction operations on the intersection at Falmouth Road (Route 28) at Osterville West Barnstable Road will continue through to April 2021. The road has been redesigned to include exclusive left turn lanes and improve bicycle and pedestrian accommodation as part of the proposed safety improvement work. The work to be done consists of furnishing and installing of new traffic signal equipment at the intersection including emergency vehicle pre-emption system, bicycle and vehicles loop detectors, construction of ADA compliant wheelchair ramps, sidewalks, and driveways, box widening, pavement milling and resurfacing, new pavement markings and signs, drainage improvements, water distribution modifications, existing utility pole relocations, installation of granite curbing, loam and seeding. Work will be performed during the day, Monday through Friday 7:00 AM-3:30 PM. Traffic control will include all required signage, channeling devices for lane shifts and alternating one-way traffic as required. Police details/ flaggers will be used as needed. Visit <u>www.mass511.com</u>, a website which provides real-time traffic and incident advisory information, and allows users to subscribe to text and email alerts for traffic conditions. Follow MassDOT on Twitter @MassDOT to receive regular updates on road and traffic conditions. Download MassDOT's GoTime mobile app and view real-time traffic conditions before setting out on the road.

UPDATED Bumps River Bridge Repairs on South Main Street in

Centerville/Main Street in Osterville

Work on the bridge is scheduled to continue through mid-May 2021. Normal work hours are 7:00 AM to 5:30 PM, Monday through Friday. Remaining work will include improving riprap at bridge abutments, bridge deck repairs, improving endblocks and guardrail connections, and concrete repairs. The contractor is expected to deploy their construction craft from McCarthy's Landing (aka Hayward Landing) at 40 Hayward Road in Centerville. This may create brief delays for other users when the contractor is using the landing. The ramp will still be available for public access. The contractor is

responsible for maintaining small vessel navigational access under the bridge at all times during construction. Mariners are urged to use caution and go slow when approaching and moving through the work area. Divers may be in the water at times during construction operations. Mariners are required to maintain proper distance from Dive and Alpha flags based on Maritime law. The bridge will remain open to traffic throughout construction. During this work there will be temporary single-lane closures with signs and police officers to direct traffic past the work zone.

CONTINUES Sidewalk, Traffic Signal, Water Distribution, and Associated Improvements on Independence Drive in Hyannis and Barnstable Village, and on Portions of Mary Dunn Road, Kidd's Hill Road, and Attucks Lane in Barnstable Village

Construction is scheduled to end in May 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Work will include a new sidewalk and additional drainage systems the full length of Independence Drive, on Mary Dunn Road a short distance south of Independence Drive, on Kidd's Hill Road from Independence Drive to Merchants Way, and on Attucks Lane from Independence Drive to Wilkens Lane. The work will also include a new traffic signal system at the intersection of Attucks Lane & Wilkens Lane; a watermain extension on portions of Attucks Lane and Independence Drive; and additional street lights on portions of Independence Drive and Kidd's Hill Road. During active construction there will be lane closures with signs, cones/construction barrels, and police details or flaggers if necessary to direct traffic past the work zones.

CONTINUES Roadway Improvements on Portions of Main Street (Route 6A) and Mill Way in Barnstable Village

Construction is scheduled to continue into spring 2021. Normal work hours are 7:00 AM to 3:30 PM, Monday through Friday. Remaining work includes utility line transfers and pole removals in a few locations (by utility companies); constructing a sidewalk from Main Street to the County Complex parking lot east end; installing street lights; refurbishing traffic signals; and other associated work. During active construction there will be lane closures or temporary detours with signs and police details or flaggers to direct traffic past or around the work zones.

CONTINUES National Grid New Customer Hookups

Monday, February 8, 2021 through Friday, February 12, 2021 Neuco crews will be working on gas services on North Street, Hyannis; Harbor Road, Hyannis and Scudder Avenue, Hyannis. Work will be ongoing for six weeks. Typical natural gas service installation includes marking out underground utilities within the project area, excavation of the street, laying gas main, relaying customer's individual gas service and connecting those services to the main and installing meters. This project should take about five days to complete. Visit ngrid.com/service line to view a YouTube video explaining the replacement of the service pipe to customer homes. Operations will start promptly at 7:00 AM and run until 3:00 PM. Reduce speed, and use caution. All scheduled work is dependent on weather and/or may be impacted due to an emergency situation.



Are You on the Town's Emergency Notification System?

The Barnstable Police Department has an emergency notification system. This system has been used to provide information during the ongoing COVID-19 event and for the recent COMM Water District issue. Did you know that only landlines are part of the federal and state Reverse 911 system and you must register cell phones which are not public records? Make sure you are on our list. Sign up <u>here</u> today. **What is CodeRED and why is it important to me?** CodeRED is an emergency notification service by which town officials can notify Barnstable residents and businesses by telephone, cellular phone, text message, or electronic mail about time-sensitive emergency situations or important community alerts. The system is capable of sending messages only to specific neighborhoods or the entire town. Only authorized officials are allowed access to use the system. Frequently asked questions can be reviewed <u>here</u>. Be sure to take a moment to learn more about this important notification system.
