Town Council Meeting – January 9, 2020

Last night's Town Council Meeting began with Town Council President Paul Hebert presiding over the meeting which began with the Pledge of Allegiance and a Moment of Silence which was followed by a robust Public Comment session. Prior to his prepared report, Town Manager Mark Ells responded to items brought up during Public Comment (Mother's Park, Ban on Plastic Bottles, Long Pond/Indian Ponds, and 5G). He then provided updates on the following items for the period December 20, 2019-January 9, 2020 during Town Manager Communications:

- We are proceeding with the tasks in the budget action calendar for FY 2021 as scheduled. We are actively meeting with staff to review the proposed FY 2021 Capital Improvement Budget. For information on our fiscal year budgets please view the Town's Open Budget website at http://budget.townofbarnstable.us.
- 2. Frequently Asked Questions (FAQ) from our Assessing Division regarding property assessments can be found on the Town's website. With tax bills arriving in mailboxes recently we thought Town Council may want to have these FAQs to remain better informed on the issue.
- 3. Our Department of Public Works continue their efforts of public water supply well rehabilitation at the Mary Dunn #4 well site and installation of test wells on numerous sites across Barnstable including the Fish & Wildlife property immediately abutting the Hyannis Water System. We continue this effort and plan to complete these efforts by the spring of 2020. Public Works has also continued meetings with the other water purveyors in Barnstable as we look comprehensively at water management. We shall continue to report our progress and findings relative to these efforts.

- 4. The Town Council appointed the Town Manager as its representative on the Cape Cod & Islands Water Protection Fund Board. The Bylaws and Regulations Subcommittee met on January 7, 2020. We began discussion of draft regulations and expect to continue discussions through the first quarter of 2020. The full Board is scheduled for its next meeting on January 28, 2020 at 4:00 PM in the East Wing Conference Room of the Barnstable County Complex. The website for the Board has been created by the Cape Cod Commission staff and the link to the current webpage is: http://www.capecodcommission.org/index.php?id=905&maincatid=3. We will keep you advised on the progress of this Board.
- 5. As reported at your last meeting, we are working with Senator Cyr's office, the Massachusetts Clean Water Trust (MCWT), and the Department of Environmental Protection to secure any funding recently made available by the state to assist the Hyannis Water System's operating and capital costs associated with removal of emerging contaminants (PFAS). https://malegislature.gov/Bills/191/H4246 Specifically, DEP Line Item 2250-2002 (\$4.2M) for the testing of potential per- and polyfluoroalkyl substances (PFAS) contamination of water supplies (staff is compiling eligible expense) and the Clean Water Trust Line Item 1595-1200 (\$10.65M) for an operating transfer to the Massachusetts Clean Water Trust to support drinking water programs to remediate per- and polyfluoroalkyl substances (PFAS) contamination of public water supplies. (Finance Director is in communication with the MCWT.) We will keep you advised of our progress on this matter.
- 6. On January 3, 2020 I attended an Economic Development Task Force meeting. This Task Force was created by a former Town Council President. One of the first orders of business was to determine if the newly elected Town Council President wanted the Task Force to continue with its efforts. After speaking with the Town Council President I affirmed that they should continue their role. They also inquired as to how new members might be added to the Task Force. I explained that the Task Force should submit their recommendation to the Town Council President for consideration. I attended both subcommittee meetings and a full task force meeting. At the Subcommittee we discussed ideas related to water access and mooring management as well as housing. In the full Task Force we discussed regulatory reform, fees and development costs, customer service and communication, zoning, and permitting. Mr. Ells will keep the Town Council advised of any future meeting he attends with the Task Force and defer to the Town Council President for dissemination of materials distributed at said meetings.
- 7. We continue to progress with the internal reorganization of our existing work force to create a Director of Communications position and supporting staff under the direct oversight of the Town Manager's office. The position of Communications Director has been posted and we will move expeditiously with this reorganization. I have invited Town Council leadership to participate in the review process for our Director of Communications. The primary role of this position includes being responsible for managing and directing our organization's internal and external communications efforts. This position, in coordination with the Town Manager, will supervise public relations, create communication strategies, and may serve as a primary media contact for the organization when appropriate. We will keep you advised as we progress on this effort.
- 8. Starting with the first issue of the new year, eNews now includes links to: <u>Town Calendar</u>, <u>Official Agendas</u>, and <u>Legal Notices</u>.
- 9. At the November 7, 2019 Town Council meeting, the Barnstable Town Council voted to adopt a Litter Control Ordinance and Enforcement Provisions. We are utilizing the Town Census mailing to ensure that all households in the Town of Barnstable are aware of this new ordinance and to share with you the images you will be seeing around the Town in the near future. Thank You for helping to keep the Town of Barnstable "Litter Free for You and Me!" The census went out to over 22, 000 households the last week of December and began arriving around January 2, 2020. The Community Services Office has been responding to phone calls about the ordinance. We are taking complaints and forwarding them to Health when appropriate. We have also taken a

number of contacts for people who we will have to get back to about their situations. Most of the calls have been extremely positive, however, they want a fine imposed. We have also received a number of suggestions since the mailing went to households/registered voters. Those suggestions have included: sending a mailing to businesses like what was done for the Bag Ban; find a way to communicate with renters through rental agencies and realtors; publicizing weekly results of the number of people charged and dollars fined - on the radio, Cape Cod Times, etc.; and bottle redemption charge for nips.

OLD BUSINESS

Agenda Item 2020-073 Appointments to a Board/ Committee/ Commission: Airport Commission; Land Acquisition and Preservation Committee; and Planning Board were approved. Agenda Item 2020-074 Appropriation and Transfer Order in the amount of \$16,500 for the Barnstable Department of Public Works Fiscal Year 2020 Operating Expense Budget for the purpose of funding maintenance at the former Cotuit Elementary School, located at 140 Old Oyster Road, Cotuit, MA was referred to a Public Hearing on January 23, 2020. DPW Director Dan Santos presented Agenda Item 2020-075 Transfer Order of \$20,000 from the Fiscal Year 2020 Solid Waste Division Capital Improvement Project #2019-141 Roll Off Trailer Replacement to the Fiscal Year 2020 Solid Waste Division Capital Improvement Project #2019-139 Compactor Refurbishing which was approved. Agenda Item 2020-076 Appropriation Order in the amount of \$169,266.00 Community Preservation Funds for hard and soft costs associated with preservation, rehabilitation and restoration work to the West Barnstable Community Building located at 2377 Meetinghouse Way, West Barnstable, MA was referred to a Public Hearing January 23, 2020. The next Town Council meeting will be held on Thursday, January 9, 2020 at 7:00 PM in Barnstable Town Hall, James H. Crocker Jr. Hearing Room, 367 Main Street, Hyannis.

School Committee Meeting – January 8, 2020

The January 8th School Committee Meeting kicked off by recognizing the Barnstable Community Innovation School (BCIS), who were recipients of the Rosenthal Award presented by the Barnstable Human Rights Advisory Commission for advancing human rights in Barnstable County. In the Superintendent's Report, Dr. Mayo-Brown spoke about:

- Barnstable Public Schools (BPS) received a Career and Technical Education Partnership Planning Grant to create greater awareness for Barnstable High School pathway of Project Lead the Way Engineering & Computer Science.
- BPS received a grant for \$59,000 for Increased Access to Quality Afterschool and Summer. This funding will provide important programming for the students of BCIS over the summer.
- Construction for the environmental science classroom at Barnstable High School (BHS) will begin in mid-January. As a reminder, the Town has invested \$1 million in capital funds in order to create a state-of-the-art environmental science classroom for our Chapter 74 Environmental Science and Technology pathway.
- Barnstable Intermediate School is having an Open House on January 29 for students in grades 3, 4, and 5. Grades 3 and 4 students and families are welcome to come from 5:00-6:30 PM and grade 5 students and families are welcomed to come from 7:00-8:30 PM.
- The transportation office has officially relocated next door to the Facilities and Grounds Building. The School Committee discussed creating a Subcommittee or Advisory Committee on School Culture and Climate in Barnstable Public Schools. The School Committee approved an additional ESL Teacher at Barnstable Intermediate School. A large number of new students entering Barnstable schools are English language learners. The February and March School Committee Meetings will be largely focused on the School Department's Budget. The next School Committee Meeting will be held on Wednesday, February 5, 2020 at 7:00 PM in the James H. Crocker, Jr. Hearing Room at Barnstable Town Hall.

Town Census Mailing

The Town of Barnstable has mailed out the Census/Voter/Street Listing forms. They started arriving in mail boxes this week. By responding to the census, you are providing proof of your residency to protect your voting rights. If all the information on your census is correct, simply sign the bottom of the census and send it back to the Town Clerk's office. **Even if there are no changes you need to sign the form and send it back.** Also, if someone has moved out of your household and is a voter – please give us their address, email or phone number so that we may contact them to obtain verification. We cannot remove a voter without their verification; thus many people stay on the census for four (4) years until we can, by law, remove them. If anyone has been added to your household, just put their information down on one of the blank lines. Make any and all corrections on the form. You cannot register to vote on the census form. If you have computer access you can go directly to the Secretary of State's website and register on line at www.sec.state.ma.us. Then click on "Elections and Voting" to register to vote; or come in to the Town Clerk's office and spend a few minutes with us as we enter your voter registration into our computer. We are always pleased to see and work with our residents. For those residents who live part of the time here in Barnstable, and part of the time in a warmer climate, you fill out the census form using the following guidelines:

- ✓ You are a Town of Barnstable resident if:
 - This is your permanent address
 - This is where are you registered to vote
 - On your Massachusetts driver's license you have a Town of Barnstable address

Barnstable Elderly & Disabled Taxation Aid Fund

Background

The Barnstable Town Council has accepted Massachusetts General Law, Chapter 60, Section 3D which allows the Town to establish a fund to defray the real estate taxes of low income elderly and disabled persons. Taxpayers contribute to the fund through a voluntary check off on their real estate tax bills. The funds collected are distributed to needy individuals through an annual award process. To be considered for this annual award, potential recipients need to meet the following eligibility requirements and complete and submit the attached application form.

- 65 years or older on July 01, 2019 OR
- Disabled- Applicant must be receiving benefits from a State or Federal recognized disability entity. (example: Social Security Administration, Veterans Administration)
- Total gross household income shall not exceed \$35,000 single, or \$40,000 married. Other assets must be less than \$40,000. Other Assets are the value of personal property and other real estate excluding domicile. This includes cars, boats, savings and checking accounts.

Gross household income is income earned in the calendar year ending 12/31/2018 and should include all income received from all sources by the applicant as well as any additional residents in the household. Please be advised that we refer to the official Town Census Listing to confirm household residents.

- Applicant(s) must be the titled owner of the property or hold a life estate in the property on July 01, 2018. If Title is held by a Trust, the applicant must be both a trustee and at least a 50% beneficiary of the trust in order to qualify. The property must be the applicant's primary residence.
- Please provide proof of income by attaching copies of all the following that apply:

Social Security Benefits Award letter Bank/Investment Account Statements

IRS Form W-2 IRS Form 1099
Pay Stubs IRS Form 1040

Timeline

Applications will be accepted through **January 15, 2020**. Awards will be announced by January 30, 2020 and will be applied directly to the applicant's residential tax bill. Housing Assistance Corporation is Now Taking Pre-applications for The Lofts at 57

The Town of Barnstable has expressed our commitment to the success of this important development and to our local non-profit housing collaborator Housing Assistance Corporation (HAC) with support from the Community Preservation Act and our municipal Affordable Housing Trust. The Lofts at 57 (57 Ridgewood Avenue, Hyannis, MA) include two income restricted affordable units and six market-rate apartments that are helping to fill an important gap in our local housing inventory often called "the missing middle." These six market rate apartments are not restricted to low-income households and they are not expensive, luxury units. The townhouses are arranged around a central green with private, off-street parking, creating a pocket neighborhood in a convenient location. All units include modern finishes, 1 ½ baths, full basement storage, and in-unit laundry hook-ups as well as coin-op laundry machines in a shared building space.

Rents for the market-rate one-bedroom units will be \$1,400 plus utilities. The two-bedroom units rent for \$1,800 plus utilities. Pre-applications are available on the <u>HAC website</u>. Applications for the restricted affordable units are also on the website. The one-bedroom affordable apartments will rent for \$1,200 and tenants cannot make more than 80% AMI (\$51,250 for a single person household).

ROAD WORK UPDATES

As always please slow down and use extreme caution when traveling through the road construction areas and follow posted safety and detour signs.

NEW National Grid New Customer Hookups

Monday, January 13, 2020 Neuco crews will install gas service on Erin Lane,



Hyannis. Tuesday, January 14, 2020 Neuco crews will install gas service on Second Avenue, Osterville. Wednesday, January 15, 2020 Neuco crews will install gas service on Peach Tree Road, Marstons Mills. Thursday, January 16, 2020 Neuco crews will install gas service on Winding Cove Road, Marstons Mills. Friday, January 17, 2020 Neuco crews will install gas service on Swallow Hill Drive, Barnstable. Typical natural gas service installation includes marking out underground utilities within the project area, excavation of the street, laying gas main, relaying customer's individual gas service and connecting those services to the main and installing meters. This project should take about two days to complete. Visit ngrid.com/service line to view a YouTube video explaining the replacement of the service pipe to customer homes. Operations will start promptly at 7:00 AM and run until 3:00 PM. Reduce speed, and use caution. All scheduled work is dependent on weather and/or may be impacted due to an emergency situation.

CONTINUES MassDOT Schedules Intersection Improvements at Falmouth Road (Route 28) at Osterville West Barnstable Road

Construction operations began on September 5, 2019, and will continue through to April 2021

MassDOT has commenced work on the intersection at Falmouth Road (Route 28) at Osterville West

Barnstable Road. The road has been redesigned to include exclusive left turn lanes and improve bicycle
and pedestrian accommodation as part of the proposed safety improvement work. The work to be done
consists of furnishing and installing of new traffic signal equipment at the intersection including
emergency vehicle pre-emption system, bicycle and vehicles loop detectors, construction of ADA
compliant wheelchair ramps, sidewalks, and driveways, box widening, pavement milling and resurfacing,
new pavement markings and signs, drainage improvements, water distribution modifications, existing
utility pole relocations, installation of granite curbing, loam and seeding.

Hours of Operation (Day/Night): Monday through Friday 7:00 AM-3:30 PM. The initial work shall be done in four phases to allow access to local businesses for both vehicles and pedestrians. Traffic control will include all required signage, channeling devises for lane shifts and alternating one-way traffic as required. Police details/ flaggers will be used as needed.

CONTINUES National Grid Service Road

Construction began on November 12, 2019; National Grid will be installing a new gas main on Service

Road in Sandwich and Barnstable. Work is anticipated to begin at the Barnstable/Sandwich town line on Service Road and continue westerly along Service Road into Sandwich. Work will be performed at night, Monday through Friday from 6:00 PM to 6:00 AM. Service Road will be closed during those times and only accessible for abutters and emergency vehicles. The project is scheduled to be completed in November, 2020.

CONTINUES Main Street (Route 6A) and Mill Way in Barnstable Village

Construction is scheduled to continue through May 2020. Normal work hours will be 6:30 AM to 4:30 PM, Monday through Friday. The project area is Main Street (Route 6A) from Rendezvous Lane to Mill Way, and Mill Way from Main Street to Barnstable Harbor Marina. The project objectives are to improve pedestrian access and overall traffic safety, rehabilitate aging infrastructure, and enhance the streetscape. The project scope includes new/improved sidewalks, landscaping, decorative street lighting in the village center, drainage, pavement, crosswalks, median islands, and traffic signals. Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic delays may occur during lane closures. When required, detours will be posted and communicated with local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.

CONTINUES Sea Street, South Street, and Ocean Avenue in Hyannis

Construction is scheduled to continue into Spring 2020. Normal work hours will be 7:00 AM to 3:30 PM, Monday through Friday. The project area is Sea Street from Main Street to Ocean Avenue, Ocean Avenue from Sea Street to Keyes Memorial Beach, and the intersection of Sea Street & South Street. Remaining work includes relocating overhead utility lines and removing obsolete utility poles – for which Eversource, Comcast, and Verizon are responsible; traffic signal adjustments and sidewalk work at the intersection of Sea Street & South Street; remaining work at the beach parking driveway; sidewalk reconstruction and street lights installation on the east side of Sea Street between Main Street and South Street, and on the west side of Sea Street between South Street and Ocean Avenue; placing the top layer of asphalt on the roads and remaining driveway aprons; permanent pavement markings; and various punch list items. Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic delays may occur during lane closures. When required, detours will be posted and communicated with local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.

CONTINUES Route 149, Main Street, and River Road in Marstons Mills

Construction is scheduled to continue into Spring 2020. Normal work hours will be from 7:00 AM to 3:30 PM, Monday through Friday. The project area is Route 149 from Mill Pond to Lovell's Lane, Main Street from Route 149 to the former elementary school, and River Road from Route 149 to the post office drive. Remaining work includes relocating overhead utility lines and removing obsolete utility poles – for which Comm-Tract, OpenCape, Comcast, and Verizon are responsible; installing colorized stamped asphalt crosswalk surfaces; installing fencing uphill from the new stone retaining wall; and various punch list items. Traffic will be maintained on these roads throughout construction. During active construction in the roadway, there will be lane closures with police details to direct traffic. Traffic delays may occur during lane closures. When required, detours will be posted and communicated with local businesses and residents. As always, please slow down and use extreme caution when traveling through the road construction areas, and follow posted safety and detour signs.
